A BILL

To amend the Congressional Budget and Impoundment Control Act of 1974 to provide for a point of order against reconciliation measures that provide budget authority for unauthorized military operations against Iran, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “No War Appropria-
5 tions through Reconciliation Act” or the “No WAR Act”.

1 **SEC. 2. POINT OF ORDER AGAINST RECONCILIATION MEAS-**
2 **URE PROVIDING BUDGET AUTHORITY FOR**
3 **UNAUTHORIZED MILITARY FORCE AGAINST**
4 **IRAN.**

5 The Congressional Budget and Impoundment Control
6 Act of 1974 is amended—

7 (1) in section 310, by adding at the end the fol-
8 lowing:

9 “(h) LIMITATION ON PROVIDING FUNDS FOR UNAU-
10 THORIZED MILITARY FORCE AGAINST IRAN.—

11 “(1) IN GENERAL.—Notwithstanding any other
12 provision of law, it shall not be in order in the Sen-
13 ate or the House of Representatives to consider any
14 reconciliation bill or reconciliation resolution re-
15 ported pursuant to a concurrent resolution on the
16 budget agreed to under section 301 or 304, or a
17 joint resolution pursuant to section 258C of the Bal-
18 anced Budget and Emergency Deficit Control Act of
19 1985, or any amendment thereto or conference re-
20 port thereon, that appropriates or otherwise provides
21 budget authority for hostilities, including hostilities
22 conducted by a proxy force, against the Islamic Re-
23 public of Iran unless Congress has authorized such
24 hostilities through a declaration of war or specific
25 authorization for use of military force.

1 “(2) DEFINITIONS.—For purposes of this sub-
2 section:

3 “(A) HOSTILITIES.—The term ‘hostilities’
4 includes any offensive military operation, strike,
5 covert action, or sustained engagement involv-
6 ing armed conflict against Iranian military
7 forces, territory, or government institutions.

8 “(B) PROXY FORCES.—The term ‘proxy
9 force’ means any foreign military, paramilitary,
10 or irregular force operating at the direction, re-
11 quest, or with the material support of the
12 United States.”; and

13 (2) in section 904, by inserting “310(h),” after
14 “310(g),” each place it appears.
