which was referred to the Committee on Transportation and Infrastructure

A BILL

To direct the Administrator of the Federal Motor Carrier Safety Administration to establish and maintain a database for commercial driver's license data, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Non-Domiciled CDL
5 Reporting Act”.

1 **SEC. 2. COMMERCIAL DRIVER'S LICENSE DATABASE.**

2 (a) IN GENERAL.—Subchapter IV of chapter 311 of
3 title 49, United States Code, is amended by adding at the
4 end the following:

5 **“§ 31162. Commercial driver's license database**

6 “(a) IN GENERAL.—Not later than 90 days after the
7 date of enactment of this section, the Director of the U.S.
8 Citizenship and Immigration Services shall make the Sys-
9 tematic Alien Verification for Entitlements service avail-
10 able for the Federal Motor Carrier Safety Administration.

11 “(b) SYNCHRONIZATION WITH STATES.—State driv-
12 er license agencies shall submit to the Administrator of
13 the Federal Motor Carrier Safety Administration—

14 “(1) the expiration date of any non-domiciled li-
15 cense issued by such State; and

16 “(2) a copy of the existing driver's license for
17 each individual issued a non-domiciled commercial
18 driver's license in such State.

19 “(c) WAIVER OF SUBMISSION.—States may request
20 a waiver of the provisions of this section under section
21 31315.

22 “(d) PROCESSING OF NON-DOMICILED CDLS.—

23 “(1) IN GENERAL.—After the Administrator re-
24 ceives a submission from a State under subsection
25 (b), the Administrator shall process such informa-

1 tion through the Systematic Alien Verification for
2 Entitlements service described in subsection (a).

3 “(2) SUBMISSION TO USCIS.—If the Adminis-
4 trator determines any non-domiciled commercial
5 driver’s license holder has an unlawful presence in
6 the United States, using the Systematic Alien
7 Verification for Entitlements service, the Adminis-
8 trator shall submit information on such holder to the
9 Director of the U.S. Citizenship and Immigration
10 Services.

11 “(3) REMOVAL.—After receiving any submis-
12 sion under paragraph (2), the Director shall inves-
13 tigate the holder for which the submission occurred
14 to determine whether such holder is eligible for re-
15 moval from the United States.

16 “(e) REPORT TO CONGRESS.—Not later than 1 year
17 after the date of enactment of this section, and each year
18 thereafter, the Administrator shall submit to the Com-
19 mittee on Transportation and Infrastructure of the House
20 of Representatives and the Committee on Commerce,
21 Science, and Transportation of the Senate a report con-
22 taining information on how many non-domiciled commer-
23 cial driver’s licenses were flagged using the system de-
24 scribed in subsection (a) and the State in which such li-
25 censes were obtained.”.

1 (b) CLERICAL AMENDMENT.—The analysis for chap-
2 ter 311 of title 49, United States Code, is amended by
3 adding at the end the following:

“31162. Commercial driver’s license database.”.

4 (c) WITHHOLDING AMOUNTS FOR STATE NON-
5 COMPLIANCE.—Section 31314 of title 49, United States
6 Code, is amended by inserting “or section 31162” after
7 “section 31311(a)” each place it appears.

8 (d) WAIVERS, EXEMPTIONS, AND PILOT PRO-
9 GRAMS.—Subsections (a), (b), and (c) of section 31315
10 of title 49, United States Code, are amended—

11 (1) by inserting “or a State” after “a person”
12 each place it appears;

13 (2) by inserting “or State” after “the person”
14 each place it appears; and

15 (3) by inserting “or, with respect to States, the
16 requirements of section 31162” after “31136” each
17 place it appears.
