A BILL

To amend title XVIII of the Social Security Act to provide for payment for services of radiologist assistants under the Medicare program, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Medicare Access to
5 Radiology Care Act of 2026”.

6 **SEC. 2. FINDINGS.**

7 Congress makes the following findings:

1 (1) Radiologist assistants are advanced-level
2 radiographers who are critically important members
3 of the radiologist-led team.

4 (2) Radiologist assistants work strictly under
5 the supervision of a radiologist to promote high
6 standards of patient care by assisting radiologists in
7 the diagnostic and interventional imaging environ-
8 ment.

9 (3) In every jurisdiction authorizing radiologist
10 assistants to practice, they are only permitted to fur-
11 nish services when delegated by and under the su-
12 pervision of a radiologist.

13 (4) Radiologist assistants value their working
14 and professional relationships with radiologists and
15 have never sought, nor do they seek, the ability to
16 practice independent of radiologists.

17 (5) While radiologist assistants perform various
18 valuable professional services and may make and
19 communicate initial observations to the radiologist,
20 radiologist assistants are not qualified to perform in-
21 terpretations (preliminary, final, or otherwise) of any
22 radiological examination.

23 (6) Removing barriers to care rendered by radi-
24 ologist assistants under the supervision of a radiolo-
25 gist will provide value-based, efficient solutions to

1 improve patient outcomes while ensuring patient
2 safety.

3 **SEC. 3. MEDICARE PAYMENT FOR RADIOLOGIST ASSISTANT**
4 **SERVICES.**

5 (a) COVERAGE.—Section 1861 of the Social Security
6 Act (42 U.S.C. 1395x) is amended—

7 (1) in subsection (s)(2)(K)—

8 (A) in clause (ii), by striking the semicolon
9 at the end and inserting “, and”; and

10 (B) by adding at the end the following new
11 clause:

12 “(iii) radiologist assistant services (as defined
13 in subsection (ooo)(1));”; and

14 (2) by adding at the end the following new sub-
15 section:

16 “(ooo) RADIOLOGIST ASSISTANT SERVICES; RADI-
17 OLOGIST ASSISTANT.—

18 “(1) RADIOLOGIST ASSISTANT SERVICES.—The
19 term ‘radiologist assistant services’ means—

20 “(A) services which would be physicians’
21 services if furnished by a physician (as defined
22 in subsection (r)(1)) and which are performed
23 by a radiologist assistant (as defined in para-
24 graph (2)) under the supervision of a radiolo-
25 gist;

1 “(B) services which the radiologist assist-
2 ant is legally authorized to perform by the
3 State in which the services are performed; and

4 “(C) services in which no other provider
5 (other than the supervising radiologist) charges
6 or is paid any amount with respect to the fur-
7 nishing of such services.

8 “(2) RADIOLOGIST ASSISTANT.—The term ‘ra-
9 diologist assistant’ means a radiographer who is cer-
10 tified by the American Registry of Radiologic Tech-
11 nologists as a registered radiologist assistant to per-
12 form radiologist assistant services.

13 “(3) RULES OF CONSTRUCTION.—Nothing in
14 this subsection shall be construed as affecting—

15 “(A) coverage of and payment for the tech-
16 nical component (including the technical compo-
17 nent of a global fee) with respect to imaging
18 services under this title as in effect before the
19 date of the enactment of this subsection;

20 “(B) the amount of payment made for
21 physicians’ services under this title when such
22 services are personally performed by a radiolo-
23 gist; or

24 “(C) the amount of payment made under
25 this title for services furnished by a covered fa-

1 cility setting (as defined in section
2 1848(a)(10)(B)).”.

3 (b) PAYMENT IN RELATION TO PHYSICIAN FEE
4 SCHEDULE.—

5 (1) PAYMENT LEVEL.—Section 1833(a)(1)(O)
6 of the Social Security Act (42 U.S.C.
7 1395l(a)(1)(O)) is amended by striking “or clinical
8 nurse specialists” and inserting “clinical nurse spe-
9 cialists, or in the case of services provided in a cov-
10 ered facility setting (as defined in section
11 1848(a)(10)(B)), radiologist assistants”.

12 (2) APPLICATION OF FEE SCHEDULE IN HOS-
13 PITAL, AMBULATORY SURGICAL CENTER SET-
14 TINGS.—Section 1848(a) of the Social Security Act
15 (42 U.S.C. 1395w-4(a)) is amended by adding at
16 the end the following new paragraph:

17 “(10) APPLICATION OF FEE SCHEDULE FOR
18 RADIOLOGIST ASSISTANT SERVICES IN HOSPITAL,
19 AMBULATORY SURGICAL CENTER SETTINGS.—

20 “(A) IN GENERAL.—In the case of radiolo-
21 gist assistant services (as defined in section
22 1861(ooo)(1)) furnished in a covered facility
23 setting (as defined in subparagraph (B)), pay-
24 ment for such services furnished in such setting
25 shall be made to the supervising radiologist in

1 the amount determined pursuant to section
 2 1833(a)(1)(O).

3 “(B) COVERED FACILITY SETTING DE-
 4 FINED.—In this paragraph, the term ‘covered
 5 facility setting’ means—

6 “(i) a hospital or critical access hos-
 7 pital;

8 “(ii) an ambulatory surgical center;
 9 and

10 “(iii) such other providers of services
 11 as the Secretary may specify.”.

12 (3) PAYMENT TO SUPERVISING RADIOLOGIST.—
 13 Section 1842(b)(6) of the Social Security Act (42
 14 U.S.C. 1395u(b)(6)) is amended in the first sen-
 15 tence—

16 (A) by striking “and” before “(J)”; and

17 (B) by inserting before the period at the
 18 end the following: “, and (K) in the case of
 19 services described in section 1861(s)(2)(K)(iii)
 20 (relating to radiologist assistant services), pay-
 21 ment shall be made to the supervising radiolo-
 22 gist”.

1 (c) EFFECTIVE DATE.—The amendments made by
2 this section shall apply to services furnished on or after
3 January 1, 2027.
