RESOLUTION

Of inquiry requesting the President and directing the Secretary of State to transmit to the House of Representatives certain documents in their possession relating to the Administration's stance on Greenland.

1 *Resolved*, That the President is requested, and the
2 Secretary of State is directed, to transmit, respectively,
3 to the House of Representatives not later than 14 days
4 after the date of the adoption of this resolution, copies
5 of all documents, Signal application chats, charts, or ta-
6 bles, including notes from meetings, audio recordings,

1 records (including telephone and email records), cor-
2 respondence, artificial intelligence large language model
3 conversation transcripts, and any other communications
4 created on or after January 20, 2025, under the control
5 of the President or the Secretary, respectively, that refer
6 or relate to any of the following:

7 (1) Any plans, policies, or assessments of or by
8 the Administration for United States ownership of
9 or free association with Greenland.

10 (2) Any formal, written description of the Ad-
11 ministration's policy toward the sovereignty and ter-
12 ritorial integrity of the Kingdom of Denmark and
13 the largely autonomous governing status of Green-
14 land as part of the Kingdom.

15 (3) Any policies or assessments pertaining to
16 United States security concerns through the 1951
17 Agreement between the United States and Denmark
18 concerning the defense of Greenland, as amended
19 and supplemented in 2004.

20 (4) Any formal, written description or analysis
21 documenting how the Department of State assesses
22 the legal or diplomatic implications of use of force
23 by the United States against the territory of a
24 NATO ally.

1 (5) Any assessments or legal justification of
2 whether seeking to take control of the territory of a
3 NATO ally would be in keeping with United States
4 obligations under the North Atlantic Treaty and the
5 Charter of the United Nations.

6 (6) All records relating to the following:

7 (A) Engagements between private United
8 States individuals and the Department of State
9 about United States influence in Greenland or
10 the prospect of United States ownership of
11 Greenland for and by the United States Gov-
12 ernment.

13 (B) Engagements between the Department
14 of State and other Federal Government officials
15 about the prospect of United States ownership
16 of Greenland for and by the United States Gov-
17 ernment.

18 (C) Engagements between the Department
19 of State officials and Kingdom of Denmark or
20 Greenlandic authorities relating to the Presi-
21 dent's comments about a United States take-
22 over of Greenland.

23 (D) Engagements between the Department
24 of State officials and Kingdom of Denmark or
25 Greenlandic authorities relating to the Presi-

1 dent's comments about the takeover of Green-
2 land in the State of the Union Address on
3 March 4, 2025.

4 (E) Engagements between the Department
5 of State officials and Kingdom of Denmark or
6 Greenlandic authorities relating to the reported
7 influence campaign by Trump-associated United
8 States individuals, publicly reported during the
9 summer and fall of 2025.

10 (F) Engagements between the Department
11 of State officials and Kingdom of Denmark au-
12 thorities relating to the assessment by Danish
13 intelligence services that the United States
14 poses a national security risk to Denmark and
15 to Europe publicly reported in December 2025.

16 (G) Engagements between the Department
17 of State officials and Kingdom of Denmark or
18 Greenlandic authorities relating to the Presi-
19 dent's appointment of Governor Jeff Landry as
20 Special Envoy to Greenland.

21 (H) Engagements between the Department
22 of State officials and representatives of other
23 European or NATO governments relating to a
24 potential United States takeover of Greenland

1 or the President's appointment of Governor Jeff
2 Landry as Special Envoy to Greenland.

3 (I) Engagements between the Department
4 of State officials and Kingdom of Denmark or
5 Greenlandic authorities relating to the January
6 14, 2026, meeting between the Vice President,
7 the Secretary of State, and representatives from
8 the Kingdom of Denmark and Greenland.
