 3 6945) to amend part A of title IV of the Social Security
 4 Act to clarify the authority of States to use funds for preg-
 5 nancy centers, and for other purposes. All points of order
 6 against consideration of the bill are waived. An amend-
 7 ment in the nature of a substitute consisting of the text
 8 of Rules Committee Print 119–17 shall be considered as
 9 adopted. The bill, as amended, shall be considered as read.
 10 All points of order against provisions in the bill, as amend-
 11 ed, are waived. The previous question shall be considered
 12 as ordered on the bill, as amended, and on any further
 13 amendment thereto, to final passage without intervening
 14 motion except: (1) one hour of debate equally divided and
 15 controlled by the chair and ranking minority member of
 16 the Committee on Ways and Means or their respective des-
 17 ignees; and (2) one motion to recommit.

18 SEC. 2. Upon adoption of this resolution it shall be
 19 in order to consider in the House the bill (H.R. 6359)

1 to require institutions of higher education to disseminate
2 information on the rights of, and accommodations and re-
3 sources for, pregnant students, and for other purposes. All
4 points of order against consideration of the bill are waived.
5 The amendment in the nature of a substitute rec-
6 ommended by the Committee on Education and Workforce
7 now printed in the bill shall be considered as adopted. The
8 bill, as amended, shall be considered as read. All points
9 of order against provisions in the bill, as amended, are
10 waived. The previous question shall be considered as or-
11 dered on the bill, as amended, and on any further amend-
12 ment thereto, to final passage without intervening motion
13 except: (1) one hour of debate equally divided and con-
14 trolled by the chair and ranking minority member of the
15 Committee on Education and Workforce or their respec-
16 tive designees; and (2) one motion to recommit.

17 SEC. 3. Upon adoption of this resolution it shall be
18 in order to consider in the House the joint resolution (H.J.
19 Res. 140) providing for congressional disapproval under
20 chapter 8 of title 5, United States Code, of the rule sub-
21 mitted by the Bureau of Land Management relating to
22 Public Land Order No. 7917 for Withdrawal of Federal
23 Lands; Cook, Lake, and Saint Louis Counties, MN. All
24 points of order against consideration of the joint resolu-
25 tion are waived. The joint resolution shall be considered

1 as read. All points of order against provisions in the joint
2 resolution are waived. The previous question shall be con-
3 sidered as ordered on the joint resolution and on any
4 amendment thereto to final passage without intervening
5 motion except: (1) one hour of debate equally divided and
6 controlled by the chair and ranking minority member of
7 the Committee on Natural Resources or their respective
8 designees; and (2) one motion to recommit.
