 2 shall be in order to consider in the House the bill (H.R.
 3 4690) to amend the Energy Conservation and Production
 4 Act to repeal certain Federal building energy efficiency
 5 performance standards, and for other purposes. All points
 6 of order against consideration of the bill are waived. The

1 amendment in the nature of a substitute recommended by
2 the Committee on Energy and Commerce now printed in
3 the bill shall be considered as adopted. The bill, as amend-
4 ed, shall be considered as read. All points of order against
5 provisions in the bill, as amended, are waived. The pre-
6 vious question shall be considered as ordered on the bill,
7 as amended, and on any further amendment thereto, to
8 final passage without intervening motion except: (1) one
9 hour of debate equally divided and controlled by the chair
10 and ranking minority member of the Committee on En-
11 ergy and Commerce or their respective designees; and (2)
12 one motion to recommit.

13 SEC. 2. Upon adoption of this resolution it shall be
14 in order without intervention of any point of order to con-
15 sider in the House the resolution (H. Res. 1182) express-
16 ing support for rural communities across the United
17 States as stewards of the environment, major suppliers of
18 United States energy resources, critical providers of food
19 production and manufacturing capacity, and drivers of na-
20 tional economic stability, and recognizing the work of the
21 House of Representatives in the 119th Congress in sup-
22 port of those vital communities. The resolution shall be
23 considered as read. The previous question shall be consid-
24 ered as ordered on the resolution and preamble to adop-
25 tion without intervening motion or demand for division of

1 the question except one hour of debate equally divided and
2 controlled by the chair and ranking minority member of
3 the Committee on Energy and Commerce or their respec-
4 tive designees.

5 SEC. 3. Upon adoption of this resolution it shall be
6 in order to consider in the House the bill (H.R. 1897)
7 to amend the Endangered Species Act of 1973 to optimize
8 conservation through resource prioritization, incentivize
9 wildlife conservation on private lands, provide for greater
10 incentives to recover listed species, create greater trans-
11 parency and accountability in recovering listed species,
12 streamline the permitting process, eliminate barriers to
13 conservation, and restore congressional intent. All points
14 of order against consideration of the bill are waived. In
15 lieu of the amendment in the nature of a substitute rec-
16 ommended by the Committee on Natural Resources now
17 printed in the bill, an amendment in the nature of a sub-
18 stitute consisting of the text of Rules Committee Print
19 119–23 shall be considered as adopted. The bill, as
20 amended, shall be considered as read. All points of order
21 against provisions in the bill, as amended, are waived. The
22 previous question shall be considered as ordered on the
23 bill, as amended, and on any further amendment thereto,
24 to final passage without intervening motion except: (1) one
25 hour of debate equally divided and controlled by the chair

1 and ranking minority member of the Committee on Nat-
2 ural Resources or their respective designees; and (2) one
3 motion to recommit.

4 SEC. 4. Upon adoption of this resolution it shall be
5 in order to consider in the House the bill (H.R. 5587)
6 to amend the Geothermal Steam Act of 1970 to waive the
7 requirement for a Federal drilling permit for certain ac-
8 tivities, to exempt certain activities from the requirements
9 of the National Environmental Policy Act of 1969, and
10 for other purposes. All points of order against consider-
11 ation of the bill are waived. The amendment in the nature
12 of a substitute recommended by the Committee on Natural
13 Resources now printed in the bill shall be considered as
14 adopted. The bill, as amended, shall be considered as read.
15 All points of order against provisions in the bill, as amend-
16 ed, are waived. The previous question shall be considered
17 as ordered on the bill, as amended, and on any further
18 amendment thereto, to final passage without intervening
19 motion except: (1) one hour of debate equally divided and
20 controlled by the chair and ranking minority member of
21 the Committee on Natural Resources or their respective
22 designees; and (2) one motion to recommit.
