# RESOLUTION

Providing for consideration of the bill (H.R. 7567) to provide

for the reform and continuation of agricultural and other programs of the Department of Agriculture through fiscal year 2031, and for other purposes; providing for consideration of the bill (H.R. 2616) to require public elementary and middle schools that receive funds under the Elementary and Secondary Education Act of 1965 to obtain parental consent before changing a minor's gender markers, pronouns, or preferred name on any school form or sex-based accommodations, including locker rooms or bathrooms; providing for consideration of the concurrent resolution (S. Con. Res. 33) setting forth the congressional budget for the United States Government for fiscal year 2026 and setting forth the appropriate budgetary levels for fiscal years 2027 through 2035; providing for consideration of the bill (S. 1318) to direct the American Battle Monuments Commission to establish a program to identify American-Jewish servicemembers buried in United States military cemeteries overseas under markers that incorrectly represent their religion and heritage, and for other purposes; providing for consideration of the bill (H.R. 1346) to amend the Clean Air Act with respect to the ethanol waiver for Reid Vapor Pressure under that Act, and for other purposes; and for other purposes.

1       *Resolved*, That at any time after adoption of this reso-  
 2       lution the Speaker may, pursuant to clause 2(b) of rule  
 3       XVIII, declare the House resolved into the Committee of  
 4       the Whole House on the state of the Union for consider-  
 5       ation of the bill (H.R. 7567) to provide for the reform  
 6       and continuation of agricultural and other programs of the  
 7       Department of Agriculture through fiscal year 2031, and

1 for other purposes. The first reading of the bill shall be  
2 dispensed with. All points of order against consideration  
3 of the bill are waived. General debate shall be confined  
4 to the bill and shall not exceed one hour equally divided  
5 and controlled by the chair and ranking minority member  
6 of the Committee on Agriculture or their respective des-  
7 ignees. After general debate the bill shall be considered  
8 for amendment under the five-minute rule. In lieu of the  
9 amendment in the nature of a substitute recommended by  
10 the Committee on Agriculture now printed in the bill, an  
11 amendment in the nature of a substitute consisting of the  
12 text of Rules Committee Print 119–22, modified by the  
13 amendment printed in part A of the report of the Com-  
14 mittee on Rules accompanying this resolution, shall be  
15 considered as adopted in the House and in the Committee  
16 of the Whole. The bill, as amended, shall be considered  
17 as the original bill for the purpose of further amendment  
18 under the five-minute rule and shall be considered as read.  
19 All points of order against provisions in the bill, as amend-  
20 ed, are waived.

21       SEC. 2. (a) No further amendment to H.R. 7567, as  
22 amended, shall be in order except those printed in part  
23 B of the report of the Committee on Rules accompanying  
24 this resolution and amendments en bloc described in sec-  
25 tion 3 of this resolution.

1           (b) Each further amendment printed in part B  
2       of the report of the Committee on Rules shall be  
3       considered only in the order printed in the report,  
4       may be offered only by a Member designated in the  
5       report, shall be considered as read, shall be debat-  
6       able for the time specified in the report equally di-  
7       vided and controlled by the proponent and an oppo-  
8       nent, shall not be subject to amendment, and shall  
9       not be subject to a demand for division of the ques-  
10      tion in the House or in the Committee of the Whole.

11          (c) All points of order against further amend-  
12      ments printed in part B of the report of the Com-  
13      mittee on Rules or against amendments en bloc de-  
14      scribed in section 3 of this resolution are waived.

15      SEC. 3. It shall be in order at any time for the chair  
16   of the Committee on Agriculture or his designee to offer  
17   amendments en bloc consisting of further amendments  
18   printed in part B of the report of the Committee on Rules  
19   accompanying this resolution not earlier disposed of.  
20   Amendments en bloc offered pursuant to this section shall  
21   be considered as read, shall be debatable for 20 minutes  
22   equally divided and controlled by the chair and ranking  
23   minority member of the Committee on Agriculture or their  
24   respective designees, shall not be subject to amendment,

1 and shall not be subject to a demand for division of the  
2 question in the House or in the Committee of the Whole.

3 SEC. 4. At the conclusion of consideration of H.R.  
4 7567 for amendment the Committee shall rise and report  
5 the bill, as amended, to the House with such further  
6 amendments as may have been adopted. The previous  
7 question shall be considered as ordered on the bill, as  
8 amended, and on any further amendment thereto to final  
9 passage without intervening motion except one motion to  
10 recommit.

11 SEC. 5. Upon adoption of this resolution it shall be  
12 in order to consider in the House the bill (H.R. 2616)  
13 to require public elementary and middle schools that re-  
14 ceive funds under the Elementary and Secondary Edu-  
15 cation Act of 1965 to obtain parental consent before  
16 changing a minor's gender markers, pronouns, or pre-  
17 ferred name on any school form or sex-based accommoda-  
18 tions, including locker rooms or bathrooms. All points of  
19 order against consideration of the bill are waived. In lieu  
20 of the amendment in the nature of a substitute rec-  
21 ommended by the Committee on Education and Workforce  
22 now printed in the bill, an amendment in the nature of  
23 a substitute consisting of the text of Rules Committee  
24 Print 119–26 shall be considered as adopted. The bill, as  
25 amended, shall be considered as read. All points of order

1 against provisions in the bill, as amended, are waived. The  
2 previous question shall be considered as ordered on the  
3 bill, as amended, and on any further amendment thereto,  
4 to final passage without intervening motion except: (1) one  
5 hour of debate equally divided and controlled by the chair  
6 and ranking minority member of the Committee on Edu-  
7 cation and Workforce or their respective designees; and  
8 (2) one motion to recommit.

9       SEC. 6. Upon adoption of this resolution it shall be  
10 in order to consider in the House the concurrent resolution  
11 (S. Con. Res. 33) setting forth the congressional budget  
12 for the United States Government for fiscal year 2026 and  
13 setting forth the appropriate budgetary levels for fiscal  
14 years 2027 through 2035. All points of order against con-  
15 sideration of the concurrent resolution are waived. The  
16 concurrent resolution shall be considered as read. All  
17 points of order against provisions in the concurrent resolu-  
18 tion are waived. The previous question shall be considered  
19 as ordered on the concurrent resolution to adoption with-  
20 out intervening motion or demand for division of the ques-  
21 tion except one hour of debate equally divided and con-  
22 trolled by the chair and ranking minority member of the  
23 Committee on the Budget or their respective designees.

24       SEC. 7. Upon adoption of this resolution it shall be  
25 in order to consider in the House the bill (S. 1318) to

1 direct the American Battle Monuments Commission to es-  
2 tablish a program to identify American-Jewish  
3 servicemembers buried in United States military ceme-  
4 teries overseas under markers that incorrectly represent  
5 their religion and heritage, and for other purposes. All  
6 points of order against consideration of the bill are waived.  
7 An amendment in the nature of a substitute consisting  
8 of the text of Rules Committee Print 119–27, modified  
9 by the amendment printed in part C of the report of the  
10 Committee on Rules accompanying this resolution, shall  
11 be considered as adopted. The bill, as amended, shall be  
12 considered as read. All points of order against provisions  
13 in the bill, as amended, are waived. The previous question  
14 shall be considered as ordered on the bill, as amended,  
15 and on any further amendment thereto, to final passage  
16 without intervening motion except: (1) one hour of debate  
17 equally divided among and controlled by the chair and  
18 ranking minority member of the Committee on the Judici-  
19 ary or their respective designees and the chair and ranking  
20 minority member of the Permanent Select Committee on  
21 Intelligence or their respective designees; and (2) one mo-  
22 tion to commit.

23 SEC. 8. In the engrossment of the House amendment  
24 to S. 1318, the Clerk shall—

1           (a) add the text of H.R. 1919, as passed by the  
2       House, as new matter at the end of the text pro-  
3       posed to be inserted by the House amendment;

4           (b) assign appropriate designations to provi-  
5       sions within the engrossment of the text proposed to  
6       be inserted by the House;

7           (c) conform cross-references and provisions for  
8       short titles within the engrossment of the text pro-  
9       posed to be inserted by the House; and

10          (d) be authorized to make technical corrections,  
11       to include corrections in spelling, punctuation, page  
12       and line numbering, section numbering, and inser-  
13       tion of appropriate headings within the engrossment  
14       of the text proposed to be inserted by the House.

15       SEC. 9. It shall be in order at any time through the  
16   legislative day of May 1, 2026, for the Speaker to enter-  
17   tain motions that the House suspend the rules as though  
18   under clause 1 of rule XV. The Speaker or his designee  
19   shall consult with the Minority Leader or his designee on  
20   the designation of any matter for consideration pursuant  
21   to this section.

22       SEC. 10. Upon adoption of this resolution it shall be  
23   in order to consider in the House the bill (H.R. 1346)  
24   to amend the Clean Air Act with respect to the ethanol  
25   waiver for Reid Vapor Pressure under that Act, and for



1 other purposes. All points of order against consideration  
2 of the bill are waived. An amendment in the nature of  
3 a substitute consisting of the text of Rules Committee  
4 Print 119–28 shall be considered as adopted. The bill, as  
5 amended, shall be considered as read. All points of order  
6 against provisions in the bill, as amended, are waived. The  
7 previous question shall be considered as ordered on the  
8 bill, as amended, and on any further amendment thereto,  
9 to final passage without intervening motion except: (1) one  
10 hour of debate equally divided and controlled by the chair  
11 and ranking minority member of the Committee on En-  
12 ergy and Commerce or their respective designees; and (2)  
13 one motion to recommit.

14 SEC. 11. In the engrossment of H.R. 7567, the Clerk  
15 shall—

- 16 (a) await the disposition of H.R. 1346;
- 17 (b) add the text of H.R. 1346, as passed by the  
18 House, as new matter at the end of H.R. 7567;
- 19 (c) assign appropriate designations to provi-  
20 sions within the engrossment;
- 21 (d) conform cross-references and provisions for  
22 short titles within the engrossment; and
- 23 (e) be authorized to make technical corrections,  
24 to include corrections in spelling, punctuation, page

- 1 and line numbering, section numbering, and inser-
- 2 tion of appropriate headings within the engrossment.
