## RESOLUTION

Providing for consideration of the bill (H.R. 5625) to direct the Attorney General to make publicly available a list of each State and unit of local government that permits cashless bail, and for other purposes; providing for consideration of the bill (H.R. 6260) to amend title 18, United States Code, to prohibit fraud in connection with

posting bail; providing for consideration of the bill (H.R. 8365) to provide for conditions on the appointment of monitors by courts, and for other purposes; providing for consideration of the concurrent resolution (H. Con. Res. 96) expressing support for law enforcement officers; and providing for consideration of the bill (H.R. 8469) making appropriations for military construction, the Department of Veterans Affairs, and related agencies for the fiscal year ending September 30, 2027, and for other purposes.

1       *Resolved*, That upon adoption of this resolution it  
 2 shall be in order to consider in the House the bill (H.R.  
 3 5625) to direct the Attorney General to make publicly  
 4 available a list of each State and unit of local government  
 5 that permits cashless bail, and for other purposes. All  
 6 points of order against consideration of the bill are waived.  
 7 The amendment in the nature of a substitute rec-  
 8 ommended by the Committee on the Judiciary now printed  
 9 in the bill shall be considered as adopted. The bill, as  
 10 amended, shall be considered as read. All points of order  
 11 against provisions in the bill, as amended, are waived. The  
 12 previous question shall be considered as ordered on the  
 13 bill, as amended, and on any further amendment thereto,  
 14 to final passage without intervening motion except: (1) one  
 15 hour of debate equally divided and controlled by the chair  
 16 and ranking minority member of the Committee on the

1 Judiciary or their respective designees; and (2) one motion  
2 to recommit.

3 SEC. 2. Upon adoption of this resolution it shall be  
4 in order to consider in the House the bill (H.R. 6260)  
5 to amend title 18, United States Code, to prohibit fraud  
6 in connection with posting bail. All points of order against  
7 consideration of the bill are waived. The amendment in  
8 the nature of a substitute recommended by the Committee  
9 on the Judiciary now printed in the bill shall be considered  
10 as adopted. The bill, as amended, shall be considered as  
11 read. All points of order against provisions in the bill, as  
12 amended, are waived. The previous question shall be con-  
13 sidered as ordered on the bill, as amended, and on any  
14 further amendment thereto, to final passage without inter-  
15 vening motion except: (1) one hour of debate equally di-  
16 vided and controlled by the chair and ranking minority  
17 member of the Committee on the Judiciary or their respec-  
18 tive designees; and (2) one motion to recommit.

19 SEC. 3. Upon adoption of this resolution it shall be  
20 in order to consider in the House the bill (H.R. 8365)  
21 to provide for conditions on the appointment of monitors  
22 by courts, and for other purposes. All points of order  
23 against consideration of the bill are waived. The amend-  
24 ment in the nature of a substitute recommended by the  
25 Committee on the Judiciary now printed in the bill, modi-

1 fied by the amendment printed in part A of the report  
2 of the Committee on Rules accompanying this resolution,  
3 shall be considered as adopted. The bill, as amended, shall  
4 be considered as read. All points of order against provi-  
5 sions in the bill, as amended, are waived. The previous  
6 question shall be considered as ordered on the bill, as  
7 amended, and on any further amendment thereto, to final  
8 passage without intervening motion except: (1) one hour  
9 of debate equally divided and controlled by the chair and  
10 ranking minority member of the Committee on the Judici-  
11 ary or their respective designees; and (2) one motion to  
12 recommit.

13       SEC. 4. Upon adoption of this resolution it shall be  
14 in order to consider in the House the concurrent resolution  
15 (H. Con. Res. 96) expressing support for law enforcement  
16 officers. All points of order against consideration of the  
17 concurrent resolution are waived. The concurrent resolu-  
18 tion shall be considered as read. All points of order against  
19 provisions in the concurrent resolution are waived. The  
20 previous question shall be considered as ordered on the  
21 concurrent resolution and preamble to adoption without  
22 intervening motion or demand for division of the question  
23 except one hour of debate equally divided and controlled  
24 by the chair and ranking minority member of the Com-  
25 mittee on the Judiciary or their respective designees.

1        SEC. 5. At any time after adoption of this resolution  
2 the Speaker may, pursuant to clause 2(b) of rule XVIII,  
3 declare the House resolved into the Committee of the  
4 Whole House on the state of the Union for consideration  
5 of the bill (H.R. 8469) making appropriations for military  
6 construction, the Department of Veterans Affairs, and re-  
7 lated agencies for the fiscal year ending September 30,  
8 2027, and for other purposes. The first reading of the bill  
9 shall be dispensed with. All points of order against consid-  
10 eration of the bill are waived. General debate shall be con-  
11 fined to the bill and shall not exceed one hour equally di-  
12 vided and controlled by the chair and ranking minority  
13 member of the Committee on Appropriations or their re-  
14 spective designees. After general debate the bill shall be  
15 considered for amendment under the five-minute rule. The  
16 bill shall be considered as read. Points of order against  
17 provisions in the bill for failure to comply with clause 2  
18 of rule XXI are waived.

19        SEC. 6. (a) No amendment to H.R. 8469 shall be in  
20 order except those printed in part B of the report of the  
21 Committee on Rules accompanying this resolution, amend-  
22 ments en bloc described in section 7 of this resolution, and  
23 pro forma amendments described in section 8 of this reso-  
24 lution.

1           (b) Each amendment printed in part B of the  
2       report of the Committee on Rules shall be consid-  
3       ered only in the order printed in the report, may be  
4       offered only by a Member designated in the report,  
5       shall be considered as read, shall be debatable for  
6       the time specified in the report equally divided and  
7       controlled by the proponent and an opponent, shall  
8       not be subject to amendment except as provided by  
9       section 8 of this resolution, and shall not be subject  
10      to a demand for division of the question in the  
11      House or in the Committee of the Whole.

12           (c) All points of order against amendments  
13      printed in part B of the report of the Committee on  
14      Rules or against amendments en bloc described in  
15      section 7 of this resolution are waived.

16      SEC. 7. It shall be in order at any time for the chair  
17      of the Committee on Appropriations or his designee to  
18      offer amendments en bloc consisting of amendments print-  
19      ed in part B of the report of the Committee on Rules ac-  
20      companying this resolution not earlier disposed of. Amend-  
21      ments en bloc offered pursuant to this section shall be con-  
22      sidered as read, shall be debatable for 20 minutes equally  
23      divided and controlled by the chair and ranking minority  
24      member of the Committee on Appropriations or their re-  
25      spective designees, shall not be subject to amendment ex-

1 cept as provided by section 8 of this resolution, and shall  
2 not be subject to a demand for division of the question  
3 in the House or in the Committee of the Whole.

4 SEC. 8. During consideration of H.R. 8469 for  
5 amendment, the chair and ranking minority member of  
6 the Committee on Appropriations or their respective des-  
7 ignees may offer up to 10 pro forma amendments each  
8 at any point for the purpose of debate.

9 SEC. 9. At the conclusion of consideration of H.R.  
10 8469 for amendment the Committee shall rise and report  
11 the bill to the House with such amendments as may have  
12 been adopted. The previous question shall be considered  
13 as ordered on the bill and amendments thereto to final  
14 passage without intervening motion except one motion to  
15 recommit.
