RESOLUTION

Providing for consideration of the bill (H.R. 1041) to amend title 38, United States Code, to prohibit the Secretary of Veterans Affairs from transmitting certain information to the Department of Justice for use by the national instant criminal background check system; providing for

consideration of the bill (H.R. 6047) to amend title 38, United States Code, to direct the Secretary of Veterans Affairs to increase the dollar amounts for the payment of certain disability compensation and dependency and indemnity compensation under the laws administered by the Secretary; providing for consideration of the bill (H.R. 1329) to permit the Smithsonian American Women's History Museum to be located within the Reserve of the National Mall, and for other purposes; and waiving a requirement of clause 6(a) of rule XIII with respect to consideration of certain resolutions reported from the Committee on Rules.

1 *Resolved*, That upon adoption of this resolution it
 2 shall be in order to consider in the House the bill (H.R.
 3 1041) to amend title 38, United States Code, to prohibit
 4 the Secretary of Veterans Affairs from transmitting cer-
 5 tain information to the Department of Justice for use by
 6 the national instant criminal background check system. All
 7 points of order against consideration of the bill are waived.
 8 The amendment in the nature of a substitute rec-
 9 ommended by the Committee on Veterans' Affairs now
 10 printed in the bill shall be considered as adopted. The bill,
 11 as amended, shall be considered as read. All points of
 12 order against provisions in the bill, as amended, are
 13 waived. The previous question shall be considered as or-
 14 dered on the bill, as amended, and on any further amend-
 15 ment thereto, to final passage without intervening motion
 16 except: (1) one hour of debate equally divided and con-

1 trolled by the chair and ranking minority member of the
2 Committee on Veterans' Affairs or their respective des-
3 ignees; and (2) one motion to recommit.

4 SEC. 2. Upon adoption of this resolution it shall be
5 in order to consider in the House the bill (H.R. 6047)
6 to amend title 38, United States Code, to direct the Sec-
7 retary of Veterans Affairs to increase the dollar amounts
8 for the payment of certain disability compensation and de-
9 pendency and indemnity compensation under the laws ad-
10 ministered by the Secretary. All points of order against
11 consideration of the bill are waived. The amendment in
12 the nature of a substitute recommended by the Committee
13 on Veterans' Affairs now printed in the bill, modified by
14 the amendment printed in part A of the report of the Com-
15 mittee on Rules accompanying this resolution, shall be
16 considered as adopted. The bill, as amended, shall be con-
17 sidered as read. All points of order against provisions in
18 the bill, as amended, are waived. The previous question
19 shall be considered as ordered on the bill, as amended,
20 and on any further amendment thereto, to final passage
21 without intervening motion except: (1) one hour of debate
22 equally divided and controlled by the chair and ranking
23 minority member of the Committee on Veterans' Affairs
24 or their respective designees; and (2) one motion to recom-
25 mit.

1 SEC. 3. Upon adoption of this resolution it shall be
2 in order to consider in the House the bill (H.R. 1329)
3 to permit the Smithsonian American Women's History
4 Museum to be located within the Reserve of the National
5 Mall, and for other purposes. All points of order against
6 consideration of the bill are waived. The amendment in
7 the nature of a substitute recommended by the Committee
8 on House Administration now printed in the bill, modified
9 by the amendment printed in part B of the report of the
10 Committee on Rules accompanying this resolution, shall
11 be considered as adopted. The bill, as amended, shall be
12 considered as read. All points of order against provisions
13 in the bill, as amended, are waived. The previous question
14 shall be considered as ordered on the bill, as amended,
15 and on any further amendment thereto, to final passage
16 without intervening motion except: (1) one hour of debate
17 equally divided and controlled by the chair and ranking
18 minority member of the Committee on House Administra-
19 tion or their respective designees; and (2) one motion to
20 recommit.

21 SEC. 4. The requirement of clause 6(a) of rule XIII
22 for a two-thirds vote to consider a report from the Com-
23 mittee on Rules on the same day it is presented to the
24 House is waived with respect to any resolution reported
25 through the legislative day of May 24, 2026, relating to
