RESOLUTION

Providing for consideration of the bill (H.R. 8646) making appropriations for Agriculture, Rural Development, Food and Drug Administration, and Related Agencies pro-

grams for the fiscal year ending September 30, 2027, and for other purposes; providing for consideration of the bill (H.R. 7726) to amend the Child Care and Development Block Grant Act of 1990 to withhold funds from noncompliant States under such Act; providing for consideration of the bill (H.R. 7892) to amend the Higher Education Act of 1965 to require to the Secretary of Education to use an identity fraud detection system to review each FAFSA to determine whether the FAFSA presents a reasonable suspicion of identity fraud; and providing for consideration of the bill (H.R. 8872) to amend part A of title IV of the Social Security Act to target funds to low-income families, strengthen program integrity guardrails for State expenditure of funds, require measurement of improper payments, and establish goals for eliminating fraud and improper payments under the program of block grants to States for temporary assistance for needy families, and for other purposes.

1 *Resolved*, That at any time after adoption of this reso-
2 lution the Speaker may, pursuant to clause 2(b) of rule
3 XVIII, declare the House resolved into the Committee of
4 the Whole House on the state of the Union for consider-
5 ation of the bill (H.R. 8646) making appropriations for
6 Agriculture, Rural Development, Food and Drug Adminis-
7 tration, and Related Agencies programs for the fiscal year
8 ending September 30, 2027, and for other purposes. The
9 first reading of the bill shall be dispensed with. All points
10 of order against consideration of the bill are waived. Gen-

1 eral debate shall be confined to the bill and shall not ex-
2 ceed one hour equally divided and controlled by the chair
3 and ranking minority member of the Committee on Appro-
4 priations or their respective designees. After general de-
5 bate the bill shall be considered for amendment under the
6 five-minute rule. The bill shall be considered as read.
7 Points of order against provisions in the bill for failure
8 to comply with clause 2 or clause 5(a) of rule XXI are
9 waived.

10 SEC. 2. (a) No amendment to H.R. 8646 shall be in
11 order except those printed in the report of the Committee
12 on Rules accompanying this resolution, amendments en
13 bloc described in section 3 of this resolution, and pro
14 forma amendments described in section 4 of this resolu-
15 tion.

16 (b) Each amendment printed in the report of the
17 Committee on Rules shall be considered only in the order
18 printed in the report, may be offered only by a Member
19 designated in the report, shall be considered as read, shall
20 be debatable for the time specified in the report equally
21 divided and controlled by the proponent and an opponent,
22 shall not be subject to amendment except as provided by
23 section 4 of this resolution, and shall not be subject to
24 a demand for division of the question in the House or in
25 the Committee of the Whole.

1 (c) All points of order against amendments printed
2 in the report of the Committee on Rules or against amend-
3 ments en bloc described in section 3 of this resolution are
4 waived.

5 SEC. 3. It shall be in order at any time for the chair
6 of the Committee on Appropriations or his designee to
7 offer amendments en bloc consisting of amendments print-
8 ed in the report of the Committee on Rules accompanying
9 this resolution not earlier disposed of. Amendments en
10 bloc offered pursuant to this section shall be considered
11 as read, shall be debatable for 20 minutes equally divided
12 and controlled by the chair and ranking minority member
13 of the Committee on Appropriations or their respective
14 designees, shall not be subject to amendment except as
15 provided by section 4 of this resolution, and shall not be
16 subject to a demand for division of the question in the
17 House or in the Committee of the Whole.

18 SEC. 4. During consideration of H.R. 8646 for
19 amendment, the chair and ranking minority member of
20 the Committee on Appropriations or their respective des-
21 ignees may offer up to 10 pro forma amendments each
22 at any point for the purpose of debate.

23 SEC. 5. At the conclusion of consideration of H.R.
24 8646 for amendment the Committee shall rise and report
25 the bill to the House with such amendments as may have

1 been adopted. The previous question shall be considered
2 as ordered on the bill and amendments thereto to final
3 passage without intervening motion except one motion to
4 recommit.

5 SEC. 6. Upon adoption of this resolution it shall be
6 in order to consider in the House the bill (H.R. 7726)
7 to amend the Child Care and Development Block Grant
8 Act of 1990 to withhold funds from noncompliant States
9 under such Act. All points of order against consideration
10 of the bill are waived. In lieu of the amendment in the
11 nature of a substitute recommended by the Committee on
12 Education and Workforce now printed in the bill, an
13 amendment in the nature of a substitute consisting of the
14 text of Rules Committee Print 119–32 shall be considered
15 as adopted. The bill, as amended, shall be considered as
16 read. All points of order against provisions in the bill, as
17 amended, are waived. The previous question shall be con-
18 sidered as ordered on the bill, as amended, and on any
19 further amendment thereto, to final passage without inter-
20 vening motion except: (1) one hour of debate equally di-
21 vided and controlled by the chair and ranking minority
22 member of the Committee on Education and Workforce
23 or their respective designees; and (2) one motion to recom-
24 mit.

1 SEC. 7. Upon adoption of this resolution it shall be
2 in order to consider in the House the bill (H.R. 7892)
3 to amend the Higher Education Act of 1965 to require
4 to the Secretary of Education to use an identity fraud de-
5 tection system to review each FAFSA to determine wheth-
6 er the FAFSA presents a reasonable suspicion of identity
7 fraud. All points of order against consideration of the bill
8 are waived. In lieu of the amendment in the nature of a
9 substitute recommended by the Committee on Education
10 and Workforce now printed in the bill, an amendment in
11 the nature of a substitute consisting of the text of Rules
12 Committee Print 119–31 shall be considered as adopted.
13 The bill, as amended, shall be considered as read. All
14 points of order against provisions in the bill, as amended,
15 are waived. The previous question shall be considered as
16 ordered on the bill, as amended, and on any further
17 amendment thereto, to final passage without intervening
18 motion except: (1) one hour of debate equally divided and
19 controlled by the chair and ranking minority member of
20 the Committee on Education and Workforce or their re-
21 spective designees; and (2) one motion to recommit.

22 SEC. 8. Upon adoption of this resolution it shall be
23 in order to consider in the House the bill (H.R. 8872)
24 to amend part A of title IV of the Social Security Act
25 to target funds to low-income families, strengthen pro-

1 gram integrity guardrails for State expenditure of funds,
2 require measurement of improper payments, and establish
3 goals for eliminating fraud and improper payments under
4 the program of block grants to States for temporary as-
5 sistance for needy families, and for other purposes. All
6 points of order against consideration of the bill are waived.
7 The amendment in the nature of a substitute rec-
8 ommended by the Committee on Ways and Means now
9 printed in the bill shall be considered as adopted. The bill,
10 as amended, shall be considered as read. All points of
11 order against provisions in the bill, as amended, are
12 waived. The previous question shall be considered as or-
13 dered on the bill, as amended, and on any further amend-
14 ment thereto, to final passage without intervening motion
15 except: (1) one hour of debate equally divided and con-
16 trolled by the chair and ranking minority member of the
17 Committee on Ways and Means or their respective des-
18 ignees; and (2) one motion to recommit.
