RESOLUTION

General for Fraud, Accountability, and Recovery, and for other purposes; providing for consideration of the bill (H.R. 8464) to amend title 31, United States Code, to authorize pausing and segmenting payments, and for other purposes; providing for consideration of the resolution (H. Res. 1335) condemning actors seeking to defraud the United States Government, and expressing the sense of the House of Representatives that government-wide fraud and improper payment prevention reforms will meaningfully improve the financial prosperity of the United States, and that Federal program eligibility should be verified before payment; and providing for consideration of the bill (S. 2) to provide for reconciliation pursuant to title II of S. Con. Res. 33.

1 *Resolved*, That upon adoption of this resolution it
 2 shall be in order to consider in the House the bill (H.R.
 3 8312) to establish fraud prevention and program integrity
 4 functions and data sharing authorities within the Depart-
 5 ment of Treasury and a permanent governmentwide In-
 6 spector General for Fraud, Accountability, and Recovery,
 7 and for other purposes. All points of order against consid-
 8 eration of the bill are waived. The amendment in the na-
 9 ture of a substitute recommended by the Committee on
 10 Oversight and Government Reform now printed in the bill
 11 shall be considered as adopted. The bill, as amended, shall
 12 be considered as read. All points of order against provi-
 13 sions in the bill, as amended, are waived. The previous
 14 question shall be considered as ordered on the bill, as

1 amended, and on any further amendment thereto, to final
2 passage without intervening motion except: (1) one hour
3 of debate equally divided and controlled by the chair and
4 ranking minority member of the Committee on Oversight
5 and Government Reform or their respective designees; and
6 (2) one motion to recommit.

7 SEC. 2. Upon adoption of this resolution it shall be
8 in order to consider in the House the bill (H.R. 8464)
9 to amend title 31, United States Code, to authorize paus-
10 ing and segmenting payments, and for other purposes. All
11 points of order against consideration of the bill are waived.
12 The amendment in the nature of a substitute rec-
13 ommended by the Committee on Oversight and Govern-
14 ment Reform now printed in the bill shall be considered
15 as adopted. The bill, as amended, shall be considered as
16 read. All points of order against provisions in the bill, as
17 amended, are waived. The previous question shall be con-
18 sidered as ordered on the bill, as amended, and on any
19 further amendment thereto, to final passage without inter-
20 vening motion except: (1) one hour of debate equally di-
21 vided and controlled by the chair and ranking minority
22 member of the Committee on Oversight and Government
23 Reform or their respective designees; and (2) one motion
24 to recommit.

1 SEC. 3. Upon adoption of this resolution it shall be
2 in order without intervention of any point of order to con-
3 sider in the House the resolution (H. Res. 1335) con-
4 demning actors seeking to defraud the United States Gov-
5 ernment, and expressing the sense of the House of Rep-
6 resentatives that governmentwide fraud and improper pay-
7 ment prevention reforms will meaningfully improve the fi-
8 nancial prosperity of the United States, and that Federal
9 program eligibility should be verified before payment. The
10 resolution shall be considered as read. The previous ques-
11 tion shall be considered as ordered on the resolution and
12 preamble to adoption without intervening motion or de-
13 mand for division of the question except one hour of de-
14 bate equally divided and controlled by the chair and rank-
15 ing minority member of the Committee on Oversight and
16 Government Reform or their respective designees.

17 SEC. 4. Upon adoption of this resolution it shall be
18 in order to consider in the House the bill (S. 2) to provide
19 for reconciliation pursuant to title II of S. Con. Res. 33.
20 All points of order against consideration of the bill are
21 waived. The bill shall be considered as read. All points of
22 order against provisions in the bill are waived. The pre-
23 vious question shall be considered as ordered on the bill
24 and on any amendment thereto to final passage without
25 intervening motion except: (1) one hour of debate equally

- 1 divided and controlled by the chair and ranking minority
- 2 member of the Committee on the Budget or their respec-
- 3 tive designees; and (2) one motion to commit.
