RESOLUTION

Providing for consideration of the bill (H.R. 8800) to authorize appropriations for fiscal year 2027 for military activi-

ties of the Department of Defense, for military construction, and for defense activities of the Department of Energy, to prescribe military personnel strengths for such fiscal year, and for other purposes; providing for consideration of the bill (H.R. 8884) to amend title II of the Social Security Act to reauthorize demonstration authority for the disability insurance program; providing for consideration of the concurrent resolution (H. Con. Res. 113) establishing the congressional budget for the United States Government for fiscal year 2027 and setting forth the appropriate budgetary levels for fiscal years 2028 through 2036; providing for consideration of the bill (H.R. 7008) to amend chapter 131 of title 5 to require certain restrictions on stocks for Members of Congress and their spouses and dependents, and for other purposes; providing for consideration of the bill (H.R. 6955) to make improvements to the Federal banking laws, and for other purposes; providing for consideration of the bill (H.R. 9770) making continuing appropriations for fiscal year 2027, and for other purposes; and for other purposes.

1 *Resolved*, That at any time after adoption of this reso-
 2 lution the Speaker may, pursuant to clause 2(b) of rule
 3 XVIII, declare the House resolved into the Committee of
 4 the Whole House on the state of the Union for consider-
 5 ation of the bill (H.R. 8800) to authorize appropriations
 6 for fiscal year 2027 for military activities of the Depart-
 7 ment of Defense, for military construction, and for defense
 8 activities of the Department of Energy, to prescribe mili-
 9 tary personnel strengths for such fiscal year, and for other

1 purposes. The first reading of the bill shall be dispensed
2 with. All points of order against consideration of the bill
3 are waived. General debate shall be confined to the bill
4 and amendments specified in this section and shall not ex-
5 ceed one hour equally divided and controlled by the chair
6 and ranking minority member of the Committee on Armed
7 Services or their respective designees. After general debate
8 the bill shall be considered for amendment under the five-
9 minute rule. In lieu of the amendment in the nature of
10 a substitute recommended by the Committee on Armed
11 Services now printed in the bill, an amendment in the na-
12 ture of a substitute consisting of the text of Rules Com-
13 mittee Print 119–33 shall be considered as adopted in the
14 House and in the Committee of the Whole. The bill, as
15 amended, shall be considered as the original bill for the
16 purpose of further amendment under the five-minute rule
17 and shall be considered as read. All points of order against
18 provisions in the bill, as amended, are waived.

19 SEC. 2. (a) No further amendment to H.R. 8800, as
20 amended, shall be in order except those printed in part
21 A of the report of the Committee on Rules accompanying
22 this resolution, amendments en bloc described in section
23 3 of this resolution, and pro forma amendments described
24 in section 4 of this resolution.

1 (b) Each further amendment printed in part A of the
2 report of the Committee on Rules shall be considered only
3 in the order printed in the report, may be offered only
4 by a Member designated in the report, shall be considered
5 as read, shall be debatable for the time specified in the
6 report equally divided and controlled by the proponent and
7 an opponent, shall not be subject to amendment except
8 as provided by section 4 of this resolution, and shall not
9 be subject to a demand for division of the question in the
10 House or in the Committee of the Whole.

11 (c) All points of order against further amendments
12 printed in part A of the report of the Committee on Rules
13 or against amendments en bloc described in section 3 of
14 this resolution are waived.

15 SEC. 3. It shall be in order at any time for the chair
16 of the Committee on Armed Services or his designee to
17 offer amendments en bloc consisting of further amend-
18 ments printed in part A of the report of the Committee
19 on Rules accompanying this resolution not earlier disposed
20 of. Amendments en bloc offered pursuant to this section
21 shall be considered as read, shall be debatable for 40 min-
22 utes equally divided and controlled by the chair and rank-
23 ing minority member of the Committee on Armed Services
24 or their respective designees, shall not be subject to
25 amendment except as provided by section 4 of this resolu-

1 tion, and shall not be subject to a demand for division
2 of the question in the House or in the Committee of the
3 Whole.

4 SEC. 4. During consideration of H.R. 8800 for
5 amendment, the chair and ranking minority member of
6 the Committee on Armed Services or their respective des-
7 ignees may offer up to 10 pro forma amendments each
8 at any point for the purpose of debate.

9 SEC. 5. At the conclusion of consideration of H.R.
10 8800 for amendment the Committee shall rise and report
11 the bill, as amended, to the House with such further
12 amendments as may have been adopted. The previous
13 question shall be considered as ordered on the bill, as
14 amended, and on any further amendment thereto to final
15 passage without intervening motion except one motion to
16 recommit.

17 SEC. 6. Upon adoption of this resolution it shall be
18 in order to consider in the House the bill (H.R. 8884)
19 to amend title II of the Social Security Act to reauthorize
20 demonstration authority for the disability insurance pro-
21 gram. All points of order against consideration of the bill
22 are waived. In lieu of the amendment in the nature of a
23 substitute recommended by the Committee on Ways and
24 Means now printed in the bill, an amendment in the na-
25 ture of a substitute consisting of the text of Rules Com-

1 mittee Print 119–34 shall be considered as adopted. The
2 bill, as amended, shall be considered as read. All points
3 of order against provisions in the bill, as amended, are
4 waived. The previous question shall be considered as or-
5 dered on the bill, as amended, and on any further amend-
6 ment thereto, to final passage without intervening motion
7 except: (1) one hour of debate equally divided and con-
8 trolled by the chair and ranking minority member of the
9 Committee on Ways and Means or their respective des-
10 ignees; and (2) one motion to recommit.

11 SEC. 7. At any time after adoption of this resolution
12 the Speaker may, pursuant to clause 2(b) of rule XVIII,
13 declare the House resolved into the Committee of the
14 Whole House on the state of the Union for consideration
15 of the concurrent resolution (H. Con. Res. 113) estab-
16 lishing the congressional budget for the United States
17 Government for fiscal year 2027 and setting forth the ap-
18 propriate budgetary levels for fiscal years 2028 through
19 2036. The first reading of the concurrent resolution shall
20 be dispensed with. All points of order against consider-
21 ation of the concurrent resolution are waived. General de-
22 bate shall be confined to the concurrent resolution and
23 shall not exceed one hour equally divided and controlled
24 by the chair and ranking minority member of the Com-
25 mittee on the Budget or their respective designees. An

1 amendment in the nature of a substitute consisting of the
2 text of Rules Committee Print 119–37 shall be considered
3 as adopted in the House and in the Committee of the
4 Whole. The concurrent resolution, as amended, shall be
5 considered as read. After general debate the Committee
6 shall rise and report the concurrent resolution, as amend-
7 ed, to the House. The previous question shall be consid-
8 ered as ordered on the concurrent resolution and amend-
9 ments thereto to adoption without intervening motion ex-
10 cept amendments offered by the chair of the Committee
11 on the Budget pursuant to section 305(a)(5) of the Con-
12 gressional Budget Act of 1974 to achieve mathematical
13 consistency. The concurrent resolution shall not be subject
14 to a demand for division of the question of its adoption.

15 SEC. 8. Upon adoption of this resolution it shall be
16 in order to consider in the House the bill (H.R. 7008)
17 to amend chapter 131 of title 5 to require certain restric-
18 tions on stocks for Members of Congress and their spouses
19 and dependents, and for other purposes. All points of
20 order against consideration of the bill are waived. In lieu
21 of the amendment in the nature of a substitute rec-
22 ommended by the Committee on House Administration
23 now printed in the bill, an amendment in the nature of
24 a substitute consisting of the text of Rules Committee
25 Print 119–38, modified by the amendment printed in part

1 B of the report of the Committee on Rules accompanying
2 this resolution, shall be considered as adopted. The bill,
3 as amended, shall be considered as read. All points of
4 order against provisions in the bill, as amended, are
5 waived. The previous question shall be considered as or-
6 dered on the bill, as amended, and on any further amend-
7 ment thereto, to final passage without intervening motion
8 except: (1) one hour of debate equally divided and con-
9 trolled by the chair and ranking minority member of the
10 Committee on House Administration or their respective
11 designees; and (2) one motion to recommit.

12 SEC. 9. Upon adoption of this resolution it shall be
13 in order to consider in the House the bill (H.R. 6955)
14 to make improvements to the Federal banking laws, and
15 for other purposes. All points of order against consider-
16 ation of the bill are waived. In lieu of the amendment in
17 the nature of a substitute recommended by the Committee
18 on Financial Services now printed in the bill, an amend-
19 ment in the nature of a substitute consisting of the text
20 of Rules Committee Print 119–35 shall be considered as
21 adopted. The bill, as amended, shall be considered as read.
22 All points of order against provisions in the bill, as amend-
23 ed, are waived. The previous question shall be considered
24 as ordered on the bill, as amended, and on any further
25 amendment thereto, to final passage without intervening

1 motion except: (1) one hour of debate equally divided and
2 controlled by the chair and ranking minority member of
3 the Committee on Financial Services or their respective
4 designees; and (2) one motion to recommit.

5 SEC. 10. Upon adoption of this resolution it shall be
6 in order to consider in the House the bill (H.R. 9770)
7 making continuing appropriations for fiscal year 2027,
8 and for other purposes. All points of order against consid-
9 eration of the bill are waived. The bill shall be considered
10 as read. All points of order against provisions in the bill
11 are waived. The previous question shall be considered as
12 ordered on the bill and on any amendment thereto to final
13 passage without intervening motion except: (1) one hour
14 of debate equally divided and controlled by the chair and
15 ranking minority member of the Committee on Appropria-
16 tions or their respective designees; and (2) one motion to
17 recommit.

18 SEC. 11. In the engrossment of H.R. 8800, the Clerk
19 shall—

20 (a) add the text of S. 1383, as passed by the House,
21 as new matter at the end of H.R. 8800;

22 (b) assign appropriate designations to provisions
23 within the engrossment;

24 (c) conform cross-references and provisions for short
25 titles within the engrossment; and

- 1 (d) be authorized to make technical corrections, to
- 2 include corrections in spelling, punctuation, page and line
- 3 numbering, section numbering, and insertion of appro-
- 4 priate headings within the engrossment.
