1 *Resolved*, That upon adoption of this resolution it
 2 shall be in order to consider in the House the bill (H.R.
 3 9576) to establish the National Fraud Enforcement Divi-
 4 sion of the Department of Justice. All points of order
 5 against consideration of the bill are waived. An amend-
 6 ment in the nature of a substitute consisting of the text
 7 of Rules Committee Print 119–41 shall be considered as
 8 adopted. The bill, as amended, shall be considered as read.

1 All points of order against provisions in the bill, as amend-
2 ed, are waived. The previous question shall be considered
3 as ordered on the bill, as amended, and on any further
4 amendment thereto, to final passage without intervening
5 motion except: (1) one hour of debate equally divided and
6 controlled by the chair and ranking minority member of
7 the Committee on the Judiciary or their respective des-
8 ignees; and (2) one motion to recommit.

9 SEC. 2. Upon adoption of this resolution it shall be
10 in order to consider in the House the bill (H.R. 10326)
11 to enhance information-sharing capabilities between Fed-
12 eral law enforcement and State agencies to detect, inves-
13 tigate, and prosecute fraud in certain Federal programs,
14 and to protect individual privacy. All points of order
15 against consideration of the bill are waived. The bill shall
16 be considered as read. All points of order against provi-
17 sions in the bill are waived. The previous question shall
18 be considered as ordered on the bill and on any amend-
19 ment thereto to final passage without intervening motion
20 except: (1) one hour of debate equally divided and con-
21 trolled by the chair and ranking minority member of the
22 Committee on the Judiciary or their respective designees;
23 and (2) one motion to recommit.

24 SEC. 3. Upon adoption of this resolution it shall be
25 in order to consider in the House the joint resolution (H.J.

1 Res. 210) providing for congressional disapproval under
2 chapter 8 of title 5, United States Code, of the rule sub-
3 mitted by the Environmental Protection Agency relating
4 to “California State Nonroad Engine Pollution Control

6 sion”. All points of order against consideration of the joint
7 resolution are waived. The joint resolution shall be consid-
8 ered as read. All points of order against provisions in the
9 joint resolution are waived. The previous question shall be
10 considered as ordered on the joint resolution and on any
11 amendment thereto to final passage without intervening
12 motion except: (1) one hour of debate equally divided and
13 controlled by the chair and ranking minority member of
14 the Committee on Energy and Commerce or their respec-
15 tive designees; and (2) one motion to recommit.

16 SEC. 4. Upon adoption of this resolution it shall be
17 in order to consider in the House the joint resolution (H.J.
18 Res. 213) providing for congressional disapproval under
19 chapter 8 of title 5, United States Code, of the rule issued
20 by the Environmental Protection Agency relating to the
21 “California State Nonroad Engine Pollution Control
22 Standards; Commercial Harbor Craft Regulations; Notice
23 of Decision”. All points of order against consideration of
24 the joint resolution are waived. The joint resolution shall
25 be considered as read. All points of order against provi-

1 sions in the joint resolution are waived. The previous ques-
2 tion shall be considered as ordered on the joint resolution
3 and on any amendment thereto to final passage without
4 intervening motion except: (1) one hour of debate equally
5 divided and controlled by the chair and ranking minority
6 member of the Committee on Energy and Commerce or
7 their respective designees; and (2) one motion to recom-
8 mit.

9 SEC. 5. Upon adoption of this resolution it shall be
10 in order to take from the Speaker's table the bill (H.R.
11 5334) to amend the Internal Revenue Code of 1986 to
12 allow early childhood educators to take the educator ex-
13 pense deduction, and for other purposes, with the Senate
14 amendments thereto, and to consider in the House, with-
15 out intervention of any point of order, a single motion of-
16 fered by the chair of the Committee on Foreign Affairs
17 or his designee that the House concur in the Senate
18 amendments. The Senate amendments and the motion
19 shall be considered as read. The motion shall be debatable
20 for one hour equally divided and controlled by the chair
21 and ranking minority member of the Committee on For-
22 eign Affairs or their respective designees. The previous
23 question shall be considered as ordered on the motion to
24 its adoption without intervening motion or demand for di-
25 vision of the question.
