RESOLUTION

Providing for consideration of the joint resolution (H.J. Res. 24) providing for congressional disapproval under chapter 8 of title 5, United States Code, of the rule submitted by the Department of Energy relating to “Energy Con-

ervation Program: Energy Conservation Standards for Walk-In Coolers and Walk-In Freezers”; providing for consideration of the joint resolution (H.J. Res. 75) providing for congressional disapproval under chapter 8 of title 5, United States Code, of the rule submitted by the Office of Energy Efficiency and Renewable Energy, Department of Energy relating to “Energy Conservation Program: Energy Conservation Standards for Commercial Refrigerators, Freezers, and Refrigerator-Freezers”; and providing for consideration of the bill (H.R. 1048) to amend the Higher Education Act of 1965 to strengthen disclosure requirements relating to foreign gifts and contracts, to prohibit contracts between institutions of higher education and certain foreign entities and countries of concern, and for other purposes.

1 *Resolved*, That upon adoption of this resolution it
 2 shall be in order to consider in the House the joint resolu-
 3 tion (H.J. Res. 24) providing for congressional dis-
 4 approval under chapter 8 of title 5, United States Code,
 5 of the rule submitted by the Department of Energy relat-
 6 ing to “Energy Conservation Program: Energy Conserva-
 7 tion Standards for Walk-In Coolers and Walk-In Freez-
 8 ers”. All points of order against consideration of the joint
 9 resolution are waived. The joint resolution shall be consid-
 10 ered as read. All points of order against provisions in the
 11 joint resolution are waived. The previous question shall be
 12 considered as ordered on the joint resolution and on any
 13 amendment thereto to final passage without intervening
 14 motion except: (1) one hour of debate equally divided and

1 controlled by the chair and ranking minority member of
2 the Committee on Energy and Commerce or their respec-
3 tive designees; and (2) one motion to recommit.

4 SEC. 2. Upon adoption of this resolution it shall be
5 in order to consider in the House the joint resolution (H.J.
6 Res. 75) providing for congressional disapproval under
7 chapter 8 of title 5, United States Code, of the rule sub-
8 mitted by the Office of Energy Efficiency and Renewable
9 Energy, Department of Energy relating to “Energy Con-
10 servation Program: Energy Conservation Standards for
11 Commercial Refrigerators, Freezers, and Refrigerator-
12 Freezers”. All points of order against consideration of the
13 joint resolution are waived. The joint resolution shall be
14 considered as read. All points of order against provisions
15 in the joint resolution are waived. The previous question
16 shall be considered as ordered on the joint resolution and
17 on any amendment thereto to final passage without inter-
18 vening motion except: (1) one hour of debate equally di-
19 vided and controlled by the chair and ranking minority
20 member of the Committee on Energy and Commerce or
21 their respective designees; and (2) one motion to recom-
22 mit.

23 SEC. 3. At any time after adoption of this resolution
24 the Speaker may, pursuant to clause 2(b) of rule XVIII,
25 declare the House resolved into the Committee of the

1 Whole House on the state of the Union for consideration
2 of the bill (H.R. 1048) to amend the Higher Education
3 Act of 1965 to strengthen disclosure requirements relating
4 to foreign gifts and contracts, to prohibit contracts be-
5 tween institutions of higher education and certain foreign
6 entities and countries of concern, and for other purposes.
7 The first reading of the bill shall be dispensed with. All
8 points of order against consideration of the bill are waived.
9 General debate shall be confined to the bill and shall not
10 exceed one hour equally divided and controlled by the chair
11 and ranking minority member of the Committee on Edu-
12 cation and Workforce or their respective designees. After
13 general debate the bill shall be considered for amendment
14 under the five-minute rule. In lieu of the amendment in
15 the nature of a substitute recommended by the Committee
16 on Education and Workforce now printed in the bill, an
17 amendment in the nature of a substitute consisting of the
18 text of Rules Committee Print 119–1 shall be considered
19 as adopted in the House and in the Committee of the
20 Whole. The bill, as amended, shall be considered as the
21 original bill for the purpose of further amendment under
22 the five-minute rule and shall be considered as read. All
23 points of order against provisions in the bill, as amended,
24 are waived. No further amendment to the bill, as amended,
25 shall be in order except those printed in the report of the

1 Committee on Rules accompanying this resolution. Each
2 such further amendment may be offered only in the order
3 printed in the report, may be offered only by a Member
4 designated in the report, shall be considered as read, shall
5 be debatable for the time specified in the report equally
6 divided and controlled by the proponent and an opponent,
7 shall not be subject to amendment, and shall not be sub-
8 ject to a demand for division of the question in the House
9 or in the Committee of the Whole. All points of order
10 against such further amendments are waived. At the con-
11 clusion of consideration of the bill for amendment the
12 Committee shall rise and report the bill, as amended, to
13 the House with such further amendments as may have
14 been adopted. The previous question shall be considered
15 as ordered on the bill, as amended, and on any further
16 amendment thereto to final passage without intervening
17 motion except one motion to recommit.
