## RESOLUTION

Providing for consideration of the bill (H.R. 2483) to reauthorize certain programs that provide for opioid use disorder prevention, treatment, and recovery, and for other purposes; providing for consideration of the bill (H.R. 2931) to direct the Administrator of the Small Business

Administration to relocate certain offices of the Small Business Administration in sanctuary jurisdictions, and for other purposes; providing for consideration of the bill (H.R. 2966) to require the Administrator of the Small Business Administration to require an applicant for certain loans of the Administration to provide certain citizenship status documentation, and for other purposes; and providing for consideration of the bill (H.R. 2987) to amend the Small Business Act to require a limit on the number of small business lending companies, and for other purposes.

1       *Resolved*, That at any time after adoption of this reso-  
 2       lution the Speaker may, pursuant to clause 2(b) of rule  
 3       XVIII, declare the House resolved into the Committee of  
 4       the Whole House on the state of the Union for consider-  
 5       ation of the bill (H.R. 2483) to reauthorize certain pro-  
 6       grams that provide for opioid use disorder prevention,  
 7       treatment, and recovery, and for other purposes. The first  
 8       reading of the bill shall be dispensed with. All points of  
 9       order against consideration of the bill are waived. General  
 10      debate shall be confined to the bill and shall not exceed  
 11      one hour equally divided and controlled by the chair and  
 12      ranking minority member of the Committee on Energy  
 13      and Commerce or their respective designees. After general  
 14      debate the bill shall be considered for amendment under  
 15      the five-minute rule. In lieu of the amendment in the na-  
 16      ture of a substitute recommended by the Committee on  
 17      Energy and Commerce now printed in the bill, an amend-

1 ment in the nature of a substitute consisting of the text  
2 of Rules Committee Print 119–4 shall be considered as  
3 adopted in the House and in the Committee of the Whole.  
4 The bill, as amended, shall be considered as the original  
5 bill for the purpose of further amendment under the five-  
6 minute rule and shall be considered as read. All points  
7 of order against provisions in the bill, as amended, are  
8 waived. No further amendment to the bill, as amended,  
9 shall be in order except those printed in part A of the  
10 report of the Committee on Rules accompanying this reso-  
11 lution. Each such further amendment may be offered only  
12 in the order printed in the report, may be offered only  
13 by a Member designated in the report, shall be considered  
14 as read, shall be debatable for the time specified in the  
15 report equally divided and controlled by the proponent and  
16 an opponent, shall not be subject to amendment, and shall  
17 not be subject to a demand for division of the question  
18 in the House or in the Committee of the Whole. All points  
19 of order against such further amendments are waived. At  
20 the conclusion of consideration of the bill for amendment  
21 the Committee shall rise and report the bill, as amended,  
22 to the House with such further amendments as may have  
23 been adopted. The previous question shall be considered  
24 as ordered on the bill, as amended, and on any further

1 amendment thereto to final passage without intervening  
2 motion except one motion to recommit.

3       SEC. 2. Upon adoption of this resolution it shall be  
4 in order to consider in the House the bill (H.R. 2931)  
5 to direct the Administrator of the Small Business Admin-  
6 istration to relocate certain offices of the Small Business  
7 Administration in sanctuary jurisdictions, and for other  
8 purposes. All points of order against consideration of the  
9 bill are waived. The amendment in the nature of a sub-  
10 stitute recommended by the Committee on Small Business  
11 now printed in the bill, modified by the amendment print-  
12 ed in part B of the report of the Committee on Rules ac-  
13 companying this resolution, shall be considered as adopt-  
14 ed. The bill, as amended, shall be considered as read. All  
15 points of order against provisions in the bill, as amended,  
16 are waived. The previous question shall be considered as  
17 ordered on the bill, as amended, and on any further  
18 amendment thereto, to final passage without intervening  
19 motion except: (1) one hour of debate equally divided and  
20 controlled by the chair and ranking minority member of  
21 the Committee on Small Business or their respective des-  
22 ignees; and (2) one motion to recommit.

23       SEC. 3. Upon adoption of this resolution it shall be  
24 in order to consider in the House the bill (H.R. 2966)  
25 to require the Administrator of the Small Business Ad-

1 ministration to require an applicant for certain loans of  
2 the Administration to provide certain citizenship status  
3 documentation, and for other purposes. All points of order  
4 against consideration of the bill are waived. The amend-  
5 ment in the nature of a substitute recommended by the  
6 Committee on Small Business now printed in the bill shall  
7 be considered as adopted. The bill, as amended, shall be  
8 considered as read. All points of order against provisions  
9 in the bill, as amended, are waived. The previous question  
10 shall be considered as ordered on the bill, as amended,  
11 and on any further amendment thereto, to final passage  
12 without intervening motion except: (1) one hour of debate  
13 equally divided and controlled by the chair and ranking  
14 minority member of the Committee on Small Business or  
15 their respective designees; and (2) one motion to recom-  
16 mit.

17       SEC. 4. Upon adoption of this resolution it shall be  
18 in order to consider in the House the bill (H.R. 2987)  
19 to amend the Small Business Act to require a limit on  
20 the number of small business lending companies, and for  
21 other purposes. All points of order against consideration  
22 of the bill are waived. The amendment in the nature of  
23 a substitute recommended by the Committee on Small  
24 Business now printed in the bill shall be considered as  
25 adopted. The bill, as amended, shall be considered as read.

1 All points of order against provisions in the bill, as amend-  
2 ed, are waived. The previous question shall be considered  
3 as ordered on the bill, as amended, and on any further  
4 amendment thereto, to final passage without intervening  
5 motion except: (1) one hour of debate equally divided and  
6 controlled by the chair and ranking minority member of  
7 the Committee on Small Business or their respective des-  
8 ignees; and (2) one motion to recommit.
