## RESOLUTION

Providing for consideration of the bill (H.R. 5371) making continuing appropriations and extensions for fiscal year 2026, and for other purposes; providing for consideration of the resolution (H. Res. 719) honoring the life and legacy of Charles “Charlie” James Kirk; and for other purposes.

- 1       *Resolved*, That upon adoption of this resolution it
- 2 shall be in order to consider in the House the bill (H.R.
- 3 5371) making continuing appropriations and extensions

1 for fiscal year 2026, and for other purposes. All points  
2 of order against consideration of the bill are waived. The  
3 bill shall be considered as read. All points of order against  
4 provisions in the bill are waived. The previous question  
5 shall be considered as ordered on the bill and on any  
6 amendment thereto to final passage without intervening  
7 motion except: (1) one hour of debate equally divided and  
8 controlled by the chair and ranking minority member of  
9 the Committee on Appropriations or their respective des-  
10 ignees; and (2) one motion to recommit.

11 SEC. 2. Upon adoption of this resolution it shall be  
12 in order without intervention of any point of order to con-  
13 sider in the House the resolution (H. Res. 719) honoring  
14 the life and legacy of Charles “Charlie” James Kirk. The  
15 resolution shall be considered as read. The previous ques-  
16 tion shall be considered as ordered on the resolution and  
17 preamble to adoption without intervening motion or de-  
18 mand for division of the question except one hour of de-  
19 bate equally divided and controlled by the chair and rank-  
20 ing minority member of the Committee on Oversight and  
21 Government Reform or their respective designees.

22 SEC. 3. Sections 9, 10, and 11 of House Resolution  
23 707, agreed to September 16, 2025, are each amended by  
24 striking “March 31, 2026” and inserting “January 31,  
25 2026”.
