5 of the text of Rules Committee Print 119–14 shall be con-
6 sidered as adopted. The bill, as amended, shall be consid-
7 ered as read. All points of order against provisions in the
8 bill, as amended, are waived. The previous question shall
9 be considered as ordered on the bill, as amended, and on
10 any further amendment thereto, to final passage without
11 intervening motion except: (1) one hour of debate equally
12 divided among and controlled by the chair and ranking
13 minority member of the Committee on Education and
14 Workforce or their respective designees and the chair and
15 ranking minority member of the Committee on Energy
16 and Commerce or their respective designees; and (2) one
17 motion to recommit.

18 SEC. 2. Upon adoption of this resolution it shall be
19 in order to consider in the House any bill specified in sec-
20 tion 3 of this resolution. All points of order against consid-
21 eration of each such bill are waived. The respective amend-
22 ments in the nature of a substitute recommended by the
23 Committee on Education and Workforce now printed in
24 each such bill shall be considered as adopted. Each such
25 bill, as amended, shall be considered as read. All points

1 of order against provisions in each such bill, as amended,
2 are waived. The previous question shall be considered as
3 ordered on each such bill, as amended, and on any further
4 amendment thereto, to final passage without intervening
5 motion except: (1) one hour of debate equally divided and
6 controlled by the chair and ranking minority member of
7 the Committee on Education and Workforce or their re-
8 spective designees; and (2) one motion to recommit.

9 SEC. 3. The bills referred to in section 2 of this reso-
10 lution are as follows:

11 (a) The bill (H.R. 1005) to prohibit elementary and
12 secondary schools from accepting funds from or entering
13 into contracts with the Government of the People's Repub-
14 lic of China and the Chinese Communist Party, and for
15 other purposes.

16 (b) The bill (H.R. 1049) to ensure that parents are
17 aware of foreign influence in their child's public school,
18 and for other purposes.

19 (c) The bill (H.R. 1069) to prohibit the availability
20 of Federal education funds for elementary and secondary
21 schools that receive direct or indirect support from the
22 Government of the People's Republic of China.

23 SEC. 4. Upon adoption of this resolution it shall be
24 in order to consider in the House the bill (H.R. 2965)
25 to require the Administrator of the Small Business Ad-

1 ministration to ensure that the small business regulatory
2 budget for a small business concern in a fiscal year is not
3 greater than zero, and for other purposes. All points of
4 order against consideration of the bill are waived. The
5 amendment in the nature of a substitute recommended by
6 the Committee on Small Business now printed in the bill
7 shall be considered as adopted. The bill, as amended, shall
8 be considered as read. All points of order against provi-
9 sions in the bill, as amended, are waived. The previous
10 question shall be considered as ordered on the bill, as
11 amended, and on any further amendment thereto, to final
12 passage without intervening motion except: (1) one hour
13 of debate equally divided and controlled by the chair and
14 ranking minority member of the Committee on Small
15 Business or their respective designees; and (2) one motion
16 to recommit.

17 SEC. 5. Upon adoption of this resolution it shall be
18 in order to consider in the House the bill (H.R. 4305)
19 to direct the Chief Counsel for Advocacy of the Small
20 Business Administration to establish a Red Tape Hotline
21 to receive notifications of burdensome agency rules, and
22 for other purposes. All points of order against consider-
23 ation of the bill are waived. The amendment in the nature
24 of a substitute recommended by the Committee on Small
25 Business now printed in the bill shall be considered as

1 adopted. The bill, as amended, shall be considered as read.
2 All points of order against provisions in the bill, as amend-
3 ed, are waived. The previous question shall be considered
4 as ordered on the bill, as amended, and on any further
5 amendment thereto, to final passage without intervening
6 motion except: (1) one hour of debate equally divided and
7 controlled by the chair and ranking minority member of
8 the Committee on Small Business or their respective des-
9 ignees; and (2) one motion to recommit.
