Impeaching Donald John Trump, President of the United States for high crimes and misdemeanors.

IN THE HOUSE OF REPRESENTATIVES

DECEMBER 10, 2025

Mr. GREEN of Texas submitted the following resolution; which was referred to the Committee on the Judiciary

RESOLUTION

Impeaching Donald John Trump, President of the United States for high crimes and misdemeanors.

1 *Resolved*, That Donald John Trump, President of the
2 United States, is an abuser of Presidential power who, if
3 left in office, will continue to promote the incitement of
4 violence, engender invidious hate, undermine our democ-
5 racy, and dissolve our Republic, that he is impeached for
6 high crimes and misdemeanors, and that the following ar-
7 ticles of impeachment be exhibited to the United States
8 Senate:

9 Articles of impeachment exhibited by the House of
10 Representatives of the United States of America in the

1 name of itself and of the people of the United States of
2 America, against Donald J. Trump, President of the
3 United States of America, in maintenance and support of
4 its impeachment against him for high crimes and mis-
5 demeanors.

6 ARTICLE I: ABUSE OF PRESIDENTIAL POWER BY CALLING
7 FOR THE EXECUTION OF MEMBERS OF CONGRESS

8 In his conduct of the office of President of the United
9 States, Donald John Trump, in violation of his constitu-
10 tional oath to faithfully execute the office of the President
11 of the United States and, to the best of his ability, pre-
12 serve, protect, and defend the Constitution of the United
13 States, and in violation of his constitutional duty to take
14 care that the laws be faithfully executed, has unfaithfully,
15 dangerously, and unconstitutionally abused his official po-
16 sition by threatening Democratic lawmakers in Congress
17 with execution.

18 President Trump called for the execution of six
19 Democratic lawmakers, all of whom are currently serving
20 in the U.S. Senate or U.S. House of Representatives and
21 who previously served in the U.S. Military or in U.S. Intel-
22 ligence communities, in response to a short video that they
23 posted on November 18, 2025. In their video, the Demo-
24 cratic lawmakers appropriately urged current members of
25 the military and intelligence communities to adhere to the
26 Constitution and the laws of our country. They specifically

1 said: “Like us, you all swore an oath to protect and defend
2 this Constitution. Right now, the threats to our Constitu-
3 tion aren’t just coming from abroad, but from right here
4 at home. Our laws are clear. You can refuse illegal orders.
5 You can refuse illegal orders. You must refuse illegal or-
6 ders. No one has to carry out orders that violate the law
7 or our Constitution.”

8 On November 20, 2025, in response, President
9 Trump called for their execution. In one social media post,
10 he wrote: “It’s called SEDITIOUS BEHAVIOR AT THE
11 HIGHEST LEVEL. Each one of these traitors to our
12 Country should be ARRESTED AND PUT ON TRIAL.
13 Their words cannot be allowed to stand—We won’t have
14 a Country anymore!!! An example MUST BE SET. Presi-
15 dent DJT.” In another, he wrote of the lawmakers: “SE-
16 DITIOUS BEHAVIOR, punishable by DEATH!” Dan-
17 gerously and unconstitutionally, he reposted a third par-
18 ty’s post: “HANG THEM GEORGE WASHINGTON
19 WOULD!!”

20 President Trump’s call for the execution of law-
21 makers is a reckless and flagrant abuse of Presidential
22 power that promotes extra-judicial punishment and the as-
23 sassination of Members of Congress, and warrants im-
24 peachment by the U.S. House of Representatives and trial
25 by the Senate.

1 ARTICLE II: ABUSE OF PRESIDENTIAL POWER TO INTIMI-
2 DATE FEDERAL JUDGES IN VIOLATION OF THE SEP-
3 ARATION OF POWERS AND INDEPENDENCE OF THE
4 JUDICIARY

5 In his conduct of the office of President of the United
6 States, Donald John Trump, in violation of his constitu-
7 tional oath to faithfully execute the office of President of
8 the United States and, to the best of his ability, preserve,
9 protect, and defend the Constitution of the United States,
10 and in violation of his constitutional duty to take care that
11 the laws be faithfully executed, has unfaithfully, dan-
12 gerously, and unconstitutionally abused his official posi-
13 tion by threatening Federal judges.

14 President Trump has fostered a political climate in
15 which lawmakers and judges face threats of political vio-
16 lence and physical assault; and in this climate has made
17 threats and vituperative comments against Federal judges,
18 putting at risk their safety and well-being, and under-
19 mining the independence of our judiciary.

20 Case in point, in response to a Federal district court
21 ruling with which President Trump disagreed, he posted:
22 “This Radical Left Lunatic of a Judge, a troublemaker
23 and agitator who was sadly appointed by Barack Hussein
24 Obama, was not elected President . . . This judge, like

1 many of the Crooked Judges’ I am forced to appear be-
2 fore, should be IMPEACHED!!!”

3 Another U.S. District Chief Judge has reported re-
4 ceiving increased numbers of violent threats, particularly
5 after he began hearing arguments in a lawsuit against the
6 Trump administration.

7 In 2025, roughly a third of the Federal judiciary has
8 been flooded with threats, with data showing that these
9 threats spike each time Trump uses abusive rhetoric
10 against judges.

11 On May 2, 2025, Reuters reported that U.S. Su-
12 preme Court Justice Ketanji Brown Jackson addressed
13 President Donald Trump’s attacks on the judiciary. The
14 relevant part of the article stated as follows:

15 “(1) “U.S. Supreme Court Justice Ketanji
16 Brown Jackson said on Thursday attacks by Repub-
17 lican President Donald Trump and his allies on
18 judges were ‘not random’ and seemed ‘designed to
19 intimidate the judiciary.’”

20 “(2) Specifically, U.S. Supreme Court Justice
21 Jackson remarked that, “The attacks are not ran-
22 dom. They seem designed to intimidate those of us
23 who serve in this critical capacity.”

24 “(3) Justice Jackson added, “The threats and
25 harassment are attacks on our democracy, on our

1 system of government. And they ultimately risk un-
2 dermining our Constitution and the rule of law.”.

3 The judiciary is afforded power over “all Cases, in
4 Law and Equity, arising under this Constitution, the
5 Laws of the United States, and Treaties made” and “to
6 Controversies to which the United States shall be a
7 Party.” U.S. Const. art. III, sec. 2. Intimidating judges,
8 and recklessly calling for the impeachment and removal
9 of judges who disagree with him demonstrate a willingness
10 by Trump to usurp authority afforded by our Constitution
11 to the judiciary and demonstrate a disregard for the Con-
12 stitution and the careful balance of powers that protects
13 our country from abuses by any single branch.

14 President Trump’s threats place the lives of Federal
15 judges, court officials, and innocent bystanders at risk,
16 promote the incitement of violence, and undermine our de-
17 mocracy, which cannot survive where President Trump’s
18 incendiary comments engender invidious hate and where
19 dissent is punishable by death.

20 In all of this, Donald John Trump has acted in a
21 manner contrary to his trust as President and subversive
22 of constitutional government to the great prejudice of the
23 cause of law and justice and to the manifest injury of the
24 people of the United States.

- 1 Wherefore Donald John Trump, by such conduct,
- 2 warrants impeachment, trial, and removal from office.
