## A BILL

To direct the Attorney General to include a data field in the National Missing and Unidentified Persons System to indicate whether the last known location of a missing person was confirmed or was suspected to have been on Federal land, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Tracking and Report-  
3 ing Absent Community-Members Everywhere Act” or the  
4 “TRACE Act”.

5 **SEC. 2. DEFINITIONS.**

6 In this Act:

7 (1) **ATTORNEY GENERAL.**—The term “Attorney  
8 General” means the Attorney General, acting  
9 through the Director of the National Institute of  
10 Justice.

11 (2) **FEDERAL LAND.**—The term “Federal land”  
12 means land owned by the United States that is  
13 under the administrative jurisdiction of—

14 (A) the Secretary of Agriculture;

15 (B) the Secretary of the Interior (except  
16 land held in trust for the benefit of an Indian  
17 Tribe); or

18 (C) the Secretary of Defense only with re-  
19 spect to land and water resources projects ad-  
20 ministered by the Corps of Engineers.

21 **SEC. 3. DATA FIELD IN THE NATIONAL MISSING AND UN-**  
22 **IDENTIFIED PERSONS SYSTEM RELATED TO**  
23 **FEDERAL LAND.**

24 The Attorney General shall include in the National  
25 Missing and Unidentified Persons System a data field to  
26 indicate whether the last known location of the missing

1 person was confirmed or was suspected to have been on  
 2 Federal land, including any specific location details about  
 3 the unit of Federal land that was the last known location  
 4 of the missing person.

5 **SEC. 4. REPORT.**

6 Not later than January 15 of the second calendar  
 7 year that begins after the date of enactment of this Act,  
 8 and annually thereafter, the Attorney General shall submit  
 9 to the Committee on the Judiciary of the Senate and the  
 10 Committee on the Judiciary of the House of Representa-  
 11 tives a report that contains, for the previous calendar year,  
 12 the number of cases in the National Missing and Unidenti-  
 13 fied Persons System for which the missing person's last  
 14 known location was confirmed or was suspected to have  
 15 been on Federal land.

16 **SECTION 1. SHORT TITLE.**

17 *This Act may be cited as the “Tracking and Reporting*

20 **SEC. 2. DEFINITIONS.**

21 *In this Act:*

 3           the administrative jurisdiction of—

4                     (A) the Secretary of Agriculture;

5                     (B) the Secretary of the Interior (except  
 6           land held in trust for the benefit of an Indian  
 7           Tribe); or

8                     (C) the Secretary of Defense only with re-  
 9           spect to land and water resources projects ad-  
 10          ministered by the Corps of Engineers.

11          (3) *TERRITORIAL WATERS OF THE UNITED*  
 12          *STATES*.—The term “territorial waters of the United  
 13          States” means all waters of the territorial sea of the  
 14          United States, 12 nautical miles wide, adjacent to the  
 15          coast of the United States and seaward of the terri-  
 16          torial baseline, as described in Presidential Proclama-  
 17          tion 5928 of December 27, 1988.

18   **SEC. 3. DATA FIELD IN THE NATIONAL MISSING AND UN-**  
 19                     **IDENTIFIED PERSONS SYSTEM RELATED TO**  
 20                     **FEDERAL LAND AND TERRITORIAL WATERS.**

21          The Attorney General shall include in the National  
 22          Missing and Unidentified Persons System a data field to  
 23          indicate whether the last known location of the missing per-  
 24          son was confirmed or was suspected to have been on Federal  
 25          land or in the territorial waters of the United States, in-

1 *cluding any specific location details about the unit of Fed-*  
2 *eral land or the area of the territorial waters of the United*  
3 *States that was the last known location of the missing per-*  
4 *son.*

5 **SEC. 4. REPORT.**

6 *Not later than January 15 of the second calendar year*  
7 *that begins after the date of enactment of this Act, and an-*  
8 *nually thereafter, the Attorney General shall submit to the*  
9 *Committee on the Judiciary of the Senate and the Com-*  
10 *mittee on the Judiciary of the House of Representatives a*  
11 *report that contains, for the previous calendar year, the*  
12 *number of cases in the National Missing and Unidentified*  
13 *Persons System for which the missing person's last known*  
14 *location was confirmed or was suspected to have been on*  
15 *Federal land or in the territorial waters of the United*  
16 *States.*
