A BILL

To amend the Omnibus Crime Control and Safe Streets Act of 1968 to enhance the Comprehensive Opioid Abuse Grant Program, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Opioid Overdose Data
5 Collection Enhancement Act”.

1 **SEC. 2. PURPOSE.**

2 The purpose of this Act is to expand the adoption
3 and implementation of, and provide interoperability of,
4 data collection tools used to track fatal and nonfatal
5 overdoses and opioid overdose reversal medication admin-
6 istration in near real-time through a web-based, mobile-
7 friendly software platform.

8 **SEC. 3. COMPREHENSIVE OPIOID ABUSE GRANT PROGRAM.**

9 Section 3021 of title I of the Omnibus Crime Control
10 and Safe Streets Act of 1968 (34 U.S.C. 10701) is amend-
11 ed—

12 (1) in subsection (a)(1)—

13 (A) in subparagraph (G), by striking “;
14 and” at the end;

15 (B) in subparagraph (H), by striking the
16 period at the end and inserting “; and”; and

17 (C) by adding at the end the following:

18 “(I) an overdose data collection program
19 described in subsection (g)(1).”; and

20 (2) by adding at the end the following:

21 “(g) OVERDOSE DATA COLLECTION PROGRAM.—

22 “(1) IN GENERAL.—An overdose data collection
23 program described in this paragraph is a program
24 under which a State, unit of local government, coaliti-
25 on of law enforcement agencies, or Indian tribe de-
26 velops and implements a data collection tool, includ-

1 ing mobile data mapping applications, with which
 2 the State, unit of local government, coalition of law
 3 enforcement agencies, or Indian tribe can easily and
 4 quickly track the locations of—

5 “(A) suspected fatal and nonfatal
 6 overdoses; and

7 “(B) the administration of opioid overdose
 8 reversal medication by first responders, includ-
 9 ing law enforcement officers, firefighters, and
 10 emergency medical service technicians.

11 “(2) ELIGIBILITY OF COALITIONS.—

12 “(A) IN GENERAL.—Notwithstanding sub-
 13 section (a)(1), a coalition of law enforcement
 14 agencies shall be eligible to receive a grant
 15 under subsection (a) only for the purpose of im-
 16 plementing an overdose data collection program
 17 described in paragraph (1) of this subsection.

18 “(B) REQUIREMENTS.—A coalition of law
 19 enforcement agencies seeking a grant under
 20 subsection (a) to implement an overdose data
 21 collection program described in paragraph (1)
 22 of this subsection shall be subject to the same
 23 requirements and authorizations to which a
 24 States, units of local government, and Indian
 25 tribes are subject under this section, including

1 the requirement to submit an application under
2 section 3022.

3 “(3) REQUIREMENTS.—A State, unit of local
4 government, coalition of law enforcement agencies,
5 or Indian tribe implementing an overdose data col-
6 lection program described in paragraph (1) shall—

7 “(A) support the development of coordi-
8 nated public safety, behavioral health, and pub-
9 lic health responses to the data collected by the
10 tool described in paragraph (1);

11 “(B) focus on areas in which fatal and
12 nonfatal overdoses occur and trends of concern;

13 “(C) provide for interoperability with exist-
14 ing Federal, State, local, and Tribal overdose
15 data collection tools and overdose data collec-
16 tion tools of coalitions of law enforcement agen-
17 cies; and

18 “(D) make data collected through the pro-
19 gram available to Federal, State, Tribal, and
20 territorial governments and coalitions of law en-
21 forcement agencies.

22 “(4) AUDIT; APPLICATION.—A State, unit of
23 local government, coalition of law enforcement agen-
24 cies, or Indian tribe seeking to use a grant received

1 under subsection (a) for a program described in
2 paragraph (1) of this subsection shall—

3 “(A) conduct an audit of available data
4 and resources; and

5 “(B) in order to avoid duplication, submit
6 the audit conducted under subparagraph (A) as
7 a part of the application for the grant of the
8 State, unit of local government, coalition of law
9 enforcement agencies, or Indian tribe.

10 “(5) CONSULTATION.—In carrying out this sub-
11 section, the Attorney General shall consult with the
12 heads of agencies that maintain overdose data collec-
13 tion tools, including the Director of the Office of Na-
14 tional Drug Control Policy.”.
