Mr. LEE (for himself, Mr. JUSTICE, Mr. COTTON, Mr. SCHMITT, Mr. CURTIS, and Mr. HAGERTY) introduced the following bill; which was read twice and referred to the Committee on Energy and Natural Resources

A BILL

To amend the Energy Policy and Conservation Act to modify standards for general service lamps, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Liberating Incandes-
5 cent Technology Act of 2025” or the “LIT Act of 2025”.

6 **SEC. 2. GENERAL SERVICES LAMPS.**

7 (a) COVERED PRODUCTS.—

8 (1) IN GENERAL.—Section 322(a) of the En-
9 ergy Policy and Conservation Act (42 U.S.C.
10 6292(a)) is amended—

1 (A) by striking paragraph (14); and

2 (B) by redesignating paragraphs (15)
3 through (20) as paragraphs (14) through (19),
4 respectively.

5 (2) CONFORMING AMENDMENTS.—

6 (A) Section 321(6)(B) of the Energy Pol-
7 icy and Conservation Act (42 U.S.C.
8 6291(6)(B)) is amended by striking “(15),
9 (16), (17), and (20)” and inserting “(14), (15),
10 (16), and (19)”.

11 (B) Section 324 of the Energy Policy and
12 Conservation Act (42 U.S.C. 6294) is amend-
13 ed—

14 (i) in subsection (a)(2)(C)(i), by strik-
15 ing “322(a)(19)” and inserting
16 “322(a)(18)”;

17 (ii) in subsection (b)(1)(B), by strik-
18 ing “(13), and paragraphs (15) through
19 (20)” and inserting “(19)”; and

20 (iii) in subsection (c)—

21 (I) in paragraph (7)—

22 (aa) by striking “product”
23 and inserting “products”; and

1 (bb) by striking “(17), and
 2 (18)” and inserting “and (17)”;
 3 and
 4 (II) in paragraph (8), in the mat-
 5 ter preceding subparagraph (A), by
 6 striking “(15) or (17)” and inserting
 7 “(14) or (16)”.

8 (C) Section 325(n)(1) of the Energy Policy
 9 and Conservation Act (42 U.S.C. 6295(n)(1)) is
 10 amended by striking “(11), and in paragraphs
 11 (13) and (14)” and inserting “(11) and (13)”.

12 (b) STANDARDS.—

13 (1) IN GENERAL.—Section 325 of the Energy
 14 Policy and Conservation Act (42 U.S.C. 6295) is
 15 amended—

16 (A) by striking subsection (i) and inserting
 17 the following:

18 “(i) RESERVED.—”; and

19 (B) in subsection (l), by striking para-
 20 graph (4).

21 (2) CONFORMING AMENDMENTS.—

22 (A) Section 323(b) of the Energy Policy
 23 and Conservation Act (42 U.S.C. 6293(b)) is
 24 amended—

25 (i) by striking paragraph (6); and

1 (ii) by redesignating paragraphs (7)
 2 through (18) as paragraphs (6) through
 3 (17), respectively.

4 (B) Section 324(a)(2)(D) of the Energy
 5 Policy and Conservation Act (42 U.S.C.
 6 6294(a)(2)(D)) is amended—

7 (i) in clause (i), in the second sen-
 8 tence, by striking “Except as provided in
 9 clause (ii), such rules” and inserting “Such
 10 rules”;

11 (ii) by striking clause (ii);

12 (iii) by redesignating clause (iii) as
 13 clause (ii); and

14 (iv) in subclause (II) of clause (ii) (as
 15 so redesignated)—

16 (I) in item (aa), by striking “;
 17 and” and inserting a period;

18 (II) by striking item (bb); and

19 (III) in the matter preceding
 20 item (aa), by striking “shall—” and
 21 all that follows through “complete” in
 22 item (aa) and inserting “shall com-
 23 plete”.

1 (C) Section 327 of the Energy Policy and
2 Conservation Act (42 U.S.C. 6297) is amend-
3 ed—

4 (i) in subsection (b)—

5 (I) in paragraph (1)(B), by strik-
6 ing “2007” in the matter preceding
7 clause (i) and all that follows through
8 the period at the end of clause (ii)
9 and inserting “2007;”; and

10 (II) in paragraph (4), by striking
11 “or is a regulation (or portion there-
12 of) regulating fluorescent or incandes-
13 cent lamps other than those to which
14 section 325(i) is applicable,”; and

15 (ii) in subsection (c)(1), by striking “,
16 except that” and all that follows through
17 “such lamps”.

18 (D) Section 334 of the Energy Policy and
19 Conservation Act (42 U.S.C. 6304) is amended
20 in the second sentence by striking “a general
21 service incandescent lamp that does not comply
22 with the applicable standard established under
23 section 325(i) or”.

24 (c) TERMINATION OF RULES.—The following rules
25 shall have no force or effect:

1 (1) The rule of the Department of Energy enti-
2 tled “Energy Conservation Program: Energy Con-
3 servation Standards for General Services Lamps”
4 (87 Fed. Reg. 27439 (May 9, 2022)).

7 General Service Lamps” (87 Fed. Reg. 27461 (May
8 9, 2022)).

10 tled “Energy Conservation Program: Energy Con-
11 servation Standards for General Services Lamps”
12 (89 Fed. Reg. 28856 (April 19, 2024)).
