## A BILL

To amend the Richard B. Russell National School Lunch Act to expand the summer electronic benefits transfer for children program to include benefit transfer during school closures, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “Stop Child Hunger  
5       Act of 2025”.

1 **SEC. 2. EXPANSION OF SUMMER ELECTRONIC BENEFITS**  
 2 **TRANSFER FOR CHILDREN PROGRAM.**

3 Section 13A of the Richard B. Russell National  
 4 School Lunch Act (42 U.S.C. 1762) is amended—

5 (1) in subsection (a)—

6 (A) in the matter preceding paragraph (1),  
 7 by inserting “and school closure period, as ap-  
 8 plicable,” after “for each summer”; and

9 (B) in paragraph (2)—

10 (i) by inserting “and school closure  
 11 periods, as applicable,” after “summer  
 12 months”; and

13 (ii) by striking the period at the end  
 14 and inserting “or during a school closure  
 15 period.”;

16 (2) in subsection (b)—

17 (A) in paragraph (2)—

18 (i) in the matter preceding subpara-  
 19 graph (A), by inserting “for summer  
 20 months or a school closure period, as appli-  
 21 cable” after “pursuant to subsection (a)”;

22 (ii) in the matter preceding clause (i),  
 23 by striking “be—” and inserting “be, for  
 24 calendar year 2025 and each year there-  
 25 after, in an amount that is not less than  
 26 the value of breakfast, lunch, and a snack

1 at the free rate for each day of such sum-  
 2 mer months or school closure period; and”;  
 3 and

4 (iii) by striking clauses (i) and (ii) of  
 5 subparagraph (A).

6 (B) in paragraph (4)(A), by inserting “ or  
 7 a school closure period, as applicable” after  
 8 “summer months”;

9 (3) in subsection (c)(1)(A)—

10 (A) by inserting “ or a school closure pe-  
 11 riod, as applicable” after “with respect to sum-  
 12 mer”; and

13 (B) by inserting “or the instructional year  
 14 in which the school closure period begins, as ap-  
 15 plicable,” before “or during”;

16 (4) in subsection (d)—

17 (A) by striking “The Secretary” and in-  
 18 serting the following:

19 “(1) IN GENERAL.—The Secretary”;

20 (B) by striking “an amount equal to 50  
 21 percent of” and inserting “, for”;

22 (C) by striking the period at the end and  
 23 inserting “, an amount calculated in accordance  
 24 with paragraph (2).”; and

25 (D) by adding at the end the following:

1           “(2) CALCULATION.—The amount to be paid by  
 2           the Secretary to each State agency and covered In-  
 3           dian Tribal organization for the administrative ex-  
 4           penses described in paragraph (1) shall be equal  
 5           to—

6                   “(A) for fiscal year 2026, 100 percent of  
 7                   such expenses;

8                   “(B) for fiscal year 2027, 90 percent of  
 9                   such expenses;

10                  “(C) for fiscal year 2028, 80 percent of  
 11                  such expenses;

12                  “(D) for fiscal year 2029, 70 percent of  
 13                  such expenses;

14                  “(E) for fiscal year 2030, 60 percent of  
 15                  such expenses; and

16                  “(F) for fiscal year 2031 and each fiscal  
 17                  year thereafter, 50 percent of such expenses.”;

18           (5) in subsection (h)—

19                   (A) in paragraph (2)—

20                           (i) in the matter preceding subpara-  
 21                           graph (A), by inserting “or school closure  
 22                           period, as applicable” after “summer”;

23                           (ii) in subparagraph (A)—

24                                   (I) by striking “or during” and  
 25                                   inserting “, during”; and

1 (II) by inserting “, or during the  
 2 calendar year in which such school  
 3 closure period began” after “oper-  
 4 ational period”;

5 (iii) in subparagraph (B)—

6 (I) in clause (i)—

7 (aa) by striking “and” at  
 8 the end and inserting “or”; and

9 (bb) by striking “(i) en-  
 10 rolled” and inserting “or during  
 11 the calendar year in which such  
 12 school closure period began, en-  
 13 rolled”; and

14 (II) by striking clause (ii);

15 (B) by redesignating paragraph (4) as  
 16 paragraph (6); and

17 (C) by inserting after paragraph (3) the  
 18 following:

19 “(4) FREE RATE.—The term ‘free rate’ has the  
 20 meaning given the term in section 1101(j)(4) of the  
 21 Families First Coronavirus Response Act (7 U.S.C.  
 22 2011 note).

23 “(5) SCHOOL CLOSURE PERIOD.—The term  
 24 ‘school closure period’ means a period in which an  
 25 elementary school or secondary school is closed, op-

1       erating remotely, or operating in a hybrid manner  
2       for 5 or more consecutive weekdays during a cal-  
3       endar year.”; and

4               (6) by adding at the end the following:

5       “(i) IMPLEMENTATION GRANTS.—

6               “(1) IN GENERAL.—The Secretary shall carry  
7       out a program to make grants to States to support  
8       the development of data systems or upgrades to ex-  
9       isting data systems that are necessary to implement  
10      this section.

11              “(2) FUNDING.—Subject to the availability of  
12      appropriations provided in advance in an appropria-  
13      tions Act specifically for the purpose of carrying out  
14      this section, and in addition to such appropriations,  
15      on October 1, 2025, out of any funds in the Treas-  
16      ury not otherwise appropriated, the Secretary of the  
17      Treasury shall transfer to the Secretary to carry out  
18      this subsection \$50,000,000, to remain available  
19      until expended.”.
