## A BILL

To amend title 38, United States Code, to modify the authority of the Secretary of Veterans Affairs to furnish improvements and structural alterations as part of home health services for disabled veterans.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “Autonomy for Disabled  
5       Veterans Act”.

1 **SEC. 2. MODIFICATION TO AUTHORITY OF SECRETARY OF**  
2 **VETERANS AFFAIRS TO FURNISH IMPROVE-**  
3 **MENTS AND STRUCTURAL ALTERATIONS AS**  
4 **PART OF HOME HEALTH SERVICES FOR DIS-**  
5 **ABLED VETERANS.**

6 (a) INCREASE.—Paragraph (2) of subsection (a) of  
7 section 1717 of title 38, United States Code, is amended—

8 (1) in the matter preceding subparagraph (A),  
9 by inserting “in the case of a veteran” before the em  
10 dash; and

11 (2) by striking subparagraphs (A) and (B) and  
12 inserting the following:

13 “(A) who first applied for benefits under this  
14 paragraph for a non-service-connected disability be-  
15 fore the date of the enactment of the Autonomy for  
16 Disabled Veterans Act and whose disability the Sec-  
17 retary determines is service-connected after such  
18 date, \$6,800; or

19 “(B) who first applied for benefits under this  
20 paragraph on or after the date of the enactment of  
21 the Autonomy for Disabled Veterans Act, \$10,000.”.

22 (b) ADJUSTMENT FOR INFLATION; CAP ON BENE-  
23 FITS.—Such subsection is further amended—

24 (1) by redesignating paragraph (3) as para-  
25 graph (5); and

1           (2) by inserting after paragraph (2) the fol-  
2       lowing new paragraphs:

3       “(3) On the first day of each fiscal year, the dollar  
4       amounts in effect under paragraph (2) shall—

5           “(A) increase by a percentage equal to the per-  
6       centage by which the residential home cost of con-  
7       struction index established under section 2102(e)(3)  
8       of this title increased during the previous fiscal year;  
9       or

10          “(B) if such index did not increase during such  
11       previous fiscal year, remain the same.

12       “(4) The Secretary may not furnish more than three  
13       improvements or structural alterations under paragraph  
14       (2) to a veteran.”.

15       (c) RULE OF CONSTRUCTION.—A veteran who, before  
16       the date of the enactment of this Act, exhausted the eligi-  
17       bility of such veteran for benefits under section 1717 of  
18       title 38, United States Code, shall not be entitled to addi-  
19       tional benefits under such section by reason of the amend-  
20       ments made by this Act.
