A BILL

To repeal certain executive orders targeting LGBTQI+ individuals.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “No Place for
5 LGBTQ+ Hate Act”.

6 **SEC. 2. REPEAL OF EXECUTIVE ORDERS.**

7 (a) IN GENERAL.—

8 (1) NO FORCE OR EFFECT.—The Executive or-
9 ders that target lesbian, gay, bisexual, transgender,

1 queer, or intersex (LGBTQI+) individuals, de-
 2 scribed in subsection (b), and any related or suc-
 3 cessor Executive orders that similarly harm or limit
 4 the rights of LGBTQI+ individuals, shall have no
 5 force or effect.

6 (2) NO FUNDING.—Pursuant to article I of the
 7 Constitution, including the Spending Clause of sec-
 8 tion 8 of article I of the Constitution, no Federal
 9 funds may be used to implement, administer, en-
 10 force, or carry out those Executive orders.

11 (b) EXECUTIVE ORDERS DESCRIBED.—The Execu-
 12 tive orders referred to in subsection (a) are the following:

13 (1) Executive Order 14168 (90 Fed. Reg. 8615;
 14 relating to the Federal interpretation of sex),
 15 which—

16 (A) mandates discrimination against
 17 transgender, nonbinary, intersex, and gender-
 18 nonconforming individuals in the United States;

19 (B) could demolish protections for
 20 LGBTQI+ individuals in employment, edu-
 21 cation, housing, and health care; and

22 (C) refuses appropriate Federal identity
 23 markers to transgender, nonbinary, and
 24 intersex individuals.

1 (2) Executive Order 14183 (90 Fed. Reg. 8757;
2 relating to reinstating and expanding the military
3 ban on transgender servicemembers).

4 (3) Executive Order 14187 (90 Fed. Reg. 8771;
5 relating to directing agencies to take action to pre-
6 vent transgender health care from being provided to
7 adolescents under the age of 19).

8 (4) Executive Order 14201 (90 Fed. Reg. 9279;
9 relating to prohibiting transgender female students
10 from participating on school sports teams aligning
11 with their gender identity).

12 (5) Executive Order 14190 (90 Fed. Reg. 8853;
13 relating to requiring schools to deny the existence of
14 transgender people).

15 **SEC. 3. SAVINGS PROVISION.**

16 Nothing in this Act shall be construed to impair any
17 constitutional authority granted to the President.
