Mr. CORNYN (for himself and Mr. KELLY) introduced the following bill; which was read twice and referred to the Select Committee on Intelligence

A BILL

To require the Director of National Intelligence to submit an action plan to enhance counternarcotics collaboration, coordination, and cooperation with the Government of Mexico, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Counternarcotics En-
5 hancement Act”.

1 **SEC. 2. PLAN TO ENHANCE COUNTERNARCOTICS COLLABO-**
2 **RATION, COORDINATION, AND COOPERATION**
3 **WITH THE GOVERNMENT OF MEXICO.**

4 (a) REQUIREMENT FOR INTELLIGENCE COMMUNITY
5 ELEMENTS.—Not later than 60 days after the date of the
6 enactment of this Act, the head of each element of the
7 intelligence community shall submit to the Director of Na-
8 tional Intelligence the following:

9 (1) A description and assessment of the intel-
10 ligence community element's direct relationship, if
11 any, with any element of the Government of Mexico,
12 including an assessment of the counterintelligence
13 risks of such relationship.

14 (2) A strategy to enhance counternarcotics co-
15 operation and appropriate coordination with each
16 element of the Government of Mexico with which the
17 intelligence community element has a direct relation-
18 ship.

19 (3) Recommendations and a description of the
20 resources required to efficiently and effectively im-
21 plement the strategy required by paragraph (2) in
22 furtherance of the national interest of the United
23 States.

24 (b) REQUIREMENT FOR DIRECTOR OF NATIONAL IN-
25 TELLIGENCE.—Not later than 180 days after the date of
26 the enactment of this Act, the Director of National Intel-

1 ligence shall submit to the congressional intelligence com-
2 mittees the following:

3 (1) The submissions received by the Director
4 pursuant to subsection (a).

5 (2) An action plan to enhance counternarcotics
6 collaboration, coordination, and cooperation with the
7 Government of Mexico, including recommendations
8 or requests for any changes in authorities or re-
9 sources in order to effectuate the plan effectively in
10 fiscal year 2026.

11 (c) FORM.—

12 (1) SUBMISSIONS FROM INTELLIGENCE COMMU-
13 NITY ELEMENTS.—The submissions required by sub-
14 section (b)(1) shall be submitted to the congressional
15 intelligence committees in the same form in which
16 they were submitted to the Director of National In-
17 telligence.

18 (2) ACTION PLAN.—The submission required by
19 subsection (b)(2) shall be submitted in unclassified
20 form, but may include a classified annex.

21 (d) CONGRESSIONAL INTELLIGENCE COMMITTEES
22 DEFINED.—In this section, the term “congressional intel-
23 ligence committees” has the meaning given that term in

1 section 3 of the National Security Act of 1947 (50 U.S.C.
2 3003).
