Mr. BENNET (for himself and Mr. HOEVEN) introduced the following bill;
which was read twice and referred to the Committee on Agriculture, Nu-
trition, and Forestry

A BILL

To reauthorize the Joint Chiefs Landscape Restoration
Partnership program, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Joint Chiefs Reauthor-
5 ization Act of 2025”.

6 **SEC. 2. JOINT CHIEFS LANDSCAPE RESTORATION PART-**
7 **nership PROGRAM.**

8 Section 40808 of the Infrastructure Investment and
9 Jobs Act (16 U.S.C. 6592d) is amended—

10 (1) in subsection (a)(2)—

1 (A) in subparagraph (B), by striking “or”
 2 at the end;

3 (B) in subparagraph (C), by striking the
 4 period at the end and inserting a semicolon;
 5 and

6 (C) by adding at the end the following:

7 “(D) to recover from wildfires; or

8 “(E) to enhance soil, water, and related
 9 natural resources.”;

10 (2) in subsection (b), by adding at the end the
 11 following:

12 “(3) AGENCY COORDINATION.—In carrying out
 13 the Program, the Chief of the Natural Resources
 14 Conservation Service shall—

15 “(A) consider corresponding management
 16 plans from the Chief of the Forest Service; and

17 “(B) collaborate with the Chief of the For-
 18 est Service regarding forestry science and prac-
 19 tice, using the best available science.”;

20 (3) in subsection (d)(1)—

21 (A) in subparagraph (A), by inserting
 22 “and post-wildfire impacts” after “wildfire
 23 risk”; and

24 (B) in subparagraph (F), by inserting “,
 25 as identified in the corresponding State forest

1 action plan or a similar priority plan (such as
2 a State wildlife or water plan)” before the semi-
3 colon at the end;

4 (4) in subsection (f), by striking paragraph (2)
5 and inserting the following:

6 “(2) inconsistently with the prohibitions under
7 the rule of the Forest Service entitled ‘Special
8 Areas; Roadless Area Conservation’ (66 Fed. Reg.
9 3244 (January 12, 2001)), and subparts C and D
10 of part 294 of title 36, Code of Federal Regulations,
11 as applicable;”; and

12 (5) in subsections (g)(2) and (h)(1), by striking
13 “and 2023” each place it appears and inserting
14 “through 2029”.
