## A BILL

To require reporting of price increases on noncompetitive  
contracts, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “Transparency in Con-  
5       tracting Act of 2025”.

6       **SEC. 2. REPORTING OF PRICE INCREASES.**

7       (a) REPORTING OF INCREASES ABOVE SPECIFIED  
8       PRICES.—Chapter 271 of title 10, United States Code, is  
9       amended by adding at the end the following new section:

1 **“§ 3709. Reporting of increases above specified prices**

2 “(a) IN GENERAL.—An offeror shall be required to  
3 report to the relevant contracting officer not later than  
4 30 days after becoming aware that the price of a product  
5 or service under a covered contract reaches or exceeds—

6 “(1) 25 percent above the price specified in the  
7 contract bid or the government paid for that product  
8 or service the previous calendar year; or

9 “(2) 50 percent above the price paid for such  
10 a product or service 5 years earlier.

11 “(b) COVERED CONTRACT DEFINED.—In this sec-  
12 tion, the term ‘covered contract’ means a contract award-  
13 ed without competition under section 3204 of this title and  
14 as defined under section 6.302 of the Federal Acquisition  
15 Regulation.”.

16 (b) INCLUSION OF NONCOMPLIANCE INFORMATION  
17 IN FAPIIS.—Chapter 271 of title 10, United States Code,  
18 as amended by subsection (a), is further amended by add-  
19 ing at the end the following new section:

20 **“§ 3710. Inclusion of noncompliance information in**  
21 **Federal Awardee Performance and Integ-**  
22 **egrity Information System**

23 “The Director of the Defense Contract Audit Agency  
24 or the relevant service acquisition executive shall report  
25 in the Federal Awardee Performance and Integrity Infor-

1 mation System (FAPIS) housed within the System for  
2 Award Management the following information:

3 “(1) Contractors who fail to report price in-  
4 creases as required under 3705(a)(2) of this title.

5 “(2) Updated findings from audits conducted  
6 by the Agency regarding noncompliance with the re-  
7 quirement.

8 “(3) With respect to unreported product or  
9 service price increases, the product or service’s Na-  
10 tional Stock Number, order quantity, unit cost, total  
11 cost, purchasing or reimbursing entity, and date of  
12 the order.”.
