## A BILL

To require the National Telecommunications and Information Administration to issue an annual report regarding the use of spectrum by the Federal Government in certain bands of frequencies, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “Federal Government  
5       Spectrum Inventory Act”.

1 **SEC. 2. ANNUAL REPORTS REGARDING FEDERAL SPEC-**  
2 **TRUM USAGE.**

3 (a) IN GENERAL.—Not later than 180 days after the  
4 date of enactment of this Act, and annually thereafter,  
5 the National Telecommunications and Information Ad-  
6 ministration shall issue a report, which shall be known as  
7 the Federal Government Spectrum Use Report.

8 (b) REQUIREMENTS.—Each report issued under sub-  
9 section (a) shall—

10 (1) address the bands of frequencies from 225  
11 megahertz to 50 gigahertz (referred to in this sub-  
12 section as the “covered bands”);

13 (2) include—

14 (A) an introduction that summarizes the  
15 types of Federal spectrum usage in the covered  
16 bands;

17 (B) an excerpt from the United States  
18 Table of Frequency Allocations, which shall  
19 show—

20 (i) the most recent frequency alloca-  
21 tions in the covered bands within the  
22 United States; and

23 (ii) each relevant footnote, whether  
24 international or with respect to the United  
25 States, that may authorize additional uses,

1                   or impose limits on certain uses, in the  
2                   covered bands;

3                   (C) a table that lists the number and type  
4                   of frequency assignments that the National  
5                   Telecommunications and Information Adminis-  
6                   tration has authorized within the covered  
7                   bands;

8                   (D) a summary of the major systems and  
9                   applications using each frequency band or sub-  
10                  band within the covered bands; and

11                  (E) a description of future uses within  
12                  each band within the covered bands, where ap-  
13                  plicable; and

14                  (3) be made available on the public website of  
15                  the National Telecommunications and Information  
16                  Administration, except that the report shall contain  
17                  a classified annex.
