A BILL

Making continuing appropriations for the fiscal year ending
September 30, 2026, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Continuing Appropria-
5 tions and Extensions and Other Matters Act, 2026”.

DIVISION A—CONTINUING APPROPRIATIONS ACT, 2026

DIVISION B—EXTENSIONS AND OTHER MATTERS

1 **SEC. 3. REFERENCES.**

2 Except as expressly provided otherwise, any reference
3 to “this Act” contained in any division of this Act shall
4 be treated as referring only to the provisions of that divi-
5 sion.

6 **DIVISION A—CONTINUING**
7 **APPROPRIATIONS ACT, 2026**

8 The following sums are hereby appropriated, out of
9 any money in the Treasury not otherwise appropriated,
10 and out of applicable corporate or other revenues, receipts,
11 and funds, for the several departments, agencies, corpora-
12 tions, and other organizational units of Government for
13 fiscal year 2026, and for other purposes, namely.

14 SEC. 101. Such amounts as may be necessary, at a
15 rate for operations as provided for fiscal year 2025 and
16 under the authority and conditions provided, for con-
17 tinuing projects or activities (including the costs of direct
18 loans and loan guarantees) that are not otherwise specifi-
19 cally provided for in this Act, that were conducted in fiscal
20 year 2025, and for which appropriations, funds, or other
21 authority were made available in the Full Year Continuing
22 Appropriations Act, 2025 (division A of Public Law 119–
23 4), except sections 1110, 1113, and 1114, and the proviso
24 in paragraph (4) of section 1602.

1 SEC. 102. (a) No appropriation or funds made avail-
2 able or authority granted pursuant to section 101 for the
3 Department of Defense shall be used for:

4 (1) the new production of items not funded for
5 production in fiscal year 2025 or prior years;

6 (2) the increase in production rates above those
7 sustained with fiscal year 2025 funds; or

8 (3) the initiation, resumption, or continuation
9 of any project, activity, operation, or organization
10 (defined as any project, subproject, activity, budget
11 activity, program element, and subprogram within a
12 program element, and for any investment items de-
13 fined as a P–1 line item in a budget activity within
14 an appropriation account and an R–1 line item that
15 includes a program element and subprogram element
16 within an appropriation account) for which appro-
17 priations, funds, or other authority were not avail-
18 able during fiscal year 2025.

19 (b) No appropriation or funds made available or au-
20 thority granted pursuant to section 101 for the Depart-
21 ment of Defense shall be used to initiate multi-year pro-
22 curements utilizing advance procurement funding for eco-
23 nomic order quantity procurement unless specifically ap-
24 propriated later.

1 SEC. 103. Appropriations made by section 101 shall
2 be available to the extent and in the manner that would
3 be provided by the pertinent appropriations Act.

4 SEC. 104. Except as otherwise provided in section
5 102, no appropriation or funds made available or author-
6 ity granted pursuant to section 101 shall be used to ini-
7 tiate or resume any project or activity for which appro-
8 priations, funds, or other authority were not available dur-
9 ing fiscal year 2025.

10 SEC. 105. Appropriations made and authority grant-
11 ed pursuant to this Act shall cover all obligations or ex-
12 penditures incurred for any project or activity during the
13 period for which funds or authority for such project or
14 activity are available under this Act.

15 SEC. 106. Unless otherwise provided for in this Act
16 or in the applicable appropriations Act for fiscal year
17 2026, appropriations and funds made available and au-
18 thority granted pursuant to this Act shall be available
19 until whichever of the following first occurs:

20 (1) The enactment into law of an appropriation
21 for any project or activity provided for in this Act.

22 (2) The enactment into law of the applicable
23 appropriations Act for fiscal year 2026 without any
24 provision for such project or activity.

25 (3) October 31, 2025.

1 SEC. 107. Expenditures made pursuant to this Act
2 shall be charged to the applicable appropriation, fund, or
3 authorization whenever a bill in which such applicable ap-
4 propriation, fund, or authorization is contained is enacted
5 into law.

6 SEC. 108. Appropriations made and funds made
7 available by or authority granted pursuant to this Act may
8 be used without regard to the time limitations for submis-
9 sion and approval of apportionments set forth in section
10 1513 of title 31, United States Code, but nothing in this
11 Act may be construed to waive any other provision of law
12 governing the apportionment of funds.

13 SEC. 109. Notwithstanding any other provision of
14 this Act, except section 106, for those programs that
15 would otherwise have high initial rates of operation or
16 complete distribution of appropriations at the beginning
17 of fiscal year 2026 because of distributions of funding to
18 States, foreign countries, grantees, or others, such high
19 initial rates of operation or complete distribution shall not
20 be made, and no grants shall be awarded for such pro-
21 grams funded by this Act that would impinge on final
22 funding prerogatives.

23 SEC. 110. This Act shall be implemented so that only
24 the most limited funding actions of that permitted in the

1 Act shall be taken in order to provide for continuation of
2 projects and activities.

3 SEC. 111. Notwithstanding section 101, section 739
4 of title VII of division B of Public Law 118–47, as contin-
5 ued in effect by division A of Public Law 119–4, shall be
6 applied as if it read as follows:

7 “SEC. 739. None of the funds made available in this
8 or any other appropriations Act may be used to increase,
9 eliminate, or reduce funding for a program, project, or ac-
10 tivity as proposed in the President’s budget request for
11 a fiscal year until such proposed change is subsequently
12 enacted in an appropriation Act.”.

13 SEC. 112. (a) For entitlements and other mandatory
14 payments whose budget authority was provided in appro-
15 priations Acts specified in section 101, for expenses au-
16 thorized under section 324 of title 38, United States Code,
17 and for activities under the Food and Nutrition Act of
18 2008, activities shall be continued at the rate to maintain
19 program levels under current law, under the authority and
20 conditions provided in the applicable appropriations Act,
21 to be continued through the date specified in section
22 106(3).

23 (b) Notwithstanding section 106, obligations for man-
24 datory payments due on or about the first day of any
25 month that begins after October 2025 but not later than

1 30 days after the date specified in section 106(3) may con-
2 tinue to be made, and funds shall be available for such
3 payments.

4 SEC. 113. Amounts made available under section 101
5 for civilian personnel compensation and benefits in each
6 department and agency may be apportioned up to the rate
7 for operations necessary to avoid furloughs within such de-
8 partment or agency, consistent with the applicable appro-
9 priations Act for fiscal year 2025, except that such author-
10 ity provided under this section shall not be used until after
11 the department or agency has taken all necessary actions
12 to reduce or defer non-personnel-related administrative ex-
13 penses.

14 SEC. 114. Funds appropriated by this Act may be
15 obligated and expended notwithstanding section 10 of
16 Public Law 91–672 (22 U.S.C. 2412), section 15 of the
17 State Department Basic Authorities Act of 1956 (22
18 U.S.C. 2680), section 313 of the Foreign Relations Au-
19 thorization Act, Fiscal Years 1994 and 1995 (22 U.S.C.
20 6212), and section 504(a)(1) of the National Security Act
21 of 1947 (50 U.S.C. 3094(a)(1)).

22 SEC. 115. (a)(1) For each amount incorporated by
23 reference in this Act that was previously designated by the
24 Congress as an emergency requirement pursuant to sec-
25 tion 251(b)(2)(A)(i) of the Balanced Budget and Emer-

1 gency Deficit Control Act of 1985, each provision of law
2 designating each such amount as an emergency require-
3 ment pursuant to such section shall not apply.

4 (2) Each amount incorporated by reference in this
5 Act that was designated by the Congress as an emergency
6 requirement pursuant to section 251(b)(2)(A)(i) of the
7 Balanced Budget and Emergency Deficit Control Act of
8 1985 in the following provisions of law are designated by
9 the Congress as an emergency requirement pursuant to
10 pursuant to section 4001(a)(1) of S. Con. Res. 14 (117th
11 Congress), the concurrent resolution on the budget for fis-
12 cal year 2022, and to legislation establishing fiscal year
13 2026 budget enforcement in the House of Representatives:

14 (A) Sections 1808 and 11206(4) of division A
15 of Public Law 119–4; and

16 (B) Sections 110 and 112 of division D of Pub-
17 lic Law 118–42, and sections 7068(b) and 7069 of
18 division F Public Law 118–47, as continued in ef-
19 fect by section 1101 of division A of Public Law
20 119–4.

21 (b) Each amount incorporated by reference in this
22 Act that was previously designated by the Congress as
23 being for disaster relief pursuant to section 251(b)(2)(D)
24 of the Balanced Budget and Emergency Deficit Control
25 Act of 1985 is designated by the Congress as being for

1 disaster relief pursuant to a concurrent resolution on the
2 budget.

3 (c) Each amount incorporated by reference in this
4 Act that was previously designated in division B of Public
5 Law 117–159, division J of Public Law 117–58, or in sec-
6 tion 443(b) of division G of Public Law 117–328 by the
7 Congress as an emergency requirement pursuant to a con-
8 current resolution on the budget shall continue to be treat-
9 ed as an amount specified in section 103(b) of division
10 A of Public Law 118–5.

11 (d) This section shall become effective immediately
12 upon enactment of this Act, and shall remain in effect
13 through the date in section 106(3).

14 SEC. 116. (a) Notwithstanding subsection (b) of sec-
15 tion 1110 of division A of Public Law 119–4, each amount
16 designated by the Congress as an emergency requirement
17 pursuant to section 251(b)(2)(A)(i) of the Balanced Budg-
18 et and Emergency Deficit Control Act of 1985 by sub-
19 section (a) of such section 1110 shall be available (or
20 repurposed, rescinded, or transferred, if applicable) as if
21 all such amounts had been so-designated by the President
22 in accordance with subsection (b) of such section 1110 and
23 such designations had been transmitted to the Congress:
24 *Provided*, That obligations incurred in anticipation of the
25 appropriations made and authority granted by this para-

1 graph are hereby ratified and approved if otherwise in ac-
 2 cord with the authorities and conditions applicable to the
 3 amounts designated as an emergency requirement by sub-
 4 section (a) of such section 1110.

5 (b) Section 251(b)(2)(A) of the Balanced Budget and
 6 Emergency Deficit Control Act of 1985 is amended by
 7 striking “and the President subsequently so designates”
 8 each place it appears.

9 (c) Section 103(a) of division A of Public Law 118–
 10 5 shall also apply to the budgetary effects of this section.

11 (d)(1) Subject to paragraph (2), this section shall be-
 12 come effective immediately upon enactment of this Act.

13 (2) If this Act is enacted after September 30, 2025,
 14 this section shall be applied as if it were in effect on Sep-
 15 tember 30, 2025.

16 SEC. 117. (a) Rescissions or cancellations of discre-
 17 tionary budget authority that continue pursuant to section
 18 101 in Treasury Appropriations Fund Symbols (TAFS)—

19 (1) to which other appropriations are not pro-
 20 vided by this Act, but for which there is a current
 21 applicable TAFS that does receive an appropriation
 22 in this Act; or

23 (2) which are no-year TAFS and receive other
 24 appropriations in this Act, may be continued instead
 25 by reducing the rate for operations otherwise pro-

1 vided by section 101 for such current applicable
2 TAFS, as long as doing so does not impinge on the
3 final funding prerogatives of the Congress.

4 (b) Rescissions or cancellations described in sub-
5 section (a) shall continue in an amount equal to the lesser
6 of—

7 (1) the amount specified for rescission or can-
8 cellation in the applicable appropriations Act ref-
9 erenced in section 101 of this Act; or

10 (2) the amount of balances available, as of Oc-
11 tober 1, 2025, from the funds specified for rescission
12 or cancellation in the applicable appropriations Act
13 referenced in section 101 of this Act.

14 (c) No later than October 31, 2025, the Director of
15 the Office of Management and Budget shall provide to the
16 Committees on Appropriations of the House of Represent-
17 atives and the Senate a comprehensive list of the rescis-
18 sions or cancellations that will continue pursuant to sec-
19 tion 101: *Provided*, That the information in such com-
20 prehensive list shall be periodically updated to reflect any
21 subsequent changes in the amount of balances available,
22 as of October 1, 2025, from the funds specified for rescis-
23 sion or cancellation in the applicable appropriations Act
24 referenced in section 101, and such updates shall be trans-

mitted to the Committees on Appropriations of the House of Representatives and the Senate upon request.

SEC. 118. (a) The remaining unobligated balances, as of September 30, 2025, from amounts appropriated by this or any other Act, including prior Acts and laws other than appropriations Acts (including, but not limited to, balances proposed for rescission in the President’s special message, presented to the U.S. Senate as EC–1680 on September 8, 2025), that—

(1) are subject to apportionment pursuant to section 1513(b) of title 31, United States Code;

(2) were not, at least 90 days prior to the expiration of the period of availability of such amount, made available in an apportionment for immediate obligation, without precondition (including by footnote), and thereafter continuously available for immediate obligation during such 90-day period; and

(3) were not available for obligation after September 30, 2025 prior to the enactment of this Act, shall remain available until September 30, 2026, for the same purposes and under the same authorities and conditions for which each such amount was provided, and shall hereafter be exempt from apportionment, notwithstanding subchapter II of chapter 15 of title 31, United States Code: *Provided*, That section 103(a) of division A of Pub-

1 lie Law 118–5 shall also apply to the budgetary effects
2 of this provision.

3 (b) Not later than November 17, 2025, the Director
4 of the Office of Management and Budget shall provide to
5 the Committees on Appropriations of the House of Rep-
6 resentatives and the Senate a comprehensive list of
7 amounts extended until September 30, 2026 by this sec-
8 tion.

9 (c) Not later than January 15, 2026, the Comptroller
10 General of the United States shall perform an audit for
11 compliance with this section and report its findings to the
12 Committees on Appropriations of the House of Represent-
13 atives and the Senate and shall perform any subsequent
14 periodic audit for compliance with this section determined
15 by the Comptroller General to be appropriate and prompt-
16 ly report any findings to the Committees.

17 (d)(1) Subject to paragraph (2), this section shall be-
18 come effective immediately upon enactment of this Act.

19 (2) If this Act is enacted after September 30, 2025,
20 this section shall be applied as if it were in effect on Sep-
21 tember 30, 2025.

22 SEC. 119. In this fiscal year and thereafter—

23 (1) Subsection (d) of section 1017 of the Con-
24 gressional Budget and Impoundment Control Act of
25 1974 shall have no force or effect.

1 (2) With respect to budget authority proposed
2 to be rescinded or that is set to be reserved or pro-
3 posed to be deferred in a special message trans-
4 mitted under section 1012 or 1013 of the Congres-
5 sional Budget and Impoundment Control Act of
6 1974, such budget authority—

7 (A) shall be made available for obligation
8 in sufficient time to be prudently obligated as
9 required under section 1012(b) or 1013 of such
10 Act; and

11 (B) may not be deferred or otherwise with-
12 held from obligation during the 90-day period
13 before the expiration of the period of avail-
14 ability of such budget authority, including, if
15 applicable, the 90-day period before the expira-
16 tion of an initial period of availability for which
17 such budget authority was provided.

18 (3) With respect to an apportionment of an ap-
19 propriation made pursuant to section 1513(b) of
20 title 31, United States Code, an appropriation (as
21 that term is defined in section 1511 of title 31,
22 United States Code) shall be apportioned—

23 (A) to make available all amounts for obli-
24 gation in sufficient time to be prudently obli-
25 gated; and

1 (B) to make available all amounts for im-
2 mediate obligation, without precondition (in-
3 cluding by footnote), not later than 90 days be-
4 fore the expiration of the period of availability
5 of such appropriation, and thereafter continu-
6 ously available for immediate obligation during
7 such 90-day period.

8 (4) As used in this section, the term “budget
9 authority” includes budget authority made available
10 by this or any other Act, by prior or subsequent ap-
11 propriations Acts, or by any law other than an ap-
12 propriations Act.

13 SEC. 120. Notwithstanding section 101, amounts are
14 provided for “Domestic Food Programs—Food and Nutri-
15 tion Service—Special Supplemental Nutrition Program
16 for Women, Infants, and Children (WIC)” at a rate for
17 operations of \$8,200,000,000.

18 SEC. 121. Section 260 of the Agricultural Marketing
19 Act of 1946 (7 U.S.C. 1636i) and section 942 of the Live-
20 stock Mandatory Reporting Act of 1999 (7 U.S.C. 1635
21 note; Public Law 106–78) shall be applied by substituting
22 the date specified in section 106(3) of this Act for “Sep-
23 tember 30, 2025”.

24 SEC. 122. (a) For the closeout of all Space Shuttle
25 contracts and associated programs, amounts that have ex-

1 pired but have not been cancelled in the Exploration,
2 Space Operations, Human Space Flight, Space Flight Ca-
3 pabilities, and Exploration Capabilities appropriations ac-
4 counts shall remain available through fiscal year 2030 for
5 the liquidation of valid obligations incurred during the pe-
6 riod of fiscal year 2001 through fiscal year 2013.

7 (b)(1) Subject to paragraph (2), this section shall be-
8 come effective immediately upon enactment of this Act.

9 (2) If this Act is enacted after September 30, 2025,
10 this section shall be applied as if it were in effect on Sep-
11 tember 30, 2025.

12 SEC. 123. During the period covered by this Act, any
13 mission in operation, including extended operations, or
14 under development or formulation by the Science Mission
15 Directorate of the National Aeronautics and Space Admin-
16 istration as of September 1, 2025, shall be continued in
17 such operations, development, or formulation.

18 SEC. 124. Amounts made available by section 101 for
19 the “National Science Foundation—Research and Related
20 Activities”, “National Science Foundation—Major Re-
21 search Equipment and Facilities Construction”, “National
22 Science Foundation—STEM Education”, and “National
23 Science Foundation—Agency Operations and Award Man-
24 agement” shall be apportioned at a rate for operations

1 necessary to maintain research facilities and scientific
2 awards at the current level.

3 SEC. 125. Amounts made available by section 101 for
4 “National Oceanic and Atmospheric Administration—Op-
5 erations, Research, and Facilities” shall be apportioned at
6 a rate for operations necessary to maintain the Office of
7 Oceanic and Atmospheric Research at the current level,
8 including for research laboratories, cooperative institutes,
9 and scientific awards.

10 SEC. 126. During the period covered by this Act, the
11 Secretary of Commerce shall renew all cooperative agree-
12 ments authorized by section 278k of title 15, United
13 States Code, for eligible entities in each State and Puerto
14 Rico and each such renewal shall be under the same terms
15 and conditions as the previous agreement, unless re-
16 quested otherwise by the eligible entity.

17 SEC. 127. Amounts made available by section 101 for
18 “Department of Justice—United States Marshals Serv-
19 ice—Salaries and Expenses” may be apportioned up to the
20 rate for operations necessary to maintain program oper-
21 ations.

22 SEC. 128. In addition to amounts otherwise provided
23 by section 101 for “Department of Justice—United States
24 Marshals Service—Salaries and Expenses”, there is ap-
25 propriated \$30,000,000, for an additional amount for fis-

1 cal year 2026, to remain available until September 30,
2 2027, of which \$7,000,000 shall be used to carry out pro-
3 tective operations, and of which \$23,000,000 shall be used
4 to enhance the Federal judicial security mission: *Provided*,
5 That the United States Marshals Service shall provide to
6 the Committees on Appropriations of the House of Rep-
7 resentatives and the Senate quarterly reports, beginning
8 30 days after the date of enactment of this Act, detailing
9 the current United States Marshals Service protective de-
10 tails, the associated cost of those protective details, and
11 the threat assessments or other information used as the
12 basis for providing the protective details: *Provided further*,
13 That such amount is designated by the Congress as being
14 for an emergency requirement pursuant to section
15 4001(a)(1) of S. Con. Res. 14 (117th Congress), the con-
16 current resolution on the budget for fiscal year 2022, and
17 to legislation establishing fiscal year 2026 budget enforce-
18 ment in the House of Representatives.

19 SEC. 129. In addition to amounts otherwise provided
20 by section 101 for “Department of Justice—United States
21 Marshals Service—Construction”, there is appropriated
22 \$30,000,000, for an additional amount for fiscal year
23 2026, to remain available until expended, to support crit-
24 ical courthouse security renovations and upgrades in space
25 that is controlled, occupied, or utilized by the United

1 States Marshals Service, and to secure prisoner movement
2 areas: *Provided*, That such amount is designated by the
3 Congress as being for an emergency requirement pursuant
4 to section 4001(a)(1) of S. Con. Res. 14 (117th Con-
5 gress), the concurrent resolution on the budget for fiscal
6 year 2022, and to legislation establishing fiscal year 2026
7 budget enforcement in the House of Representatives.

8 SEC. 130. During the period covered by this Act, sec-
9 tion 235(b) of the Sentencing Reform Act of 1984 (18
10 U.S.C. 3551 note; Public Law 98–473; 98 Stat. 2032),
11 as such section relates to chapter 311 of title 18, United
12 States Code, and the United States Parole Commission,
13 shall be applied by substituting “38” for “37” each place
14 it appears.

15 SEC. 131. Notwithstanding sections 102 and 104,
16 amounts made available by section 101 of this Act to the
17 Department of Defense for “Shipbuilding and Conversion,
18 Navy” may be apportioned up to the rate for operations
19 necessary to fund completion of prior year shipbuilding
20 programs for the fiscal year 2016 and fiscal year 2018
21 Virginia Class Submarine Programs, in an amount not to
22 exceed \$154,000,000.

23 SEC. 132. (a) Notwithstanding sections 102 and 104,
24 amounts made available by section 101 to the Department
25 of Defense for “Research, Development, Test and Evalua-

tion, Air Force” shall be apportioned up to the rate for operations necessary for the E-7 Wedgetail program, in an amount not to exceed \$199,676,000, only for the purpose of continued rapid prototyping activities, to maintain program schedule and transition to production for the E-7 Wedgetail program: *Provided*, That the Secretary of the Air Force shall obligate such funds without reserving the full estimated cancellation liability for the effort: *Provided further*, That none of the funds appropriated or otherwise made available by this or any other Act, including prior Acts and laws other than appropriations Acts, may be used to pause, cancel, or terminate the E-7 Wedgetail aircraft program or to prepare to pause, cancel, or terminate such program.

(b) Of the unobligated balance of funds made available to the Department of Defense for the E-7 program under the heading “Aircraft Procurement, Air Force” in Public Law 119-4, \$200,000,000 is hereby transferred to and merged with amounts available for the E-7 program under the heading “Research, Development, Test and Evaluation, Air Force” only for the purpose of continued rapid prototyping activities, to maintain program schedule and transition to production for the E-7 Wedgetail program.

1 SEC. 133. Notwithstanding section 101, the first pro-
2 viso under the heading “Department of Energy—Atomic
3 Energy Defense Activities—National Nuclear Security
4 Administration—Weapons Activities” in division D of
5 Public Law 118–42 shall be applied by substituting
6 “\$149,244,000” for “\$118,056,000”.

7 SEC. 134. (a) During the period covered by this Act,
8 title I of Public Law 108–361 (the Calfed Bay-Delta Au-
9 thorization Act) (118 Stat. 1681), as amended by section
10 204 of division D of Public Law 117–103, shall be applied
11 by substituting “2026” for “2022” each place it appears.

12 (b) During the period covered by this Act, section
13 103(f)(4)(A) of title I of Public Law 108–361 (the Calfed
14 Bay-Delta Authorization Act) (118 Stat. 1696) shall be
15 applied by substituting “\$32,600,000” for
16 “\$30,000,000”.

17 SEC. 135. Notwithstanding section 101, the amounts
18 made available to the Department for “Energy Efficiency
19 and Renewable Energy”, “Electricity”, “Fossil Energy
20 and Carbon Management”, and “Cybersecurity, Energy
21 Security, and Emergency Response”, shall be obligated
22 and expended for the programs, projects, and activities,
23 and in the amounts, specified in the “Final Bill” column
24 in the “Department of Energy” table included under the
25 heading “Title III—Department of Energy” in the explan-

1 atory statement described in section 4 in the matter pre-
2 ceding division A of Public Law Public Law 118–42 and
3 subsection (e), (f), and (g) of section 301 of Public Law
