A BILL

To amend the Infrastructure Investment and Jobs Act to include certain yellow coloring as construction materials for purposes of the Build America, Buy America Act, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Paving the Way for
5 American Industry Act”.

1 **SEC. 2. INCLUSION OF CERTAIN MATERIALS IN BUILD**
2 **AMERICA, BUY AMERICA ACT.**

3 (a) IN GENERAL.—Section 70917 of the Infrastruc-
4 ture Investment and Jobs Act (41 U.S.C. 8301 note; Pub-
5 lic Law 117–58) is amended by adding at the end the fol-
6 lowing:

7 “(d) CERTAIN YELLOW PIGMENTS.—

8 “(1) IN GENERAL.—For the purpose of this
9 part—

10 “(A) beginning on the date of enactment of
11 the Paving the Way for American Industry Act,
12 all yellow organic pigments used in water-based
13 paints for road, highway, or airport surface
14 markings shall be considered to be construction
15 materials; and

16 “(B) beginning on the date that is 2 years
17 after the date of enactment of the Paving the
18 Way for American Industry Act, all yellow or-
19 ganic pigments used in all formulas for road,
20 highway, or airport surface markings shall be
21 considered to be construction materials.

22 “(2) PRODUCED IN THE UNITED STATES.—For
23 the purpose of this part, with respect to a yellow or-
24 ganic pigment described in paragraph (1), the term
25 ‘produced in the United States’ means that all man-
26 ufacturing processes from initial combination of ma-

1 terials through the chemical reaction resulting in the
2 synthesized pigment, where chemical reaction is a
3 process (including a biochemical process) that re-
4 sults in a molecule with a new structure by breaking
5 intramolecular bonds and by forming new
6 intramolecular bonds, or by altering the spatial ar-
7 rangement of atoms in a molecule, occurred in the
8 United States.”.

9 (b) IMPLEMENTATION.—Not later than 90 days after
10 the date of enactment of this Act, the Director of the Of-
11 fice of Management and Budget shall update relevant
12 guidance, including the implementation guidance of the
13 Made in America Office, to reflect the amendment made
14 by subsection (a).
