## A BILL

To establish an interagency task force on expediting disaster  
relief funding, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “Disaster Recovery Im-  
5       provement Act”.

6       **SEC. 2. FINDINGS; SENSE OF CONGRESS.**

7       (a) FINDINGS.—Congress finds the following:

8               (1) Numerous programs administered by Fed-  
9       eral agencies, while not dedicated exclusively to dis-

1       aster recovery, play a critical role in supporting and  
2       expediting recovery efforts.

3           (2) The delayed delivery of Federal disaster re-  
4       lief funding to local communities in the wake of re-  
5       cent natural disasters, including Hurricane Helene,  
6       revealed new and longstanding bottlenecks in Fed-  
7       eral disaster response.

8           (3) State and local governments should have  
9       greater input in how the Federal Government ad-  
10      ministers disaster relief assistance and responsibility  
11      for responding to natural disasters.

12      (b) SENSE OF CONGRESS.—It is the sense of Con-  
13      gress that Federal agencies must incorporate rec-  
14      ommendations from State and local governments to im-  
15      prove their disaster response capability.

16      **SEC. 3. DISASTER RECOVERY IMPROVEMENT TASK FORCE.**

17      (a) ESTABLISHMENT.—Not later than 90 days after  
18      the date of enactment of this Act, the Administrator of  
19      the Federal Emergency Management Agency shall estab-  
20      lish an interagency task force on expediting disaster relief  
21      funding to be known as the “Disaster Recovery Improve-  
22      ment Task Force”.

23      (b) MEMBERSHIP.—

24           (1) IN GENERAL.—The interagency task force  
25      established under subsection (a), shall consist of—

1 (A) a senior official from the Federal  
2 Emergency Management Agency, appointed by  
3 the Administrator of the Federal Emergency  
4 Management Agency, to serve as chair;

5 (B) a senior official, appointed by the head  
6 of the respective agency of the official, experi-  
7 enced in handling disaster recovery matters  
8 from each of—

9 (i) the Small Business Administration;

10 (ii) the Department of Housing and  
11 Urban Development;

12 (iii) the Department of Agriculture;

13 (iv) the Department of Health and  
14 Human Services;

15 (v) the Department of Labor;

16 (vi) the Department of Transpor-  
17 tation;

18 (vii) the Department of Commerce;

19 (viii) the Department of the Treasury;

20 (ix) the Department of the Interior;

21 (x) the Environmental Protection  
22 Agency;

23 (xi) the Army Corp of Engineers; and

24 (xii) the Office of Management and  
25 Budget;

1 (C) 4 state governors, jointly appointed by  
2 the Chairs and Ranking Members of the Com-  
3 mittee on Homeland Security and Govern-  
4 mental Affairs of the Senate and the Committee  
5 on Transportation and Infrastructure of the  
6 House of Representatives, representing States  
7 that, during the 3-year period immediately pre-  
8 ceding appointment to the interagency task  
9 force, have experienced a major disaster, as de-  
10 fined in section 401 of the Robert T. Stafford  
11 Disaster Relief and Emergency Assistance Act  
12 (42 U.S.C. 5170), of which—

13 (i) 1 was a hurricane;

14 (ii) 1 was a wildfire;

15 (iii) 1 was a tornado; and

16 (iv) 1 was an earthquake; and

17 (D) 4 county commissioners, jointly ap-  
18 pointed by the Chairs and Ranking Members of  
19 the Committee on Homeland Security and Gov-  
20 ernmental Affairs of the Senate and the Com-  
21 mittee on Transportation and Infrastructure of  
22 the House of Representatives, representing a  
23 county in a State that, during the 3-year period  
24 immediately preceding appointment to the  
25 interagency task force, have experienced a

major disaster, as defined in section 401 of the Robert T. Stafford Disaster Relief and Emergency Assistance Act (42 U.S.C. 5170), of which—

- (i) 1 was a hurricane;
- (ii) 1 was a wildfire;
- (iii) 1 was a tornado; and
- (iv) 1 was an earthquake.

(2) ADVISORY MEMBERS.—Members of Congress representing the Committee on Homeland Security and Governmental Affairs of the Senate and the Committee on Transportation and Infrastructure of the House of Representatives may serve on the interagency task force established under subsection (a) as advisory members in a non-voting capacity.

(c) REPORTS.—

(1) IN GENERAL.—Not later than 1 year after the date of enactment of this Act, the interagency task force established under subsection (a) shall submit to the Committee on Homeland Security and Governmental Affairs of the Senate, the Committee on Transportation and Infrastructure of the House of Representatives, and the Committee on Homeland Security of the House of Representatives and make publicly available a report that—

1 (A) identifies the programs, including tem-  
2 porary programs, for which Congress appro-  
3 priates funds to aid recovery purposes relating  
4 to the consequences of natural disasters;

5 (B) contains recommendations for Federal  
6 agencies on the most effective way to expedite  
7 disaster relief efforts, including recommenda-  
8 tions to—

9 (i) streamline the establishment and  
10 administration of temporary programs;

11 (ii) improve the timeliness, accessi-  
12 bility, and clarity of applications for fund-  
13 ing; and

14 (iii) reduce delays in the review and  
15 obligation of funds with respect to applica-  
16 tions received;

17 (C) identifies the different types of funding  
18 mechanisms for which Congress provides appro-  
19 priations to Federal agencies for disaster relief,  
20 including grants, loans, reimbursements, and  
21 contract authority;

22 (D) contains recommendations to Federal  
23 agencies and Congress on the most effective  
24 way to expedite the expenditure of the funds

1 identified under subparagraph (C) toward dis-  
2 aster relief;

3 (E) contains recommendations for Federal  
4 agencies and Congress to strengthen State ca-  
5 pacity to prepare for, respond to, and recover  
6 from natural disasters;

7 (F) identifies factors that cause delays in  
8 disaster relief program funding being made  
9 available or obligated, including during transi-  
10 tions from one presidential administration to  
11 another presidential administration;

12 (G) includes recommendations on how out-  
13 going and incoming Presidential administra-  
14 tions can equip themselves to set up and deliver  
15 disaster relief aid without delay, including an  
16 assessment of actions required of both outgoing  
17 and incoming Presidential administrations to  
18 ensure continuity and uninterrupted delivery of  
19 disaster relief funding;

20 (H) evaluates barriers within Federal  
21 agencies and across Federal agencies that delay  
22 the obligation or expenditure of disaster relief  
23 funds and provides recommendations to address  
24 those barriers; and

1 (I) assesses specific actions taken by Fed-  
2 eral agencies over time that have improved or  
3 hindered interagency coordination, State and  
4 local engagement, and the timely delivery of  
5 disaster relief funding.

6 (2) RECOMMENDATIONS.—In making rec-  
7 ommendations for the report under paragraph (1),  
8 the interagency task force shall make recommenda-  
9 tions for ways to expedite making available and obli-  
10 gating specific funding appropriated by Congress to  
11 certain agencies, including—

12 (A) to the Federal Emergency Manage-  
13 ment Agency, including with respect to Public  
14 Assistance funding under section 406 of the  
15 Robert T. Stafford Disaster Relief and Emer-  
16 gency Assistance Act (42 U.S.C. 5172) and  
17 Hazard Mitigation Grant Program funding  
18 under section 404 of that Act (42 U.S.C.  
19 5170);

20 (B) to the Department of Housing and  
21 Urban Development, including with respect to  
22 funding under the Community Development  
23 Block Grant Disaster Recovery program;

24 (C) to the Department of Agriculture, in-  
25 cluding with respect to funding for necessary



1 expenses relating to losses of revenue or quality  
2 or production of crops as a consequence of a  
3 major disaster, as defined in section 404 of the  
4 Robert T. Stafford Disaster Relief and Emer-  
5 gency Assistance Act (42 U.S.C. 5170);

6 (D) to the Department of Agriculture, in-  
7 cluding with respect to Forest Service oper-  
8 ations, forest and rangeland research, state,  
9 private, and tribal forestry, and National Forest  
10 System funding for necessary expenses relating  
11 to the consequences of disaster relief;

12 (E) to the Department of Labor, including  
13 with respect to Disaster Recovery Dislocated  
14 Worker Grant funding under section 170 of the  
15 Workforce Innovation and Opportunity Act (29  
16 U.S.C. 3225);

17 (F) to the Department of Commerce, in-  
18 cluding with respect to Economic Development  
19 Administration funding under the Public Works  
20 and Economic Development Act of 1965 (42  
21 U.S.C. 3121 et seq.);

22 (G) to the Department of the Interior, in-  
23 cluding with respect to National Park Service  
24 Historic Preservation Fund and construction

1 funding for necessary expenses relating to the  
2 consequences of disaster relief; and

3 (H) to the Environmental Protection Agen-  
4 cy, including with respect to Clean Water State  
5 Revolving Fund funding under title VI of the  
6 Federal Water Pollution Control Act (33 U.S.C.  
7 1381 et seq.).

8 (3) IMPLEMENTATION REPORT.—Not later than  
9 180 days after the date on which the interagency  
10 task force submits the report under paragraph (1),  
11 the interagency task force shall submit to the con-  
12 gressional committees described in that paragraph a  
13 report detailing—

14 (A) which of the recommendations con-  
15 tained in the report under paragraph (1) shall  
16 be implemented by Federal agencies and why  
17 those recommendations in the report not being  
18 implemented are not selected for implementa-  
19 tion;

20 (B) how the recommendations selected for  
21 implementation will be carried out; and

22 (C) legislative recommendations for Con-  
23 gress to support the recommendations selected  
24 for implementation.

1       (d) NO ADDITIONAL FUNDING.—No additional funds  
2 are authorized to be appropriated to carry out this Act.

3       (e) TERMINATION.—The interagency task force es-  
4 tablished under subsection (a) shall terminate on the date  
5 that is 90 days after the date on which the interagency  
6 task force submits the report under subsection (c)(3).
