## A BILL

To amend the John D. Dingell, Jr. Conservation, Management, and Recreation Act to designate as a component of the National Heritage Area System the Endless Mountains National Heritage Area in the State of Pennsylvania, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Endless Mountains  
5 National Heritage Area Act”.

1 **SEC. 2. DESIGNATION OF ENDLESS MOUNTAINS NATIONAL**  
 2 **HERITAGE AREA.**

3 (a) DESIGNATION.—Section 6001(a) of the John D.  
 4 Dingell, Jr. Conservation, Management, and Recreation  
 5 Act (Public Law 116–9; 133 Stat. 768; 136 Stat. 6163)  
 6 is amended by adding at the end the following:

7 “(14) ENDLESS MOUNTAINS NATIONAL HERIT-  
 8 AGE AREA.—

9 “(A) IN GENERAL.—There is established  
 10 as a component of the National Heritage Area  
 11 System the Endless Mountains National Herit-  
 12 age Area in the State of Pennsylvania, to con-  
 13 sist of Bradford, Sullivan, Susquehanna, and  
 14 Wyoming Counties, Pennsylvania, and any por-  
 15 tions of other counties in the State of Pennsyl-  
 16 vania identified in the feasibility study for the  
 17 Endless Mountains National Heritage Area, the  
 18 specific boundaries of which shall be established  
 19 by the Secretary based on that feasibility study.

20 “(B) LOCAL COORDINATING ENTITY.—The  
 21 Endless Mountains Heritage Region, Inc., shall  
 22 be the local coordinating entity for the National  
 23 Heritage Area designated by subparagraph  
 24 (A).”.

25 (b) MANAGEMENT PLAN.—For the purposes of sec-  
 26 tion 6001(c) of the John D. Dingell, Jr. Conservation,

1 Management, and Recreation Act (Public Law 116–9; 133  
2 Stat. 772; 136 Stat. 6173), the local coordinating entity  
3 for the Endless Mountains National Heritage Area des-  
4 ignated under the amendment made by subsection (a)  
5 shall submit to the Secretary of the Interior for approval  
6 a proposed management plan for the Endless Mountains  
7 National Heritage Area not later than 3 years after the  
8 date of enactment of this Act.

9 (c) TERMINATION OF AUTHORITY.—For the purposes  
10 of subsection (g)(4) of section 6001 of the John D. Din-  
11 gell, Jr. Conservation, Management, and Recreation Act  
12 (Public Law 116–9; 133 Stat. 776), the authority of the  
13 Secretary of the Interior to provide assistance under that  
14 section for the Endless Mountains National Heritage Area  
15 designated under the amendment made by subsection (a)  
16 shall terminate on the date that is 15 years after the date  
17 of enactment of this Act.
