**A BILL**

To make appropriations for U.S. Immigration and Customs Enforcement.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “10 Years of ICE Fund-  
5 ing Act”.

6 **SEC. 2. U.S. IMMIGRATION AND CUSTOMS ENFORCEMENT.**

7 (a) OPERATIONS AND SUPPORT.—For necessary ex-  
8 penses of U.S. Immigration and Customs Enforcement for

1 operations and support, including for the purchase and  
2 lease of up to 3,790 police-type vehicles (of which 2,350  
3 vehicles shall be replacement vehicles only), for overseas  
4 vetted units, and for maintenance, minor construction,  
5 and minor leasehold improvements at owned and leased  
6 facilities, \$100,363,620,000.

7 (b) PROCUREMENT, CONSTRUCTION, AND IMPROVE-  
8 MENTS.—For necessary expenses of U.S. Immigration and  
9 Customs Enforcement for procurement, construction, and  
10 improvements, including acquisition of necessary addi-  
11 tional real property and facilities, construction and ongo-  
12 ing maintenance, facility improvements, equipment, and  
13 related expenses, \$5,000,000,000.

14 (c) AVAILABILITY.—Amounts appropriated under  
15 subsections (a) and (b) shall remain available until Sep-  
16 tember 30, 2036.

17 (d) RULE OF CONSTRUCTION.—Amounts appro-  
18 priated under subsections (a) and (b) shall remain avail-  
19 able for obligation notwithstanding section 501 of the De-  
20 partment of Homeland Security Appropriations Act, 2026,  
21 or any other provision of law limiting the period of avail-  
22 ability of such amounts.
