Mrs. GILLIBRAND introduced the following bill; which was read twice and referred to the Committee on Homeland Security and Governmental Affairs

A BILL

To prohibit the use of the name, image, likeness, or signature of a sitting President on Federal assets, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Halting Unilateral
5 Money and Building Labeling by Egotistical Presidents
6 Act” or the “HUMBLE Presidents Act”.

1 **SEC. 2. PROHIBITIONS RELATING TO THE USE OF NAMES,**
 2 **IMAGES, LIKENESSES, AND SIGNATURES OF**
 3 **SITTING PRESIDENTS.**

4 (a) COVERED ASSET DEFINED.—In this section, the
 5 term “covered asset” means—

6 (1) Federal property, including a Federal build-
 7 ing; and

8 (2) any other Federal asset.

9 (b) DESIGNATION.—The name, image, likeness, or
 10 signature of a sitting President may not be used to des-
 11 ignate or name a covered asset.

12 (c) DECORATION.—The name, image, likeness, or sig-
 13 nature of a sitting President may not be used to decorate
 14 the exterior of a covered asset.

15 (d) USE OF FUNDS.—No Federal funds may be used
 16 to carry out an activity prohibited under subsection (b)
 17 or (c).

18 (e) PROHIBITION WITH RESPECT TO THE NAME,
 19 IMAGE, LIKENESS, OR SIGNATURE OF THE PRESIDENT
 20 ON UNITED STATES COINS AND CURRENCY.—Subchapter
 21 II of chapter 51 of title 31, United States Code, is amend-
 22 ed—

23 (1) in section 5112, by adding at the end the
 24 following:

25 “(bb) PROHIBITION ON CERTAIN REPRESENTA-
 26 TIONS.—The name, image, likeness, or signature of the

1 sitting President may not appear on any United States
2 coin.”; and

3 (2) in section 5114(b), by inserting after the
4 first sentence the following: “The name or signature
5 of the sitting President, or any image or likeness of
6 the sitting President that is not covered under the
7 following sentence, may not appear on United States
8 currency or securities.”.
