Mrs. GILLIBRAND introduced the following bill; which was read twice and referred to the Committee on the Judiciary

A BILL

To amend title 18, United States Code, to prohibit the purchase, ownership, or possession of enhanced body armor by civilians.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Aaron Salter, Jr., Re-
5 sponsible Body Armor Possession Act”.

6 **SEC. 2. BAN ON PURCHASE, OWNERSHIP, OR POSSESSION**
7 **OF ENHANCED BODY ARMOR BY CIVILIANS.**

8 (a) BAN.—

1 (1) IN GENERAL.—Chapter 44 of title 18,
 2 United States Code, is amended by adding at the
 3 end the following:

4 **“§ 935. Ban on purchase, ownership, or possession of**
 5 **enhanced body armor by civilians**

6 “(a) DEFINITION.—In this section, the term ‘covered
 7 law enforcement officer’—

8 “(1) has the meaning given the term ‘qualified
 9 law enforcement officer’ in section 926B and the
 10 term ‘qualified retired law enforcement officer’ in
 11 section 926C; and

12 “(2) includes corrections officers.

13 “(b) PROHIBITION.—Except as provided in sub-
 14 section (c), it shall be unlawful for a person to purchase,
 15 own, or possess enhanced body armor.

16 “(c) EXCEPTIONS.—Subsection (b) shall not apply
 17 to—

18 “(1) a purchase, ownership, or possession by or
 19 under the authority of—

20 “(A) the United States or any department
 21 or agency of the United States;

22 “(B) a State, or a department, agency, or
 23 political subdivision of a State; or

24 “(C) a Tribe or law enforcement agency of
 25 a Tribe;

1 “(2) a covered law enforcement officer; or

2 “(3) enhanced body armor that was lawfully
3 possessed by any person before the date of enact-
4 ment of this section.”.

5 (2) TECHNICAL AND CONFORMING AMEND-
6 MENT.—The table of sections for chapter 44 of title
7 18, United States Code, is amended by adding at
8 the end the following:

“935. Ban on purchase, ownership, or possession of enhanced body armor by
civilians.”.

9 (b) ENHANCED BODY ARMOR DEFINED.—Section
10 921(a) of title 18, United States Code, is amended by add-
11 ing at the end the following:

12 “(39) The term ‘enhanced body armor’ means
13 body armor, including a helmet or shield, the bal-
14 listic resistance of which meets or exceeds the bal-
15 listic performance of RF1 armor, determined using
16 such standard as the National Institute of Justice
17 has in effect at the time at which a person pur-
18 chases, owns, or possesses such armor.”.

19 (c) PENALTIES.—Section 924(a) of such title is
20 amended by adding at the end the following:

21 “(9) Whoever knowingly violates section 935
22 shall be fined under this title, imprisoned not more
23 than 5 years, or both.”.
