## A BILL

To amend Kristen’s Act to provide for the inclusion of information related to developmental disabilities, Alzheimer’s disease, and dementia in alerts issued through the Ashanti Alert communications network, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

### 3   **SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “Enhanced Alerts for  
5   Missing Loved Ones with Disabilities Act of 2026”.

1 **SEC. 2. ALERTS FOR MISSING ADULTS WITH DEVELOP-**  
 2 **MENTAL DISABILITIES, ALZHEIMER’S DIS-**  
 3 **EASE, AND DEMENTIA.**

4 Section 204(b) of Kristen’s Act (34 U.S.C. 21904(b))  
 5 is amended—

6 (1) in paragraph (1), by inserting after “(in-  
 7 cluding health care needs” the following: “and  
 8 whether the individual has a developmental disability  
 9 (as defined in section 102 of the Developmental Dis-  
 10 abilities Assistance and Bill of Rights Act of 2000  
 11 (42 U.S.C. 15002)), Alzheimer’s disease, or demen-  
 12 tia”; and

13 (2) in paragraph (3)(A), by striking “suffers  
 14 from a proven mental or physical disability” and in-  
 15 serting the following: “has been diagnosed with a  
 16 mental disability, a physical disability, a develop-  
 17 mental disability (as defined in section 102 of the  
 18 Developmental Disabilities Assistance and Bill of  
 19 Rights Act of 2000 (42 U.S.C. 15002)), Alzheimer’s  
 20 disease, or dementia”.

21 **SEC. 3. TRAINING RELATED TO DEVELOPMENTALLY DIS-**  
 22 **ABLED MISSING PERSONS.**

23 (a) MISSING ADULTS.—Section 206 of Kristen’s Act  
 24 (34 U.S.C. 21906) is amended—

25 (1) in paragraph (1), by striking “and” at the  
 26 end;

1           (2) in paragraph (2), by striking the period at  
2           the end and inserting “; and”; and

3           (3) by adding at the end the following:

4           “(3) training and educational programs related  
5           to responding effectively to a reported missing adult  
6           with a developmental disability (as defined in section  
7           102 of the Developmental Disabilities Assistance  
8           and Bill of Rights Act of 2000 (42 U.S.C.  
9           15002)).”.

10          (b) MISSING CHILDREN.—Section 301(b) of the  
11       PROTECT Act (34 U.S.C. 20501(b)) is amended—

12           (1) in paragraph (3), by striking “and” at the  
13           end;

14           (2) in paragraph (4)(B), by striking the period  
15           at the end and inserting “; and”; and

16           (3) by adding at the end the following:

17           “(5) provide training and educational programs  
18           for use by States, territories of the United States,  
19           and Tribal governments, related to responding effec-  
20           tively to a reported missing child with a develop-  
21           mental disability (as defined in section 102 of the  
22           Developmental Disabilities Assistance and Bill of  
23           Rights Act of 2000 (42 U.S.C. 15002)).”.
