A BILL

To promote efforts to bring about stability and security
in Sudan, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLES; TABLE OF CONTENTS.**

4 (a) ~~SHORT TITLES.—~~This Act may be cited as the
5 “~~Preventing External Aggression and Conflict Escalation~~
6 ~~in Sudan Act of 2026~~” or the “~~PEACE in Sudan Act~~”.

3 **SEC. 2. STATEMENT OF POLICY.**

4 It is the policy of the United States—

- 5 (1) to advance and protect the national security
- 6 of the United States, including by identifying, dis-
- 7 rupting, and dismantling the networks and actions
- 8 of criminal and malign actors who foment and ben-
- 9 efit from instability, conflict, humanitarian emer-
- 10 gency, state failure, and ungoverned spaces;
- 11 (2) to utilize all available diplomatic and eco-
- 12 nomic tools to secure an end to the war in Sudan;
- 13 (3) to counter—
- 14 (A) malign foreign interference and exter-
- 15 nal military support to parties to the conflict in
- 16 Sudan; and

1 (~~B~~) destabilizing regional and domestic ac-
 2 tors who seek to benefit from the continued
 3 conflict in Sudan;

4 (~~4~~) to promote efforts to bring about stability
 5 and security in Sudan, including by addressing the
 6 humanitarian suffering of the Sudanese people and
 7 others impacted across Africa;

8 (~~5~~) to hold perpetrators of war crimes, crimes
 9 against humanity, and genocide in Sudan account-
 10 able for their crimes;

11 (~~6~~) to advance and protect the internationally
 12 recognized human rights of all Sudanese people, re-
 13 gardless of ethnicity, religion, sex, or geographic
 14 area of origin; and

15 (~~7~~) to support the aspirations of the people of
 16 Sudan for a political transition process that results
 17 in a civilian government that—

18 (~~A~~) is democratic;

19 (~~B~~) is accountable;

20 (~~C~~) respects the internationally-recognized
 21 human rights of its citizens; and

22 (~~D~~) is at peace with itself and its neigh-
 23 bors.

24 **SEC. 3. DEFINITIONS.**

25 In this Act:

1 (1) ~~ADMISSION; ADMITTED; ALIEN.~~—The terms
 2 “admission”, “admitted”, and “alien” have the
 3 meanings given such terms in section 101(a) of the
 4 Immigration and Nationality Act (8 U.S.C.
 5 1101(a)).

6 (2) ~~AID OR ABET.~~—The term “aid or abet”
 7 means to intentionally assist or encourage a person
 8 or persons to commit a crime.

9 (3) ~~APPROPRIATE CONGRESSIONAL COMMIT-~~
 10 ~~TEES.~~—Except as provided in section 7, the term
 11 “appropriate congressional committees” means—

12 (A) the Committee on Foreign Relations of
 13 the Senate; and

14 (B) the Committee on Foreign Affairs of
 15 the House of Representatives.

16 (4) ~~ATROCITY.~~—The term “atrocities” means
 17 war crimes, crimes against humanity, or genocide.

18 (5) ~~FOREIGN PERSON.~~—The term “foreign per-

19 son” means an individual or entity that is not a

20 United States person.

21 (6) ~~GENOCIDE.~~—The term “genocide” means

22 an offense described in section 1091(a) of title 18,

23 United States Code.

1 (7) INTERNATIONAL FINANCIAL INSTITU-
2 TION.—The term “international financial institu-
3 tion” means—

4 (A) the International Monetary Fund;

5 (B) the International Bank for Recon-
6 struction and Development;

7 (C) the International Development Asso-
8 ciation;

9 (D) the International Finance Corporation;

10 (E) the Inter-American Development Bank
11 Group;

12 (F) the Asian Development Bank;

13 (G) the Inter-American Investment Cor-
14 poration;

15 (H) the African Development Bank;

16 (I) the African Development Fund;

17 (J) the European Bank for Reconstruction
18 and Development;

19 (K) the Multilateral Investment Guaranty
20 Agency; and

21 (L) any multilateral financial institution
22 established after the date of the enactment of
23 this Act that could provide financial assistance
24 to the Government of Sudan.

1 (8) NON-STATE ARMED GROUP.—The term
 2 “non-state armed group” means any entity partici-
 3 pating in, supporting, or contributing to the conflict
 4 or commission of atrocities that is not an organiza-
 5 tion of a foreign government, including militia,
 6 armed groups, mercenaries, private military contrac-
 7 tors, and terrorist organizations.

8 (9) QUAD.—The term “Quad” means the diplo-
 9 matic grouping of the United States, Egypt, Saudi
 10 Arabia, and the United Arab Emirates that has been
 11 convening in an effort to mediate an end to the con-
 12 flict in Sudan.

13 (10) QUINTET.—The term “Quintet” means
 14 the diplomatic grouping of the African Union, the
 15 Intergovernmental Authority on Development, the
 16 League of Arab States, the European Union, and
 17 the United Nations.

18 (11) TORTURE.—The term “torture” has the
 19 meaning given such a term in section 2340(1) of
 20 title 18, United States Code.

21 (12) UNITED STATES PERSON.—The term
 22 “United States person” means—

23 (A) a United States citizen, an alien law-
 24 fully admitted for permanent residence to the

United States, or any other individual subject to the jurisdiction of the United States; and

(B) an entity organized under the laws of the United States or of any jurisdiction within the United States, including a foreign branch of such an entity.

(13) WAR CRIME.—The term “war crime”—

(A) has the meaning given such term in section 2441(c) of title 18, United States Code; and

(B) includes sexual violence.

SEC. 4. REPORT ON ACTIVITIES OF CERTAIN FOREIGN GOVERNMENTS AND GROUPS IN SUDAN.

(a) IN GENERAL.—Not later than 90 days after the date of the enactment of this Act, and semiannually thereafter, the Secretary of State, in coordination with the Director of National Intelligence, shall submit a report to the appropriate congressional committees that includes—

(1) a comprehensive analysis of the involvement of foreign governments and malign actors operating in Africa by supporting, facilitating, or contributing to the conflict and commission of atrocities in Sudan, including findings regarding—

(A) the estimated amount of arms and materiel transferred to the Sudanese Armed

1 Forces, the Rapid Support Forces, and to non-
2 state armed groups contributing to the conflict
3 in Sudan, including the suspected country of or-
4 igin and any transit countries;

5 (B) the estimated number of affiliated
6 combatants and support personnel in Sudan
7 acting in support of the war effort, including
8 those who are engaged in active fighting, train-
9 ing, and equipping;

10 (C) engagement in, or support for, drone
11 and aircraft strikes;

12 (D) the provision of, or support for, the
13 training of combatants, including child soldiers
14 such as the “Lion Cubs”, in Sudan;

15 (E) the provision of intelligence services,
16 intelligence sharing, or information sharing for
17 the Sudanese Armed Forces or Rapid Support
18 Forces, including through the provision of intel-
19 ligence personnel in Sudan;

20 (F) the provision of material support to
21 the Sudanese Armed Forces or the Rapid Sup-
22 port Forces to evade or undermine account-
23 ability measures or sanctions;

24 (G) the provision of financial and in-kind
25 support to the Sudanese Armed Forces, the

1 Rapid Support Forces, or non-state armed
2 groups operating in Sudan;

3 (H) the business interests held by foreign
4 governments and individuals from foreign coun-
5 tries referred to in this paragraph, including in-
6 terests in aviation, banking, media, livestock,
7 real estate, transportation, petroleum, and gold
8 mining;

9 (I) the source, frequency, and scope of vio-
10 lations of the United Nations arms embargo
11 outlined in United Nations Security Council
12 Resolutions 1556 (2004) and 1591 (2005);

13 (J) instances of international travel by
14 non-state armed groups from Sudan for pur-
15 poses other than structured diplomatic negotia-
16 tions; and

17 (K) actions that violate existing United
18 States defense cooperation agreements or des-
19 ignation as a major non-NATO ally of the
20 United States (as defined in section 644 of the
21 Foreign Assistance Act of 1961 (22 U.S.C.
22 2403));

23 (2) a comprehensive analysis of the involvement
24 of non-state armed groups in supporting, facili-

tating, or contributing to the conflict in Sudan and
the commission of atrocities in Sudan, including—

(A) the Wagner Group;

(B) the Sudan Revolutionary Front;

(C) the Sudanese Muslim Brotherhood, including its al-Baraa Bin Malik Brigade;

(D) the Sudan Liberation Movement, led by Minni Minnawi;

(E) the Sudan People's Liberation Movement—North—al Hilu;

(F) the Sudan People's Liberation Army—in—Opposition;

(G) the Sudan Liberation Movement, led by Abdul Wahid al-Nur;

(H) the Sudanese Liberation Army, led by Malik Agar;

(I) the Sudan Liberation Movement—Transitional Council, led by El-Hadi Idris Yahya;

(J) the Joint Security Forces, including the Justice and Equality Movement;

(K) Gathering of Sudan Liberation Forces, led by Al-Tahir Hajar;

(L) the Central Reserve Forces;

- 1 (M) the Sudanese Awakening Revolution-
- 2 tionary Council, led by Musa Hilal;
- 3 (N) the Sudan Shield Forces;
- 4 (O) the Third Front (Tamazuj);
- 5 (P) Army 70;
- 6 (Q) the Tigray Defense Forces;
- 7 (R) the Desert Wolves;
- 8 (S) the Libyan Arab Armed Forces (also
- 9 known as the “Libyan National Army”); and
- 10 (T) the Union of Forces for Democracy
- 11 and Development;
- 12 (3) an analysis of private and commercial activ-
- 13 ity facilitating or benefitting from the war economy
- 14 related to the conflict in Sudan, within or outside
- 15 Sudan, including activity related to—
- 16 (A) port operations;
- 17 (B) aviation (including airlines and air-
- 18 ports);
- 19 (C) ground transportation services;
- 20 (D) the mining, refining, processing, and
- 21 trade of gold, gum arabic, and other natural re-
- 22 sources;
- 23 (E) private military companies;
- 24 (F) banking and financial services;
- 25 (G) cryptocurrency transactions;

1 (H) technology;

2 (I) military equipment; and

3 (J) weapons manufacturing; and

4 (4) a determination and analysis of whether ac-
5 tions taken by a government of a foreign country re-
6 ferred to in paragraph (1)—

7 (A) involves defense articles or defense
8 services (as such terms are defined in section
9 47 of the Arms Export Control Act (22 U.S.C.
10 2794)) of United States origin;

11 (B) violates the terms of applicable United
12 States or end-user assurances, licenses, or
13 agreements; and

14 (C) violates the arms embargo designated
15 by United Nation Security Council Resolutions
16 1556 (2004), 1591 (2005), and any successor
17 Security Council Resolution for an arms embar-
18 go on all or part of Sudan.

19 (b) FORM.—The report required under subsection (a)
20 shall be submitted in unclassified form, but may include
21 a classified annex.

22 (c) BRIEFING.—Not later than 15 days after the sub-
23 mission of the report required under subsection (a), the
24 Secretary of State and the Director of National Intel-
25 ligence, or their respective designees, shall provide a brief-

1 ing to the appropriate congressional committees regarding
2 the matters contained in such report.

3 **SEC. 5. REPORT ON ATROCITIES AND GROSS VIOLATIONS**
4 **OF INTERNATIONALLY RECOGNIZED HUMAN**
5 **RIGHTS IN SUDAN.**

6 (a) **IN GENERAL.**—Not later than 90 days after the
7 date of the enactment of this Act, and semiannually there-
8 after, the Secretary of State shall submit to the appro-
9 priate congressional committees a comprehensive report
10 regarding the conduct of, support for, and perpetrators
11 of gross violations of internationally recognized human
12 rights in Sudan since April 15, 2023.

13 (b) **ELEMENTS.**—The report required under sub-
14 section (a) shall include a description of—

15 (1) any atrocities and other gross violations of
16 internationally recognized human rights committed
17 by the Sudanese Armed Forces, the Rapid Support
18 Forces, non-state armed groups, other entities of the
19 Government of Sudan, and other individuals, includ-
20 ing—

21 (A) the recruitment and use of child sol-
22 diers;

23 (B) the use of starvation and sexual vio-
24 lence as weapons of war, including systematic

1 rape, sexual slavery, and other forms of sexual
2 violence;

3 ~~(C)~~ the denial of humanitarian access, in-
4 cluding the obstruction of humanitarian assist-
5 ance or the targeting of aid workers;

6 ~~(D)~~ looting, occupation, or destruction of
7 civilian infrastructure, including religious sites,
8 health facilities, and schools;

9 ~~(E)~~ violations in the conduct of hostilities,
10 summary executions, the deliberate targeting of
11 civilians, and arbitrary detention;

12 ~~(F)~~ the systematic targeting of medical fa-
13 cilities and medical personnel, emergency re-
14 sponse rooms, or other humanitarian initiatives;

15 ~~(G)~~ the deliberate targeting of places of
16 worship; and

17 ~~(H)~~ ethnically motivated violence, including
18 violence against minority non-Arab communities
19 and indigenous ethnic groups of the Nuba
20 Mountains; and

21 ~~(2)~~ the sanctions imposed in accordance with
22 the Chemical and Biological Weapons Control and
23 Warfare Elimination Act of 1991 (title III of Public
24 Law 102-182; 22 U.S.C. 5601 et seq.) and the con-

1 tinued monitoring of the use of chemical weapons by
2 the Government of Sudan.

3 ~~(c) FORM.—The report required under subsection (a)~~
4 ~~shall be submitted in unclassified form, but may include~~
5 ~~a classified annex.~~

6 **SEC. 6. STRATEGY.**

7 ~~(a) IN GENERAL.—The Secretary of State, in coordi-~~
8 ~~nation with the Secretary of the Treasury, the Secretary~~
9 ~~of Defense, and the heads of other relevant Federal de-~~
10 ~~partments and agencies, shall develop a comprehensive~~
11 ~~strategy to secure a ceasefire and durable political settle-~~
12 ~~ment in Sudan. In developing such strategy, the Secretary~~
13 ~~shall utilize all available economic and diplomatic tools,~~
14 ~~and enhance diplomatic, financial, and legal measures to~~
15 ~~hold perpetrators of atrocities and other gross violations~~
16 ~~of internationally recognized human rights accountable.~~

17 ~~(b) ELEMENTS.—The strategy required under sub-~~
18 ~~section (a) shall include a description of the Secretary of~~
19 ~~State's plans—~~

20 ~~(1) to help end the conflict in Sudan, including~~
21 ~~by—~~

22 ~~(A)(i) determining the key actors who~~
23 ~~must be involved in diplomatic negotiations to~~
24 ~~end the war;~~

1 (ii) supporting their sustained and credible
2 participation in such negotiations; and

3 (iii) assessing the appropriate staffing
4 needed within the Department of State's Office
5 of Sudan Affairs, including locally employed
6 staff and staff based in Ethiopia and Kenya, to
7 engage on coordinated diplomatic efforts to end
8 the war in Sudan;

9 (B) establishing a timeline for using diplo-
10 matic engagement, intelligence diplomacy, secu-
11 rity cooperation, and foreign assistance, as ap-
12 propriate, to secure the support of allies and
13 partners in finding diplomatic paths to end the
14 conflict in Sudan; and

15 (C) coordinating with the Quintet, the
16 Quad, and other international partners—

17 (i) to end the armed conflict in
18 Sudan;

19 (ii) to protect civilians in Sudan;

20 (iii) to hold accountable perpetrators
21 of atrocities and other gross violations of
22 internationally recognized human rights;
23 and

24 (iv) to seek an enduring diplomatic
25 resolution to the conflict;

1 (2) to cripple the war economy and abettor net-
2 work;

3 (3) to collaborate with the Secretary of the
4 Treasury to hold perpetrators of atrocities in Sudan
5 accountable for their crimes;

6 (4) to counter foreign influence and military
7 support to the Sudanese Armed Forces and the
8 Rapid Support Forces, which exacerbates the con-
9 flict in Sudan;

10 (5) to promote stability and alleviate human
11 suffering in Sudan by—

12 (A) securing guarantees for unrestricted
13 humanitarian access to vulnerable populations
14 and the implementation of protection measures,
15 including measures to prevent human traf-
16 ficking, sexual violence, and the recruitment of
17 child soldiers; and

18 (B) analyzing—

19 (i) how to most effectively leverage
20 diplomatic and assistance tools and
21 incentivize strategic burden-sharing with
22 international partners to improve the hu-
23 manitarian conditions in Sudan;

24 (ii) requirements for rebuilding essen-
25 tial infrastructure that has been destroyed

1 in the conflict, including health systems,
2 education, and civilian infrastructure, and
3 the role to be played by the international
4 community in such efforts;

5 (iii) how to engage in diplomatic ef-
6 forts to ensure support for humanitarian
7 relief and recovery in Sudan from inter-
8 national donors, including foreign govern-
9 ments and multilateral organizations; and

10 (iv) how the United States, and other
11 partners can work to ensure the safety and
12 security of humanitarian aid workers and
13 journalists in Sudan; and

14 (6) to implement a comprehensive diplomatic
15 approach toward engagement with the countries bor-
16 dering Sudan, in addition to Kenya and Uganda,
17 and regional institutions to address the issues de-
18 tailed in paragraphs (1) through (5).

19 (c) SUBMISSION.—Not later than 180 days after the
20 date of the enactment of this Act, the Secretary of State
21 shall submit to the appropriate congressional committees
22 the strategy developed pursuant to subsection (a) in an
23 unclassified form, which shall include the information de-
24 scribed in subsection (b) and may include a classified
25 annex.

1 (d) BRIEFING.—Not later than 15 days after submit-
 2 ting the strategy required under subsection (a), and every
 3 90 days thereafter, the Secretary of State, or the Sec-
 4 retary’s designee, shall brief the appropriate congressional
 5 committees regarding—

6 (1) the status of the implementation of such
 7 strategy; and

8 (2) any changes or updates based on evolving
 9 conditions in Sudan.

10 **SEC. 7. ASSESSMENT OF ELIGIBILITY OF ARMED ACTORS IN**
 11 **SUDAN FOR DESIGNATION AS SPECIALLY**
 12 **DESIGNATED GLOBAL TERRORISTS.**

13 (a) DEFINED TERM.—In this section, the term “ap-
 14 propriate congressional committees” means—

15 (1) the Committee on Foreign Relations of the
 16 Senate;

17 (2) the Committee on the Judiciary of the Sen-
 18 ate;

19 (3) the Committee on Foreign Affairs of the
 20 House of Representatives; and

21 (4) the Committee on the Judiciary of the
 22 House of Representatives.

23 (b) IN GENERAL.—The Secretary of State, in con-
 24 sultation with the Secretary of the Treasury and the At-
 25 torney General, shall conduct an assessment to determine

1 whether any armed actor in Sudan meets the criteria for
 2 designation as a specially designated global terrorist, con-
 3 sistent with the International Emergency Economic Pow-
 4 ers Act (50 U.S.C. 1701 et seq.).

5 (c) REPORT.—Not later than 90 days after the date
 6 of the enactment of this Act, the Secretary of State shall
 7 submit to the appropriate congressional committees a clas-
 8 sified report containing—

9 (1) the results of the assessment conducted
 10 pursuant to subsection (b); and

11 (2) a description of action the Secretary has
 12 planned based on such results.

13 **SEC. 8. SANCTIONS.**

14 (a) IN GENERAL.—The President may impose the
 15 sanctions described in subsection (b) with respect to any
 16 foreign person the President determines, on or after the
 17 date of the enactment of this Act—

18 (1) to be responsible for, complicit in, or to
 19 have directly or indirectly engaged in or facilitated—

20 (A) actions that threaten the peace, secu-
 21 rity, stability, or territorial integrity of Sudan;

22 (B) the supply, sale, or transfer of arms or
 23 any related materiel, or any assistance, advice,
 24 or training related to military activities to—

25 (i) the Sudanese Armed Forces;

1 (ii) the Rapid Support Forces; or

2 (iii) non-State armed groups oper-
3 ating in Sudan;

4 (C) the use or recruitment of child sol-
5 diers;

6 (D) directing, leading, or enabling the
7 presence of foreign military forces or non-state
8 armed groups in Sudan;

9 (E) aiding or abetting Sudanese Armed
10 Forces or Rapid Support Forces by—

11 (i) providing financial support or a
12 safe haven; or

13 (ii) contributing to the concealment of
14 their crimes;

15 (F) actions that obstruct, undermine,
16 delay, or have the purpose or effect of under-
17 mining a political process aimed at securing a
18 ceasefire, peace, or political resolution to the
19 conflict in Sudan;

20 (G) the commission of atrocities or other
21 gross violations of internationally recognized
22 human rights (as defined in section 1262 of the
23 Global Magnitsky Human Rights Accountability
24 Act (subtitle F of title XII of Public Law 114-
25 328; 22 U.S.C. 10101));

1 (H) the smuggling or trafficking of natural
2 resources from or through Sudan, including
3 gold and gum arabic;

4 (I) actions that constitute a violation of
5 the arms embargo under United Nations Secu-
6 rity Council Resolutions 1556 (2004) and 1591
7 (2005), including facilitating financial trans-
8 actions in furtherance of such actions or facili-
9 tating any export, reexport, transshipment, or
10 transfer in furtherance of such actions;

11 (J) the targeting of civilians, including
12 women and children, through the commission of
13 acts of violence (including killing, maiming, tor-
14 ture, or rape or other sexual violence), abduc-
15 tion, forced displacement, or attacks on schools,
16 hospitals, religious sites, or locations where ci-
17 vilians are seeking refuge or aid provided by do-
18 mestic or international actors;

19 (K) the obstruction of activities of, or at-
20 tacks on, the United Nations, bilateral or multi-
21 lateral diplomatic missions, or international hu-
22 manitarian organizations, or their personnel;

23 (L) the operation of private military com-
24 panies that are contributing to violence against
25 civilians in Sudan;

1 ~~(M)~~ the obstruction of the delivery or dis-
 2 tribution of, or access to, humanitarian assist-
 3 ance, including by force, intimidation, theft, co-
 4 ercion, or bureaucratic means;

5 ~~(N)~~ significant efforts to impede investiga-
 6 tions or prosecutions of alleged gross abuses of
 7 internationally recognized human rights in
 8 Sudan; or

9 ~~(O)~~ actions or policies that obstruct, un-
 10 dermine, delay, or impede, or pose a significant
 11 risk of obstructing, undermining, delaying, or
 12 impeding, the formation or operation of a civil-
 13 ian government;

14 ~~(2)(A)~~ to have materially assisted, sponsored, or
 15 provided financial, material, or technological support
 16 for, or goods or services to or in support of—

17 ~~(i)~~ any activity described in this section;
 18 and

19 ~~(ii)~~ any person whose property and inter-
 20 ests in property are blocked pursuant to this
 21 section; or

22 ~~(B)~~ to be owned or controlled by, or to have
 23 acted or purported to act for or on behalf of (di-
 24 rectly or indirectly) any person whose property and

1 interests in property are blocked pursuant to this
 2 section; or

3 ~~(3)~~ forms an entity for the purpose of evading
 4 sanctions that would otherwise be imposed pursuant
 5 to this section.

6 ~~(b) SANCTIONS; EXCEPTIONS.—~~

7 ~~(1) SANCTIONS.—~~

15 **SEC. 2. STATEMENT OF POLICY.**

13 (Q) the Tigray Defense Forces;

14 (R) the Desert Wolves;

15 (S) the Libyan Arab Armed Forces (also
16 known as the “Libyan National Army”); and

17 (T) the Union of Forces for Democracy and
18 Development;

19 (3) an analysis of private and commercial activ-
20 ity facilitating or benefitting from the war economy
21 related to the conflict in Sudan, within or outside
22 Sudan, including activity related to—

 16 congressional committees a comprehensive report regarding
 17 the conduct of, support for, and perpetrators of gross viola-
 18 tions of internationally recognized human rights in Sudan
 19 since April 15, 2023.

20 (b) *ELEMENTS.*—The report required under subsection
 21 (a) shall include a description of—

22 (1) any atrocities and other gross violations of
 23 internationally recognized human rights committed
 24 by the Sudanese Armed Forces, the Rapid Support
 25 Forces, non-state armed groups, other entities of the

1 *Government of Sudan, and other individuals, includ-*
2 *ing—*

3 *(A) the recruitment and use of child sol-*
4 *diers;*

5 *(B) the use of starvation and sexual violence*
6 *as weapons of war, including systematic rape,*
7 *sexual slavery, and other forms of sexual vio-*
8 *lence;*

9 *(C) the denial of humanitarian access, in-*
10 *cluding the obstruction of humanitarian assist-*
11 *ance or the targeting of aid workers;*

12 *(D) looting, occupation, or destruction of ci-*
13 *vilian infrastructure, including religious sites,*
14 *health facilities, residential buildings, and*
15 *schools;*

16 *(E) violations in the conduct of hostilities,*
17 *summary executions, the deliberate targeting of*
18 *civilians, and arbitrary detention;*

19 *(F) the systematic targeting of medical fa-*
20 *cilities and medical personnel, emergency re-*
21 *sponse rooms, or other humanitarian initiatives;*

22 *(G) the deliberate targeting of places of wor-*
23 *ship; and*

24 *(H) ethnically motivated violence, including*
25 *violence against minority non-Arab communities*

1 *and indigenous ethnic groups of the Nuba Moun-*
 2 *tains; and*

3 *(2) the sanctions imposed in accordance with the*
 4 *Chemical and Biological Weapons Control and War-*
 5 *fare Elimination Act of 1991 (title III of Public Law*
 6 *102–182; 22 U.S.C. 5601 et seq.) and the continued*
 7 *monitoring of the use of chemical weapons by the*
 8 *Government of Sudan.*

9 *(c) FORM.—The report required under subsection (a)*
 10 *shall be submitted in unclassified form, but may include*
 11 *a classified annex.*

12 **SEC. 6. STRATEGY.**

13 *(a) IN GENERAL.—The Secretary of State, in coordi-*
 14 *nation with the Secretary of the Treasury, the Secretary*
 15 *of Defense, and the heads of other relevant Federal depart-*
 16 *ments and agencies, shall develop a comprehensive strategy*
 17 *to secure a ceasefire and durable political settlement in*
 18 *Sudan. In developing such strategy, the Secretary shall uti-*
 19 *lize all available economic and diplomatic tools, and en-*
 20 *hance diplomatic, financial, and legal measures to hold per-*
 21 *petrators of atrocities and other gross violations of inter-*
 22 *nationally recognized human rights accountable.*

23 *(b) ELEMENTS.—The strategy required under sub-*
 24 *section (a) shall include a description of the Secretary of*
 25 *State’s plans—*

1 (1) *to help end the conflict in Sudan, including*
2 *by—*

3 (A)(i) *determining the key actors who must*
4 *be involved in diplomatic negotiations to end the*
5 *war;*

6 (ii) *supporting their sustained and credible*
7 *participation in such negotiations;*

8 (iii) *assessing the appropriate staffing need-*
9 *ed within the Department of State's Office of*
10 *Sudan Affairs, including locally employed staff*
11 *and staff based in Ethiopia and Kenya, to en-*
12 *gage on coordinated diplomatic efforts to end the*
13 *war in Sudan;*

14 (B) *establishing a timeline for using diplo-*
15 *matic engagement, intelligence diplomacy, secu-*
16 *rity cooperation, and foreign assistance, as ap-*
17 *propriate, to secure the support of allies and*
18 *partners in finding diplomatic paths to end the*
19 *conflict in Sudan; and*

20 (C) *coordinating with the Quintet, the*
21 *Quad, and other international partners—*

22 (i) *to end the armed conflict in Sudan;*

23 (ii) *to protect civilians in Sudan;*

24 (iii) *to hold accountable perpetrators of*
25 *atrocities and other gross violations of*

1 *internationally recognized human rights;*
 2 *and*

3 *(iv) to seek an enduring diplomatic*
 4 *resolution to the conflict;*

5 *(2) to cripple the war economy and abettor net-*
 6 *work;*

7 *(3) to collaborate with the Secretary of the*
 8 *Treasury to hold perpetrators of atrocities in Sudan*
 9 *accountable for their crimes;*

10 *(4) to counter foreign influence and military*
 11 *support to the Sudanese Armed Forces and the Rapid*
 12 *Support Forces, which exacerbates the conflict in*
 13 *Sudan; and*

14 *(5) to promote stability and alleviate human suf-*
 15 *fering in Sudan by—*

16 *(A) securing guarantees for unrestricted hu-*
 17 *manitarian access to vulnerable populations and*
 18 *the implementation of protection measures, in-*
 19 *cluding measures to provide trauma-informed*
 20 *care and prevent human trafficking, sexual vio-*
 21 *lence, and the recruitment of child soldiers; and*

22 *(B) analyzing—*

23 *(i) how to most effectively leverage dip-*
 24 *lomatic and assistance tools and incentivize*
 25 *strategic burden-sharing with international*

1 *partners to improve the humanitarian con-*
 2 *ditions in Sudan;*

3 *(ii) requirements for rebuilding essen-*
 4 *tial infrastructure that has been destroyed*
 5 *in the conflict, including health systems,*
 6 *education, and civilian infrastructure, and*
 7 *the role to be played by the international*
 8 *community in such efforts;*

9 *(iii) how to engage in diplomatic ef-*
 10 *forts to ensure support for humanitarian re-*
 11 *lief and recovery in Sudan from inter-*
 12 *national donors, including foreign govern-*
 13 *ments and multilateral organizations; and*

14 *(iv) how the United States, and other*
 15 *partners can work to ensure the safety and*
 16 *security of humanitarian aid workers and*
 17 *journalists in Sudan;*

18 *(6) to implement a comprehensive diplomatic*
 19 *approach toward engagement with the countries bor-*
 20 *dering Sudan, in addition to Kenya and Uganda,*
 21 *and regional institutions to address the issues de-*
 22 *tailed in paragraphs (1) through (5); and*

23 *(7) to identify potential opportunities for United*
 24 *States economic engagement and investment in a*
 25 *post-conflict Sudan and the broader region that could*

1 *support diplomatic efforts to end the conflict, includ-*
2 *ing by—*

3 *(A) identifying opportunities for United*
4 *States private sector investment in Sudan’s re-*
5 *covery and reconstruction, including in sectors*
6 *such as agriculture, energy, critical minerals, in-*
7 *frastructure, and financial services;*

8 *(B) assessing mechanisms through which the*
9 *United States Government, including through the*
10 *United States International Development Fi-*
11 *nance Corporation and the United States Trade*
12 *and Development Agency, may support United*
13 *States private sector actors seeking to engage in*
14 *Sudan and the broader region;*

15 *(C) evaluating opportunities to deepen*
16 *trade and investment ties with countries neigh-*
17 *boring Sudan as part of a broader regional eco-*
18 *nomics strategy that advances United States in-*
19 *terests and promotes stability for the region; and*

20 *(D) analyzing the manner in which United*
21 *States economic engagement in Sudan and the*
22 *region can support the durability of a credible*
23 *peace agreement or cessation of hostilities, and*
24 *advance an economic order that prioritizes*

1 *transparency, accountability, and the long-term*
 2 *interests of the people of Sudan.*

3 (c) *SUBMISSION.*—*Not later than 180 days after the*
 4 *date of the enactment of this Act, the Secretary of State*
 5 *shall submit to the appropriate congressional committees*
 6 *the strategy developed pursuant to subsection (a) in an un-*
 7 *classified form, which shall include the information de-*
 8 *scribed in subsection (b) and may include a classified*
 9 *annex.*

10 (d) *BRIEFING.*—*Not later than 15 days after submit-*
 11 *ting the strategy required under subsection (a), and every*
 12 *90 days thereafter, the Secretary of State, or the Secretary’s*
 13 *designee, shall brief the appropriate congressional commit-*
 14 *tees regarding—*

15 (1) *the status of the implementation of such*
 16 *strategy; and*

17 (2) *any changes or updates based on evolving*
 18 *conditions in Sudan.*

19 **SEC. 7. ASSESSMENT OF ELIGIBILITY OF ARMED ACTORS IN**
 20 **SUDAN FOR DESIGNATION AS SPECIALLY**
 21 **DESIGNATED GLOBAL TERRORISTS.**

22 (a) *DEFINED TERM.*—*In this section, the term “appro-*
 23 *priate congressional committees” means—*

24 (1) *the Committee on Foreign Relations of the*
 25 *Senate;*

1 (2) *the Committee on the Judiciary of the Sen-*
2 *ate;*

3 (3) *the Committee on Foreign Affairs of the*
4 *House of Representatives; and*

5 (4) *the Committee on the Judiciary of the House*
6 *of Representatives.*

7 (b) *IN GENERAL.—The Secretary of State, in consulta-*
8 *tion with the Secretary of the Treasury and the Attorney*
9 *General, shall conduct an assessment to determine whether*
10 *any armed actor in Sudan meets the criteria for designa-*
11 *tion as a specially designated global terrorist, consistent*
12 *with the International Emergency Economic Powers Act*
13 *(50 U.S.C. 1701 et seq.).*

14 (c) *REPORT.—Not later than 90 days after the date*
15 *of the enactment of this Act, the Secretary of State shall*
16 *submit to the appropriate congressional committees a clas-*
17 *sified report containing—*

18 (1) *the results of the assessment conducted pursu-*
19 *ant to subsection (b); and*

20 (2) *a description of action the Secretary has*
21 *planned based on such results.*

22 **SEC. 8. SANCTIONS.**

23 (a) *IN GENERAL.—The President may impose the*
24 *sanctions described in subsection (b) with respect to any*

1 *foreign person the President determines, on or after the date*
 2 *of the enactment of this Act—*

3 *(1) to be responsible for, complicit in, or to have*
 4 *directly or indirectly engaged in or facilitated—*

5 *(A) actions that threaten the peace, security,*
 6 *stability, or territorial integrity of Sudan;*

7 *(B) the supply, sale, or transfer of arms or*
 8 *any related materiel, or any assistance, advice,*
 9 *or training related to military activities to—*

10 *(i) the Sudanese Armed Forces;*

11 *(ii) the Rapid Support Forces; or*

12 *(iii) non-State armed groups operating*
 13 *in Sudan;*

14 *(C) the use or recruitment of child soldiers;*

15 *(D) directing, leading, or enabling the pres-*
 16 *ence of foreign military forces or non-state*
 17 *armed groups in Sudan that have engaged in ac-*
 18 *tions that threaten the peace, security, stability,*
 19 *or territorial integrity of Sudan;*

20 *(E) aiding or abetting Sudanese Armed*
 21 *Forces or Rapid Support Forces by—*

22 *(i) providing financial or material*
 23 *support or a safe haven; or*

24 *(ii) contributing to the concealment of*
 25 *their crimes;*

1 (F) actions that obstruct, undermine, delay,
2 or have the purpose or effect of undermining a
3 political process aimed at securing a ceasefire,
4 peace, or political resolution to the conflict in
5 Sudan;

6 (G) the commission of atrocities or other
7 gross violations of internationally recognized
8 human rights (as defined in section 1262 of the
9 Global Magnitsky Human Rights Accountability
10 Act (subtitle F of title XII of Public Law 114–
11 328; 22 U.S.C. 10101);

12 (H) the smuggling or trafficking of natural
13 resources from or through Sudan, including gold
14 and gum arabic;

15 (I) actions that constitute a violation of the
16 arms embargo under United Nations Security
17 Council Resolutions 1556 (2004) and 1591
18 (2005), including facilitating financial trans-
19 actions in furtherance of such actions or facili-
20 tating any export, reexport, transshipment, or
21 transfer in furtherance of such actions;

22 (J) the targeting of civilians, including
23 women and children, through the commission of
24 acts of violence (including killing, maiming, tor-
25 ture, or rape or other sexual violence), abduction,

1 *forced displacement, or attacks on schools, hos-*
2 *pitals, religious sites, or locations where civilians*
3 *are seeking refuge or aid provided by domestic or*
4 *international actors;*

5 *(K) the obstruction of activities of, or at-*
6 *tacks on, the United Nations, bilateral or multi-*
7 *lateral diplomatic missions, or international hu-*
8 *manitarian organizations, or their personnel;*

9 *(L) the operation of private military com-*
10 *panies that are contributing to violence against*
11 *civilians in Sudan;*

12 *(M) the obstruction of the delivery or dis-*
13 *tribution of, or access to, humanitarian assist-*
14 *ance, including by force, intimidation, theft, co-*
15 *ercion, or bureaucratic means;*

16 *(N) significant efforts to impede investiga-*
17 *tions or prosecutions of alleged gross abuses of*
18 *internationally recognized human rights in*
19 *Sudan; or*

20 *(O) actions or policies that obstruct, under-*
21 *mine, delay, or impede, or pose a significant risk*
22 *of obstructing, undermining, delaying, or imped-*
23 *ing, the formation or operation of a civilian gov-*
24 *ernment;*

1 (2)(A) *to have materially assisted, sponsored, or*
 2 *provided financial, material, or technological support*
 3 *for, or goods or services to or in support of—*

4 *(i) any activity described in this section;*

5 *(ii) any person whose property and inter-*
 6 *ests in property are blocked pursuant to this sec-*
 7 *tion; or*

8 (B) *to be owned or controlled by, or to have acted*
 9 *or purported to act for or on behalf of (directly or in-*
 10 *directly) any person whose property and interests in*
 11 *property are blocked pursuant to this section; or*

12 (3) *forms an entity for the purpose of evading*
 13 *sanctions that would otherwise be imposed pursuant*
 14 *to this section.*

15 (b) *SANCTIONS; EXCEPTIONS.—*

16 (1) *SANCTIONS.—*

17 (A) *ASSET BLOCKING.—Notwithstanding*
 18 *section 202 of the International Emergency Eco-*
 19 *nomic Powers Act (50 U.S.C. 1701), the Presi-*
 20 *dent may exercise all of the powers granted to*
 21 *the President by such Act to the extent necessary*
 22 *to block and prohibit all transactions in all*
 23 *property and interests in property of a foreign*
 24 *person the President determines meets 1 or more*
 25 *of the criteria described in subsection (a) if such*

property and interests in property are in the United States, come within the United States, or are or come within the possession or control of a United States person.

(B) *PROHIBITIONS ON FINANCIAL TRANSACTIONS.*—Notwithstanding the requirements under section 202 of the International Emergency Economic Powers Act (50 U.S.C. 1701), the President may exercise all powers granted to the President by such Act to the extent necessary—

(i) to prohibit any United States financial institution from making loans or providing credit to the foreign person; or

(ii) to prohibit any transactions in foreign exchange that are subject to the jurisdiction of the United States and in which the foreign person has any interest.

(C) *ALIENS INADMISSIBLE FOR VISAS, ADMISSION, OR PAROLE.*—

(i) *VISAS, ADMISSION, OR PAROLE.*—
An alien is described in this clause if the Secretary of State or the Secretary of Homeland Security (or a designee of either

1 *such Secretary) knows, or has reason to be-*
2 *lieve the alien—*

3 *(I) meets any of the criteria de-*
4 *scribed in subsection (a); and*

5 *(II)(aa) is inadmissible to the*
6 *United States;*

7 *(bb) is ineligible to receive a visa*
8 *or other documentation to enter the*
9 *United States; or*

10 *(cc) is otherwise ineligible to be*
11 *admitted or paroled into the United*
12 *States or to receive any other benefit*
13 *under the Immigration and Nation-*
14 *ality Act (8 U.S.C. 1101 et seq.).*

15 *(ii) CURRENT VISAS REVOKED.—*

16 *(I) IN GENERAL.—The issuing*
17 *consular officer, the Secretary of State,*
18 *or a designee of the Secretary of State,*
19 *in accordance with section 221(i) of*
20 *the Immigration and Nationality Act*
21 *(8 U.S.C. 1201(i)), shall revoke any*
22 *visa or other entry documentation*
23 *issued to an alien described in clause*
24 *(i) regardless of when the visa or other*
25 *entry documentation was issued.*

1 (II) *EFFECT OF REVOCATION.*—

2 *Each revocation under subclause (I)*
3 *shall—*

4 *(aa) take effect immediately;*
5 *and*

6 *(bb) automatically cancel*
7 *any other valid visa or entry doc-*
8 *umentation that is in the alien's*
9 *possession.*

10 (2) *PENALTIES.*—*Any person that commits, at-*
11 *tempts to commit, conspires to commit, or causes the*
12 *commission of an action described in subsection (a)*
13 *shall be subject to the penalties set forth in subsections*
14 *(b) and (c) of section 206 of the International Emer-*
15 *gency Economic Powers Act (50 U.S.C. 1705) to the*
16 *same extent as a person that commits an unlawful act*
17 *described in subsection (a) of such section.*

18 (3) *IMPLEMENTATION.*—*The President—*

19 *(A) may exercise all authorities provided*
20 *under sections 203 and 205 of the International*
21 *Emergency Economic Powers Act (50 U.S.C.*
22 *1702 and 1704) to carry out this section; and*

23 *(B) shall issue such regulations, licenses,*
24 *and orders as may be necessary to carry out this*
25 *section.*

1 (4) *EXCEPTION TO COMPLY WITH UNITED NA-*
2 *TIONS HEADQUARTERS AGREEMENT.*—*Sanctions de-*
3 *scribed in paragraph (1)(B) shall not apply with re-*
4 *spect to an alien if admitting or paroling the alien*
5 *into the United States is necessary to permit the*
6 *United States to comply with the Agreement regard-*
7 *ing the Headquarters of the United Nations, signed at*
8 *Lake Success June 26, 1947, and entered into force*
9 *November 21, 1947, between the United Nations and*
10 *the United States, or other applicable international*
11 *obligations.*

12 (5) *EXCEPTION TO COMPLY WITH INTELLIGENCE*
13 *AND LAW ENFORCEMENT ACTIVITIES.*—*Sanctions*
14 *under this section shall not apply to any activity sub-*
15 *ject to—*

16 (A) *the reporting requirements under title V*
17 *of the National Security Act of 1947 (50 U.S.C.*
18 *3091 et seq.) or any authorized intelligence ac-*
19 *tivities of the United States; or*

20 (B) *to carry out or assist any authorized*
21 *law enforcement activities of the United States.*

22 (6) *EXCEPTION FOR HUMANITARIAN ASSIST-*
23 *ANCE.*—

24 (A) *DEFINITIONS.*—*In this paragraph:*

1 (i) *AGRICULTURAL COMMODITY*.—The
2 term “agricultural commodity” has the
3 meaning given such term in section 102 of
4 the *Agricultural Trade Act of 1978* (7
5 U.S.C. 5602).

6 (ii) *MEDICAL DEVICE*.—The term
7 “medical device” has the meaning given the
8 term “device” in section 201 of the *Federal*
9 *Food, Drug, and Cosmetic Act* (21 U.S.C.
10 321).

11 (iii) *MEDICINE*.—The term “medicine”
12 has the meaning given the term “drug” in
13 section 201 of the *Federal Food, Drug, and*
14 *Cosmetic Act* (21 U.S.C. 321).

15 (B) *IN GENERAL*.—Sanctions under this
16 section shall not apply to—

17 (i) the conduct or facilitation of a
18 transaction for the provision of agricultural
19 commodities, food, medicine, medical de-
20 vices, humanitarian assistance, or for hu-
21 manitarian purposes; or

22 (ii) transactions that are necessary for
23 or related to any activity described in
24 clause (i).

1 (7) *EXCEPTION RELATING TO THE IMPORTATION*
 2 *OF GOODS.*—

3 (A) *GOOD.*—*In this paragraph, the term*
 4 *“good” means any article, natural or manmade*
 5 *substance, material, supply, or manufactured*
 6 *product, including inspection and test equip-*
 7 *ment, and excluding technical data.*

8 (B) *IN GENERAL.*—*A requirement to block*
 9 *and prohibit all transactions in all property and*
 10 *interests in property under this section shall not*
 11 *include the authority or a requirement to impose*
 12 *sanctions on the importation of goods.*

13 **SEC. 9. SPECIAL ENVOY FOR SUDAN.**

14 *Section 7204(d) of the Department of State Authoriza-*
 15 *tion Act for Fiscal Year 2025 (division G of Public Law*
 16 *118–159; 22 U.S.C. 10001 note) is amended by striking “2*
 17 *years” and inserting “5 years”.*

18 **SEC. 10. ASSISTANCE TO THE GOVERNMENT OF SUDAN BY**
 19 **INTERNATIONAL FINANCIAL INSTITUTIONS.**

20 (a) *RESTRICTIONS.*—*Except as provided in subsections*
 21 *(b) and (c), the Secretary of the Treasury shall instruct the*
 22 *United States Executive Director or the appropriate head*
 23 *of the respective international financial institutions—*

24 (1) *to use the voice and vote of the United States*
 25 *in those institutions to oppose any premature, new,*

1 *long-term reconstruction or capacity-building support*
 2 *for Sudan, including support that would benefit a*
 3 *foreign person or entity described in section 8(a); and*
 4 *(2) to work with other key donor countries to de-*
 5 *velop a coordinated policy for lending to the Govern-*
 6 *ment of Sudan in a post-conflict scenario, including*
 7 *firm benchmarks and preconditions for lending.*

8 *(b) NATIONAL SECURITY WAIVER.—The President*
 9 *may waive application of subsection (a) if the President*
 10 *determines such a waiver is in the national security interest*
 11 *of the United States.*

12 *(c) EXCEPTION FOR LIFESAVING HUMANITARIAN*
 13 *PROJECTS THAT DIRECTLY SUPPORT BASIC HUMAN*
 14 *NEEDS.—The advocacy otherwise required under subsection*
 15 *(a)(1) shall not apply to a specific loan or extension of fi-*
 16 *nancial assistance that has the sole purpose of supporting*
 17 *lifesaving humanitarian projects that directly support basic*
 18 *human needs, including emergency food, shelter, health,*
 19 *water, sanitation, and hygiene.*

20 **SEC. 11. SUDAN BUSINESS RISK ADVISORY.**

21 *Not later than 90 days after the date of the enactment*
 22 *of this Act, the Secretary of State, in coordination with the*
 23 *Secretary of Labor and the Secretary of Commerce, shall*
 24 *update its Sudan Business Risk Advisory, which was origi-*

1 nally issued in May 2022 and updated in May 2023, to
2 include—

3 (1) updates to the information regarding gold
4 from Sudan as a mineral from a conflict-affected
5 area, including the role of foreign governments in the
6 supply chain for Sudanese gold;

7 (2) information with respect to the supply chain
8 for Sudanese gum arabic, its role in fueling the con-
9 flict in Sudan, and nefarious actors involved in
10 smuggling gum arabic through Chad, the Central Af-
11 rican Republic, and South Sudan; and

12 (3) risks associated with conducting business
13 with entities connected to the Sudanese Armed Forces,
14 the Rapid Support Forces, or non-state armed groups;

15 **SEC. 12. UNITED STATES ENGAGEMENT AT THE UNITED NA-**
16 **TIONS WITH RESPECT TO SUDAN.**

17 *The United States Mission to the United Nations shall*
18 *assess—*

19 (1) *the need for additional coordination between*
20 *the United States, the United Nations Security Coun-*
21 *cil, the European Union, and other partner countries’*
22 *sanctions regimes;*

23 (2) *if the mandate of the United Nations Panel*
24 *of Experts on the Sudan (established by United Na-*
25 *tions Security Council Resolution 1591 (2005) and*

1 *most recently extended by United Nations Security*
 2 *Council Resolution 2791 (2025)) is sufficient to en-*
 3 *able it to fully and accurately report to the United*
 4 *Nations Security Council on issues related to war, in-*
 5 *cluding with respect to violations of the United Na-*
 6 *tions arms embargo; and*

7 *(3) the need to work with other United Nations*
 8 *Security Council members to expand the United Na-*
 9 *tions arms embargo for Sudan.*

10 **SEC. 13. FOREIGN ASSISTANCE TO SUDAN.**

11 *(a) PROHIBITION.—Except as provided in subsection*
 12 *(b), United States assistance may not be furnished to Sudan*
 13 *if such assistance—*

14 *(1) provides financial or capacity building sup-*
 15 *port directly to Government of Sudan institutions;*

16 *(2) supports debt relief through the Heavily In-*
 17 *debted Poor Countries Initiative to restructure, re-*
 18 *schedule, or cancel the sovereign debt of Sudan; or*

19 *(3) is security assistance.*

20 *(b) NATIONAL SECURITY WAIVER.—The President*
 21 *may waive application of subsection (a) if the President*
 22 *determines that such a waiver is in the national security*
 23 *interest of the United States.*

24 *(c) ANNUAL REPORT.—Not later than 90 days after*
 25 *the date of the enactment of this Act, and annually there-*

1 *after, the Secretary of State, in consultation with the Sec-*
 2 *retary of Agriculture and other relevant departments and*
 3 *agencies, shall submit a report to the appropriate congres-*
 4 *sional committees that details all United States foreign as-*
 5 *sistance to Sudan.*

6 **SEC. 14. ANNUAL REPORT ON FINANCIAL ASSETS HELD BY**
 7 **ARMED ACTORS IN SUDAN.**

8 *(a) IN GENERAL.—Not later than 180 days after the*
 9 *date of the enactment of this Act, and annually thereafter,*
 10 *the Secretary of the Treasury, in consultation with the Di-*
 11 *rector of National Intelligence and the Secretary of State,*
 12 *shall submit a report to the appropriate congressional com-*
 13 *mittees that includes—*

14 *(1) a list of all countries and foreign banking in-*
 15 *stitutions that hold assets on behalf of senior officials*
 16 *in the Sudanese Armed Forces, the Rapid Support*
 17 *Forces, and the General Intelligence Service; and*

18 *(2) how foreign actors are profiting from the war*
 19 *in Sudan through various business sectors.*

20 *(b) FORM.—Each report required under subsection (a)*
 21 *shall be submitted in an unclassified form, but may include*
 22 *a classified annex.*

23 **SEC. 15. TERMINATION.**

24 *The requirements under sections 4, 5, 6, 10, 13, and*
 25 *14 shall terminate on the date that is 30 days after the*

1 *Secretary of State submits to the appropriate congressional*
2 *committees a certification that—*

3 *(1) a credible and durable peace agreement, ces-*
4 *sation of hostilities, or other end to hostilities has*
5 *been achieved and verified by the Secretary of State;*
6 *and*

7 *(2) the Rapid Support Forces, the Sudanese*
8 *Armed Forces, and any other body or institution of*
9 *the Government of Sudan are no longer committing*
10 *atrocities.*

11 **SEC. 16. RULE OF CONSTRUCTION.**

12 *Nothing in this Act may be construed to authorize the*
13 *use of military force.*

14 **SEC. 17. SUNSET.**

15 *This Act shall cease to have any force or effect begin-*
16 *ning on the date that is 5 years after the date of the enact-*
17 *ment of this Act.*
