Mr. YOUNG (for himself and Mr. COONS) introduced the following bill; which was read twice and referred to the Committee on Commerce, Science, and Transportation

A BILL

To amend the Stevenson-Wydler Technology Innovation Act of 1980 to reauthorize the regional innovation program, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Build to Scale Reau-
5 thorization Act of 2026”.

1 **SEC. 2. REAUTHORIZATION OF REGIONAL INNOVATION**
 2 **PROGRAM.**

3 (a) IN GENERAL.—Section 27 of the Stevenson-
 4 Wydler Technology Innovation Act of 1980 (15 U.S.C.
 5 3722) is amended—

6 (1) in subsection (a)—

7 (A) in paragraph (2)—

8 (i) in subparagraph (E), by striking
 9 “and”;

10 (ii) in subparagraph (F), by striking
 11 the period and inserting “; and”; and

12 (iii) by adding at the end the fol-
 13 lowing new subparagraph:

14 “(G) increase access to capital to invest in
 15 innovation-based business ventures in the geo-
 16 graphic region.”; and

17 (B) by amending paragraph (4) to read as
 18 follows:

19 “(4) VENTURE DEVELOPMENT ORGANIZA-
 20 TION.—The term ‘venture development organization’
 21 means a State or nonprofit organization that has a
 22 measured, geographically defined, economic develop-
 23 ment purpose within its core mission and contributes
 24 to regional or sector-based economic prosperity by
 25 providing the following:

1 “(A) Direct financing to private innova-
2 tion-centered businesses.

3 “(B) Services to accelerate the commer-
4 cialization of research.

5 “(C) Entrepreneurial support tailored to
6 innovation-centered founders, start-ups, and
7 businesses within the geographic areas of serv-
8 ice of such founders, start-ups, and businesses,
9 as the case may be.”;

10 (2) in subsection (b), by striking “strategies”
11 and inserting “initiatives”;

12 (3) in subsection (c)—

13 (A) in paragraph (1)—

14 (i) by inserting “and subject to the
15 availability of appropriations” after “pur-
16 suant to subsection (b)”;

17 (ii) by striking “may” and inserting
18 “shall”;

19 (B) by striking paragraph (4)(D);

20 (C) by amending paragraph (5) to read as
21 follows:

22 “(5) COST SHARE.—The Federal share of the
23 cost of any activity funded under this subsection
24 shall not exceed 50 percent, plus an additional
25 amount that—

1 “(A) shall not exceed 40 percent; and

2 “(B) is based on the relative needs of the
3 area in which the activity at issue will be fund-
4 ed, as determined in accordance with regula-
5 tions promulgated by the Secretary.”; and

6 (D) by amending paragraph (6) to read as
7 follows:

8 “(6) OUTREACH.—The Secretary shall conduct
9 outreach to encourage participation in regional inno-
10 vative initiatives under this subsection by public and
11 private sector entities—

12 “(A) in—

13 “(i) rural communities;

14 “(ii) communities negatively impacted
15 by trade;

16 “(iii) areas with persistent economic
17 distress; or

18 “(B) that agree to collaborate with local
19 workforce investment area boards to carry out
20 workforce or training related activities.”;

21 (4) in subsection (d)(4)—

22 (A) by amending the heading to read as
23 follows: “DATA SOURCES”; and

1 (B) by inserting “and the Regional Tech-
 2 nology and Innovation Hub Program under sec-
 3 tion 28” after “subsection (c)”;
 4 (5) in subsection (e)—

5 (A) in paragraph (1), by striking “or at”
 6 and inserting “, the Department of Energy, the
 7 National Science Foundation, and”; and

8 (B) in paragraph (2)(A), by striking
 9 “strategies” and inserting “initiatives and ac-
 10 tivities carried out pursuant to subsection (d)”;
 11 and

12 (6) by amending subsection (h) to read as fol-
 13 lows:

14 “(h) FUNDING.—

15 “(1) USE OF UNOBLIGATED FUNDS.—Notwith-
 16 standing any other provision of law relating to the
 17 availability of funds to carry out this section, the
 18 Secretary may obligate and expend any amounts ap-
 19 propriated or otherwise available to carry out this
 20 section for any previous fiscal year that remains un-
 21 obligated as of the date of the enactment of this
 22 subsection.

23 “(2) FUTURE AUTHORITY.—There is authorized
 24 to be appropriated to the Secretary to carry out this

1 section \$50,000,000 for each of fiscal years 2026
2 through 2030.”.

3 (b) NOTICE OF FUNDING OPPORTUNITY.—Not later
4 than 90 days after the date of the enactment of this Act,
5 the Secretary of Commerce shall issue a notice of funding
6 opportunity with respect to the regional innovation pro-
7 gram established under section 27(b) of the Stevenson-
8 Wydler Technology Innovation Act of 1980 (15 U.S.C.
9 3722(b)), as amended by subsection (a).
