A BILL

To amend title XIX of the Social Security Act to ensure Medicaid coverage of mental health services and primary care services furnished on the same day.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Improving Coordina-
5 tion and Access to Resources Equitably for Youth Act”
6 or the “Improving CARE for Youth Act”.

1 **SEC. 2. MEDICAID COVERAGE OF MENTAL HEALTH SERV-**
 2 **ICES AND PRIMARY CARE SERVICES FUR-**
 3 **NISHED ON THE SAME DAY.**

4 (a) IN GENERAL.—Section 1902(a) of the Social Se-
 5 curity Act (42 U.S.C. 1396a(a)) is amended—

6 (1) in paragraph (89), by striking “; and” and
 7 inserting a semicolon;

8 (2) in paragraph (90)(C), by striking the period
 9 at the end and inserting “; and”; and

10 (3) by inserting after paragraph (90)(C) the
 11 following new paragraph:

12 “(91) not prohibit payment under the plan for
 13 a mental health service or primary care service fur-
 14 nished to an individual for which payment would
 15 otherwise be payable under the plan, with respect to
 16 such individual, if such service were not a same-day
 17 qualifying service (as defined in subsection (zz)).”.

18 (b) SAME-DAY QUALIFYING SERVICES DEFINED.—
 19 Section 1902 of the Social Security Act (42 U.S.C. 1396a)
 20 is amended by adding at the end the following new sub-
 21 section:

22 “(zz) SAME-DAY QUALIFYING SERVICES DEFINED.—
 23 For purposes of subsection (a)(91), the term ‘same-day
 24 qualifying service’ means—

25 “(1) a primary care service furnished to an in-
 26 dividual by a provider at an office, clinic, or other

1 outpatient facility on the same day a mental health
2 service is furnished to such individual by such pro-
3 vider (or another provider) at the same office, clinic,
4 or other outpatient facility; and

5 “(2) a mental health service furnished to an in-
6 dividual by a provider at an office, clinic, or other
7 outpatient facility on the same day a primary care
8 service is furnished to such individual by such pro-
9 vider (or another provider) at the office, clinic, or
10 other outpatient facility.”.
