Ms. MURKOWSKI (for herself and Mr. HEINRICH) introduced the following bill;
which was read twice and referred to the Committee on Indian Affairs

A BILL

To amend the Tribal Forest Protection Act of 2004 to
improve that Act, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Tribal Forest Protec-
5 tion Act Amendments Act of 2025”.

6 **SEC. 2. TRIBAL FOREST PROTECTION ACT OF 2004 AMEND-**
7 **MENTS.**

8 Section 2 of the Tribal Forest Protection Act of 2004
9 (25 U.S.C. 3115a) is amended—

1 (1) in subsection (a), by striking paragraph (2)
 2 and inserting the following:

3 “(2) INDIAN FOREST LAND OR RANGELAND.—

4 The term ‘Indian forest land or rangeland’ means—

5 “(A) land that is held in trust by, or with
 6 a restriction against alienation by, the United
 7 States for an Indian tribe or a member of an
 8 Indian tribe, and—

9 “(i) is Indian forest land (as defined
 10 in section 304 of the National Indian For-
 11 est Resources Management Act (25 U.S.C.
 12 3103));

13 “(ii) has a cover of grasses, brush, or
 14 any similar vegetation; or

15 “(iii) formerly had a forest cover or
 16 vegetative cover that is capable of restora-
 17 tion; and

18 “(B) land that is in the State of Alaska
 19 and held by an Alaska Native Corporation pur-
 20 suant to the Alaska Native Claims Settlement
 21 Act (43 U.S.C. 1601 et seq.).”;

22 (2) in subsection (b)—

23 (A) in the subsection heading, by inserting
 24 “OR RESTORE” after “PROTECT”;

1 (B) in paragraph (1), by striking “to pro-
 2 tect Indian forest land or rangeland” and all
 3 that follows through “Indian forest land or
 4 rangeland)” and inserting “to protect or restore
 5 Indian forest land or rangeland, or to carry out
 6 a project to protect or restore Federal land”;
 7 and

8 (C) in paragraph (3), by striking “that
 9 is—” and all that follows through the period at
 10 the end of subparagraph (B) and inserting “or
 11 Indian forest land or rangeland.”;
 12 (3) in subsection (c)—

13 (A) in the subsection heading, by inserting
 14 “FOR FEDERAL LAND” after “CRITERIA”;

15 (B) by striking “an Indian tribe,” in the
 16 matter preceding paragraph (1) and all that fol-
 17 lows through “Indian tribe—” in the matter
 18 preceding subparagraph (A) of paragraph (2)
 19 and inserting the following: “Federal land, are
 20 whether—

21 “(1) the Federal land has a special geographic,
 22 historical, or cultural significance to the Indian tribe
 23 and—”;

24 (C) in paragraph (1) (as so designated)—

1 (i) in subparagraph (A), by striking
 2 clause (i) and inserting the following:

3 “(i) Indian forest land or rangeland;
 4 or”; and

5 (ii) in subparagraph (B), by inserting
 6 “or watershed” after “land”;

7 (D) by redesignating paragraphs (3) and
 8 (4) as paragraphs (2) and (3), respectively;

9 (E) in paragraph (2) (as so redesignated),
 10 by striking “subject” and inserting “Federal”;
 11 and

12 (F) in paragraph (3) (as so redesignated),
 13 by striking “Forest Service or Bureau of Land
 14 Management” and inserting “Federal”;

15 (4) in subsection (g), by striking “date of en-
 16 actment of this Act” and inserting “date of enact-
 17 ment of the Tribal Forest Protection Act Amend-
 18 ments Act of 2025”; and

19 (5) by adding at the end the following:

20 “(h) AUTHORIZATION OF APPROPRIATIONS.—There
 21 is authorized to be appropriated to carry out this Act
 22 \$15,000,000 for each of fiscal years 2026 through 2031.”.
