

<p>S.J. Res. 3.—Proposing an amendment to the Constitution of the United States to protect the rights of crime victims. Referred to the Judiciary Jan. 19, 1999. Reported amended Oct. 4, 1999; Rept. 106-254.</p>	<p>S.J. Res. 39 (H.J. Res. 86).—Recognizing the 50th anniversary of the Korean War and the service by members of the Armed Forces during such war, and for other purposes. Referred to the Judiciary Feb. 3, 2000. Reported Mar. 9, 2000; no written report. Passed Senate Mar. 9, 2000. Received in House and held at desk Mar. 13, 2000.</p>
<p>S.J. Res. 11.—Prohibiting the use of funds for military operations in the Federal Republic of Yugoslavia (Serbia and Montenegro) unless Congress enacts specific authorization in law for the conduct of those operations. Ordered placed on the calendar Feb. 24, 1999.</p>	<p>S.J. Res. 40.—Providing for the appointment of Alan G. Spoon as a citizen regent of the Board of Regents of the Smithsonian Institution. Referred to the Judiciary Mar. 17, 1999. Reported Apr. 29, 1999; Rept. 106-246. Considered Mar. 27, 28, 2000. Failed of passage (two-thirds required) Mar. 29, 2000; Roll No. 48: 63-37.</p>	<p>S.J. Res. 42.—Providing for the reappointment of Manuel L. Ibanez as a citizen regent of the Board of Regents of the Smithsonian Institution. Referred to Rules and Administration Feb. 29, 2000. Committee discharged. Passed Senate Apr. 12, 2000. Received in House and referred to House Administration Apr. 13, 2000. Rules suspended. Passed House May 2, 2000. Presented to the President May 4, 2000. Approved May 5, 2000. Public Law 106-199.</p>
<p>S.J. Res. 20.—Concerning the deployment of the United States Armed Forces to the Kosovo region in Yugoslavia. Referred to Foreign Relations Apr. 20, 1999. Reported Apr. 30, 1999; no written report. Considered May 3, 4, 1999. Laid on the table May 4, 1999; Roll No. 98: 78-22.</p>	<p>S.J. Res. 43.—Expressing the sense of Congress that the President of the United States should encourage free and fair elections and respect for democracy in Peru. Ordered placed on the calendar Mar. 29, 2000. Passed Senate amended Apr. 7, 2000. Received in House and referred to International Relations Apr. 10, 2000. Committee discharged. Passed House Apr. 11, 2000. Presented to the President Apr. 13, 2000. Approved Apr. 25, 2000. Public Law 106-186.</p>
<p>S.J. Res. 21.—To designate September 29, 1999, as “Veterans of Foreign Wars of the United States Day”. Referred to the Judiciary Apr. 21, 1999. Reported June 10, 1999; no written report. Passed Senate June 30, 1999. Received in House and held at desk July 1, 1999.</p>	<p>S.J. Res. 44 (H.J. Res. 98).—Supporting the Day of Honor 2000 to honor and recognize the service of minority veterans in the United States Armed Forces during World War II. Referred to the Judiciary Apr. 6, 2000. Committee discharged. Passed Senate May 18, 2000. Received in House and held at desk May 19, 2000. Passed House May 23, 2000. Presented to the President May 23, 2000. Approved May 26, 2000. Public Law 106-205.</p>
<p>S.J. Res. 22.—To reauthorize, and modify the conditions for, the consent of Congress to the Northeast Interstate Dairy Compact and to grant the consent of Congress to the Southern Dairy Compact. Ordered placed on the calendar Apr. 28, 1999.</p>	<p>S.J. Res. 46 (H.J. Res. 101).—Commemorating the 225th Birthday of the United States Army. Referred to the Judiciary June 6, 2000. Committee discharged. Passed Senate amended June 13, 2000. Received in House and held at desk June 14, 2000.</p>
<p>S.J. Res. 26.—Expressing the sense of Congress with respect to the courtmartial conviction of the late Rear Admiral Charles Butler McVay, III, and calling upon the President to award a Presidential Unit Citation to the final crew of the U.S.S. INDIANAPOLIS. Ordered placed on the calendar May 26, 1999.</p>	<p>S.J. Res. 48 (H.J. Res. 100).—Calling upon the President to issue a proclamation recognizing the 25th anniversary of the Helsinki Final Act. Referred to the Judiciary June 8, 2000.
