**UNANIMOUS CONSENT AGREEMENTS**

S. 3297 (ORDER NO. 894)

1.—*Ordered*, That at 12:00 p.m. on Tuesday, December 9, 2008, the Senate resume consideration of the motion to proceed to S. 3297, a bill to advance America's priorities. (Dec. 8, 2008.)

S. 1974

2.—*Ordered*, That S. 1974, a bill to make technical corrections related to the Pension Protection Act of 2006, remain at the desk. (Mar. 31, 2008.)

VETO MESSAGE ON S. 5

3.—*Ordered*, That the veto message on S. 5, the Stem Cell Research Enhancement Act of 2007, be considered as read and that it be printed in the Record and spread in full upon the Journal.

*Ordered further*, That the message be held at the desk. (June 20, 2007.)

H.R. 3997

4.—*Ordered*, That if the Senate receives from the House a message on H.R. 3997, an act to amend the Internal Revenue Code of 1986 to provide earnings assistance and tax relief to members of the uniformed services, volunteer firefighters, and Peace Corps volunteers, and for other purposes, with an amendment that is not germane to the Senate amendment or the underlying bill, that the bill and its amendments be referred to the Committee on Finance.
