UNANIMOUS CONSENT AGREEMENT

H.R. 2346 (ORDER NO. 63)

Ordered, That at 9:00 a.m. on Thursday, May 21, 2009, the Senate resume consideration of H.R. 2346, an act making supplemental appropriations for the fiscal year ending September 30, 2009, and for other purposes; provided, that the time until 10:00 a.m. be for debate only, equally divided and controlled between the two Leaders or their designees; provided further, that at 10:00 a.m., the Senate vote on the motion to invoke cloture on H.R. 2346.

Ordered further, That with respect to the motion to invoke cloture on H.R. 2346, the mandatory quorum required under Rule XXII be waived.

Ordered further, That the filing deadline for second degree amendments be 9:30 a.m. on Thursday, May 21, 2009. (*May 19, 20, 2009.*)

When objection is heard to immediate consideration of a resolution or motion when submitted, it shall be placed here, to be laid before the Senate on the next legislative day for consideration, unless by unanimous consent the Senate shall otherwise direct. (Rule XIV, Paragraph 6.)
