PENDING BUSINESS

H.R. 2847 (ORDER NO. 87)

An act making appropriations for the Departments of Commerce, Justice, Science and Related Agencies for the fiscal year ending September 30, 2010, and for other purposes. (*Oct. 5, 2009.*)

UNANIMOUS CONSENT AGREEMENTS

CONFERENCE REPORT TO ACCOMPANY H.R. 2647

1.—*Ordered*, That upon the conclusion of Morning Business on Thursday, October 22, 2009, the Senate resume consideration of the conference report to accompany H.R. 2647, an act to authorize appropriations for fiscal year 2010 for military activities of the Department of Defense, for military construction, and for defense activities of the Department of Energy, to prescribe military personnel strengths for such fiscal year, to provide special pays and allowances to certain members of the Armed Forces, expand concurrent receipt of military retirement and VA disability benefits to disabled military retirees, and for other purposes; provided, that there be one hour for debate, equally divided and controlled between the Senator from Michigan (Mr. Levin) and the Senator from Arizona (Mr. McCain), prior to a vote on the motion to invoke cloture on the conference report.

Ordered further, That with respect to the motion to invoke cloture on the conference report, the mandatory quorum required under Rule XXII be waived. (*Oct. 20, 21, 2009.*)

H.R. 3548 (ORDER NO. 174)

2.—*Ordered*, That with respect to the motion to invoke cloture on the motion to proceed to H.R. 3548, an act to amend the Supplemental Appropriations Act, 2008 to provide for the temporary availability of certain additional emergency unemployment compensation, and for other purposes, the mandatory quorum required under Rule XXII be waived. (*Oct. 21, 2009.*)

H.R. 2847 (ORDER NO. 87)

3.—*Ordered*, That cloture not having been invoked on the committee substitute amendment to H.R. 2847, an act making appropriations for the Departments of Commerce, Justice, Science and Related Agencies for the fiscal year ending September 30, 2010, and for other purposes, and a motion to reconsider the vote by which cloture was not invoked having been entered, that the cloture vote on the bill be delayed to occur upon reconsideration, and that upon reconsideration, if cloture is not invoked on the substitute, then the cloture motion on the bill be withdrawn.

Ordered further, That the filing deadline for first degree amendments be 3:00 p.m. on Tuesday, October 13, 2009.

Ordered further, That with regard to the motion to invoke cloture on the committee-reported substitute amendment and on H.R. 2847, the mandatory quorums required under Rule XXII be waived. (*Oct. 8, 2009.*)
