**UNANIMOUS CONSENT AGREEMENT**

H.R. 4213

*Ordered*, That at 9:30 a.m. on Wednesday, March 3, 2010, the Senate resume consideration of H.R. 4213, an act to amend the Internal Revenue Code of 1986 to extend certain expiring provisions, and for other purposes; provided, that the next two Democratic amendments be offered by the Senator from Washington (Mrs. Murray) and the Senator from Vermont (Mr. Sanders), and the next two Republican amendments be amendments offered by the Senator from Kentucky (Mr. Bunning). (*Mar. 2, 2010.*)
