**UNANIMOUS CONSENT AGREEMENT**

S. 3217 (ORDER NO. 349)

*Ordered*, That at 9:30 a.m. on Friday, May 14, 2010, the Senate resume consideration of S. 3217, an original bill to promote the financial stability of the United States by improving accountability and transparency in the financial system, to end “too big to fail”, to protect the American taxpayer by ending bailouts, to protect consumers from abusive financial services practices, and for other purposes; provided, that the following be the next first degree amendments in order:
