**UNANIMOUS CONSENT AGREEMENT****S.J. RES. 26**

*Ordered,* That on Thursday, June 10, 2010, after any Leader time, the Republican Leader, or his designee, be recognized to move to proceed to the consideration of S.J. Res. 26, a joint resolution disapproving a rule submitted by the Environmental Protection Agency relating to the endangerment finding and the cause or contributing findings for greenhouse gases under section 202(a) of the Clean Air Act; provided, that there be six hours of debate on the motion to proceed to S.J. Res. 26, with the time equally divided and controlled between the Senator from California (Mrs. Boxer) and the Senator from Alaska (Ms. Murkowski), or their designees; provided further, that upon the use or yielding back of time, the Senate proceed to vote on adoption of the motion to proceed; further, that if the motion is agreed to, then there be one hour of debate on the joint resolution, divided as described above; further, that upon the use or yielding back of that time, the Senate proceed to vote on passage of the joint resolution; provided further, that if the motion to proceed is not agreed to, then no further motion to proceed to the joint resolution be in order.

*Ordered further,* That no amendment or motion on the subject of the EPA greenhouse gas regulations or relating to the endangerment finding be in order prior to consideration of the motion to proceed to S.J. Res. 26; provided, that no amendments be in order to the joint resolution, and with all other provisions of the statute governing consideration of the joint resolution remaining in effect during the pendency of this agreement. After an action taken by the Senate, any Senator voting with the prevailing side or who has not voted may, on the same day or on either of the next two days of actual session thereafter, either enter a motion for reconsideration or move a reconsideration.
