PENDING BUSINESS

H.R. 5297 (ORDER NO. 435)

An act to create the Small Business Lending Fund Program to direct the Secretary of the Treasury to make capital investments in eligible institutions in order to increase the availability of credit for small businesses, to amend the Internal Revenue Code of 1986 to provide tax incentives for small business job creation, and for other purposes. *(June 29, 2010.)*

UNANIMOUS CONSENT AGREEMENT

HOUSE MESSAGE TO ACCOMPANY H.R. 1586

Ordered, That upon the conclusion of Leader remarks on Wednesday, August 4, 2010, the Senate resume consideration of the House Message to Accompany H.R. 1586, an act to modernize the air traffic control system, improve the safety, reliability, and availability of transportation by air in the United States, provide for modernization of the air traffic control system, reauthorize the Federal Aviation Administration, and for other purposes; provided, that there be an hour for debate prior to a vote on the motion to invoke cloture on the motion to concur in the House amendment to the Senate amendment, with Amdt. No. 4575, offered by the Senator from Nevada (Mr. Reid), with the time equally divided and controlled between the Leaders or their designees, with the Senator from Washington (Mrs. Murray) designated to control the time of the Majority Leader; provided further, that upon the use or yielding back of time, the Senate proceed to vote on the motion to invoke cloture on the motion to concur with an amendment.

Ordered further, That with respect to the motion to invoke cloture filed on the motion to concur with Amdt. No. 4575, offered by the Senator from Nevada (Mr. Reid), in the House amendment to the Senate amendment to H.R. 1586, the mandatory quorum call required under Rule XXII be waived. *(Aug. 2, 3, 2010.)*
