UNANIMOUS CONSENT AGREEMENT

H.R. 5297 (ORDER NO. 435)

Ordered, That at 11:00 a.m. on Tuesday, September 14, 2010, the Senate proceed to a vote on the motion to invoke cloture on Amdt. No. 4596, offered by the Senator from Nebraska (Mr. Johanns) to Amdt. No. 4595 to the substitute Amdt. No. 4594 to H.R. 5297, an act to create the Small Business Lending Fund Program to direct the Secretary of the Treasury to make capital investments in eligible institutions in order to increase the availability of credit for small businesses, to amend the Internal Revenue Code of 1986 to provide tax incentives for small business job creation, and for other purposes.
