#### UNANIMOUS CONSENT AGREEMENTS

#### S. 3992 (ORDER NO. 663)

1.—Ordered, That following the remarks of the Senator from Illinois (Mr. Durbin) on Thursday, December 9, 2010, the Senate resume consideration of the motion to proceed to S. 3992, a bill to authorize the cancellation of removal and adjustment of status of certain alien students who are long-term United States residents and who entered the United States as children and for other purposes, with the time until 11:00 a.m. be equally divided and controlled between the Leaders or their designees; provided, that the cloture vote on the motion to proceed occur at 11:00 a.m. on Thursday, December 9, 2010; provided further, that the mandatory quorum required under Rule XXII be waived.

Ordered further, That if there are back to back votes with respect to the cloture motions, there be four minutes of debate, equally divided and controlled in the usual form, prior to each vote. (Dec. 6, 7, 8, 2010.)

#### H.R. 847 (ORDER NO. 641)

2.—Ordered, That with respect to the cloture motion filed on the motion to proceed to H.R. 847, an act to amend the Public Health Service Act to extend and improve protections and services to individuals directly impacted by the terrorist attack in New York City on September 11, 2001, and for other purposes, the mandatory quorum required under Rule XXII be waived.

Ordered further, That if there are back to back votes with respect to the cloture motions, there be four minutes of debate, equally divided and controlled in the usual form, prior to each vote. (Dec. 6, 7, 2010.)
